3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures in accordance with Government of Republic of South Sudan Interim Public Procurement and Disposal Regulations, 2006 and opened to all eligible bidders defined in the Bid Document.


4. A complete set of bidding documents may be purchased by interested bidders on submission of a written application and upon payment of a non refundable fee of **USD 200.00 (Two hundred United state Dollars')** and method of payment will be by cash.

5. Interested bidders may obtain further information and inspect the bidding document at the address below between **8:00 am and 5:00 pm** from **Mondays to Fridays**.

6. Sealed bids must be delivered to the office of Director General of Taxation and the chairperson of committee for financial forms to the address below on or before **12:00 noon** on **13<sup>th</sup>/Dec/ 2011**. All bids must be accompanied by:

- A Certified True Copy of a Valid Business Registration
- Evidence of Tax Compliance
- Brief company profile
- Evidence of experience in similar assignments
- Bid Security of Sixty Thousand South Sudanese Pounds( **SSP 60,000.00**) and must be in the form of a Bank Guarantee or a certified Bank Cheque;
