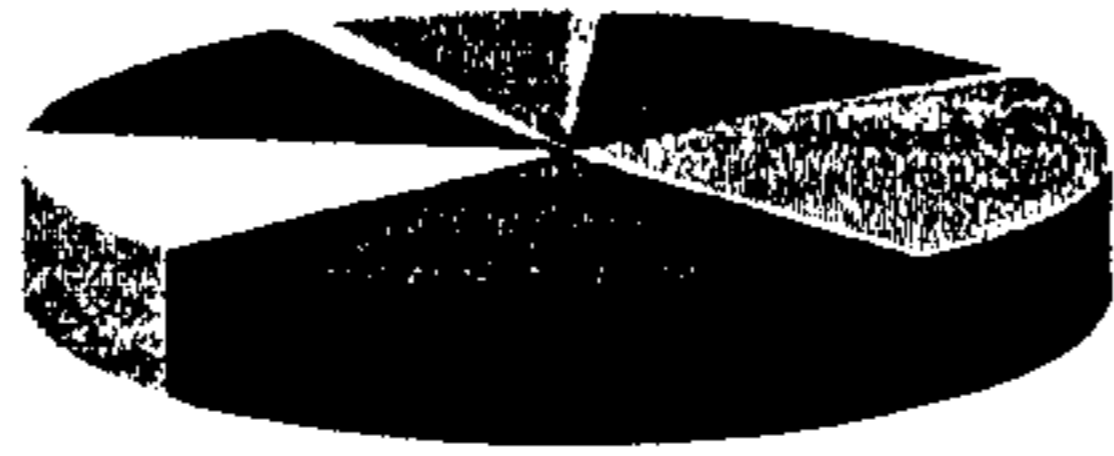



MoFEP reserves the right to accept or reject any application and is not bound to give reasons for its decision. All applications must be accompanied by:

- A Certified True Copy of a Valid Business Registration certificate
 - Tax Clearance Certificate
 - Tax Identification Number(TIN)
 - Brief company profile
 - Evidence of experience in similar assignments for the category applied for.
5. Applications will be opened on **4/6/2012 at 12: 00 noon** in the presence of applicants or their representatives' who choose to attend, at the office of Director General of

Procurement Ministry of Finance and Economic Planning RSS - Juba. Late applications will be rejected and returned unopened to bidders.
