## **HON. OGATO CHAM GILO**

### **Minister for Social Development JS/B**

#### **BRIEF PROFILE**

Currently working as the State Minister for Social Development Jonglei State for the last two {2} years. He is a very strong service provider to the people to meet the expectation of the people's Social needs - in the government of Jonglei State.

- 1982 – 1984 he worked as a primary teacher for two years in Pochalla District {Obuodi Village}.
- He served in the SPLA – armed struggle for Freedom fighter, he attended signal training in Zinc Gambella Region Ethiopia for Five Months as a radio Operator and work as a radio operator for 11 years {1985 - 1996}.
- The rank from 2<sup>nd</sup> Lt. to Colonel in the SPLA/M
- 1994 – 2005 he was nominated member to National Liberation Council {NLC}.
- 1995 appointed as Executive Director for Pibor County.
- And at the same time seconded to civil authority – New Sudan.
- 1996 – 2000 appointed as Acting Commissioner for Pochalla County where he served for four {4} years.
- 2001 - 2005 appointed full Commissioner for Pochalla County.
- 2005 – 2009 nominated as a member Jonglei State legislative Assembly
- 2009 – 2010 appointed Governor Advisor on Education – Jonglei State.
- 2010 – 2011 appointed Minister for Social Development Jonglei State

#### **ACHIEVEMENTS**

- Within 24 months {two years} of service, Hon. Minister Ogato Cham managed to work out most burning issues on child abduction within and outside Jonglei State. The Ministry in collaboration with other concerned bodies brought back fifty nine {59} abducted children from various Counties within Jonglei state and as far as other states like CES {Central Equatoria State and Eastern Equatoria State} in collaboration with the Partners; UNICEF, UNMIS and SAVE THE CHILDREN. Among these children are mothers abducted together with their children. The Ministry achieves its objectives of re-unifying the victims with their initial parents.
- In 2010, five staffs are trained in Juba University as social workers for better performance of their duties and assignments in the Ministry.
- At large the ministry has created concrete relationship with concerned bodies like UNICEF and SAVE THE CHILDREN - South Sudan to cater for these abducted

children and mothers in term of service provision before they are reunified with their initial parents.

- Moreover, he managed to put up some structures within the Ministry's environment, i.e. built fence, car shade, planted flowers around the fence, construction of the Ministry's cloaking rooms with its two septic tanks and working on refurbishing the Ministry's building.
- Initiated the ongoing construction of the State Stadium, appointed one junior and one senior sport staff.
- Refurbishment of the basket ball court at Malek secondary school

### **EDUCATIONAL BACKGROUND**

- He has phenomena of patriotism which lead him into field of battle during the Struggle. He attended his first classes in Pibor Primary School in 1970 – 1975. He further joint Pibor Intermediate School from 1976 – 1979.
