\* Soccer ball. We want to stay identical with JTF-160. At JTF-160, detainees have their hands shackled and their feet free, and they are permitted to exercise in a fenced area by themselves, for 15-20 minutes, twice a week. There are no soccer balls.

\* Checkers. ICRC has endorsed concept of single-person games, which this is not. Second, this is beyond the chaplain's role. He is there to provide spiritual advice, not to become a buddy and provide recreation.

\* Call to the family. Bad idea to set U.S. Navy personnel up as liaisons to Al Quaeda family members.

Can provide more background if you want. Great call by [redacted] to raise the issues, and for you [redacted] to report them as you did. Thanks!

Good evening [redacted] spoke with the detainee today as part of my rounds. He made no special requests. I advised him we were still working the mail issue and expected to have him some info later this week. I have not advised him I have received the two letters. As feed back to my questions to him, he has indicated the staff was taking care of his needs, treating him well, his meals were fine and that the medical and the chaplain services were most appreciated. Although he made no requests to me, I was visited by [redacted] his evening with the following:

- The detainee was inquiring of [redacted] about his legal status and any idea how long he was going to be detained here. I informed [redacted] had no information concerning the detainees legal future, as I have not received any additional information. I advised the chaplain of today's C-SPANN interview with Secretary Rumsfelt on this topic and per the Secretary's remarks to reporters, the detainees legal status was still being reviewed by the legal analyst and that no decisions had been made.

- The detainee has requested the use of a soccer ball during his recreation time. A review of the Camp X-Ray SOP does not provide any guidance in this area. Personally, since the recreation area the detainee has access to is secured, he is under two man guard force supervision and cuffed during recreation call, I feel comfortable with accommodating the request, unless directed otherwise.

[redacted] has requested to bring in a checker board game during his visit with the detainee and to be responsible for taking it out of the block with him, when he departs. Again, not covered in the Camp X-Ray SOP. Told [redacted] I would inquire and get back with him. Personally, don't view a checker board and checkers as a problem since my guard force will ensure that all pieces are accounted for when introduced and exiting the block, with [redacted]

Sir,

As previously mentioned, Friday is the Muslim Sabbath day and it is a religious obligation for us to receive the sermon and pray. Islamic traditions hold that in order to have a valid 'Sabbath' congregational sermon/prayer that there must be a minimum of no less than three (3) persons in attendance. Since this is not currently possible and unlike GITMO where detainees are able to conduct such services while still confined to 'chain link' cells, that allow for a free flow of conversation and fellowship – our situation here is expressly unique in comparison. Therefore, and by your leave; my solution to this legitimate concern would be to allow the detainee to listen to 'sermons' (khutbahs) on cassette tape. These tapes have been/will be recorded in both English and Arabic, which is the practice here in the U.S.; and are IAW with the legal obligations of the faith. As your Muslim Religious Liaison, I personally assure you that they do not contain any adverse material. Respectfully, I further recommend, if this request is approved; that the detainee be allowed to listen to these tapes (one per Friday)– either using the player currently in A block or I could provide a walkman with headphones – one hour prior to the second scheduled prayer (approx. 1200 hrs) and then to conclude with his daily prayer (approx. 1300 hrs). Given the reservations clearly articulated by the powers that be, this recommended solution will allow for the free religious observance of the detainee by using expressly tailored modifications to those observances that simultaneously satisfy the 'security' restrictions that must be observed.

Good morning Sir, the following weekly summary is provided. All privileges mentioned in NAVBRIG Norfolk message DTG 061400Z APR 02 remain in affect. The detainee abides by the rules and regulations and as of yet, has not presented any disciplinary problems for my staff. I continue to see the detainee on a daily basis and he receives frequent visits by [ ] and my IDC, when required. He is becoming more accustomed to the facilities and my staff and is becoming more talkative as time passes. He remains in Maximum Custody, isolated from the general population and under two guard control (one E-7 and one E-6) at all times. The only time he is permitted out of his cell is during shower and recreation calls. Specific issues addressed this week and actions taken include:

- Monday 15 April 02, detainee requested via [ ] information concerning legal status and how long he was going to be detained here. Detainee advised that we have received no additional information concerning his legal status or length of stay. The detainee requested the use of a soccer ball during recreation call. Passed up the COC for consideration, disapproved 16 April 02 as not IAW JTF-160 SOP for Camp X-Ray. Detainee advised. [ ] requested permission to bring in a checker board during his visits and be responsible for removing it from the block at his departure. Passed up the COC for consideration, disapproved 16 April 02 as not IAW JTF-160 SOP for Camp X-Ray. Detainee and [ ] advised. [ ] asked if he may be permitted to contact the detainees family on his behalf, Health/Comfort. Passed up the COC for consideration, disapproved as bad precedence to set by having U.S. Navy personnel liaison with Al Quaeda family members. Detainee [ ] advised the calls were not authorized.

- Tuesday 16 April 02, received direction concerning mail routing procedures for the detainee and the two letters this facility received, 12 April 02. CLF decision is to have mail forwarded to the established JTF-160 address of 160 Camp X-Ray, Washington DC 20355. Both letters received were forwarded to this address on 17 April 02, with the out going mail.

- Wednesday 17 April 02, [ ] the assigned doctor visited the detainee as follow-up to [ ] letter from [ ] responsible for representation of indigent defendants in the Federal Courts in the Eastern District and was aware that the detainee was located at my facility. He was interested in determining weather the detainee seeks to have counsel appointed and requested that I contact his office immediately. I made no calls to the inquiry and forwarded the letter to CLF for info and direction. The detainee requested via [ ] Fast for (20) days in observance of Ramadan 2001 to meet his religious obligations, as this time was lost during his capture. Forwarded the request to CLF for consideration and approval. [ ] Received a facsimile [ ] to indicate his office was

- Thursday 18 April 02, informed by CLF the facsimile received from the Federal Public Defenders office on 17 April 02 had been forwarded to JFCOM and to not communicate with this office or take any action on the correspondence.

- Friday 19 April 02, received approval from CLF to permit the detainee to Fast for (20) days in observation of Ramadan 2001 to account for that time lost during capture and processing for detention. Will permit the detainee to commence his (20) observation period between sunrise 22 April 02 and sunset 11 May 02. My staff can support without disruption to our normal routine. Received the letter correspondence to back up the facsimile from the Federal Public Defenders office of 17 April 02. Informed CLF and was directed to hold the letter as they would in all likelihood be answering the correspondence with something as simple as contact the Dept of Defense General Counsel (once the final decision is made). During daily rounds the detainee asked again, if I had any idea about how long he may be here and again, I have told him that I had not received any new information and that to my knowledge his case was moving through the judicial process. My future response to such inquires until otherwise directed will be, "I don't know, sorry".

In summary, the detainee has adapted to his new surroundings and staff. I receive no complaints from him, just inquires. Would like to pass along my appreciation for all the support received to date. Specifically, would like to recognize the tremendous effort by NAVSTA Security. Perimeter defense remains in place and affective, the control point guards remain vigilant, have smooth out the few wrinkles with access control by providing access lists and a radio for communications between by central control station and the watch. Not a single unauthorized visitor has gained access to my front door. thanks to the Security efforts in place. One side note for info, I have been informed that [ ] [ ] CNP, PERS-84 will be visiting the command AM, 30 April 02. My staff and I will be standing by for the visit.

Good evening [ ] the following weekly summary is provided. All privileges mentioned in NAVBRIG Norfolk message DTG 061400Z APR 02 continue to be observed as the detainee remains compliant with the Brig's established rules and regulations. I continue to see the detainee on a daily basis as part of my routine rounds. He is alert and in good sprits. He continues to have frequent visits by the Chaplain and is seen regularly by the assigned doctor. He remains in Maximum Custody, isolated from the general population and under two guard control (one E-7 and one E-6) at all times. The only time he is permitted out of his cell is during shower and recreation calls. Specific issues this week and actions taken include: (b)(6)

- Monday 22 April 02, detainee's request to FAST in observation of the (20) days lost during Ramadan 2001 due to his capture and processing to Camp X-Ray, commenced this morning, prior to sunrise. CLF approval received for this request and will run through sunset Saturday, 11 May 02. Drafted and forwarded to CLF [ ] a proposed response from me to the Federal Public Defenders office, as directed by [ ] (b)(6)

- Tuesday 23 April 02, [ ] concurred with the proposed response to the Federal Public Defenders office submitted 22 April 01. Letter smoothed, signed, copy filed and placed in this mornings out going mail.

- Wednesday, 24 April 02, received a call this morning from [ ] of Defense Human Services, Defense Intelligence Agency. He indicated his department was responsible for visiting the detainees and was inquiring about the procedures to visit our detainee here at the Brig. He went on to say he worked the visits to Camp X-Ray via SOUTHCOM. I informed him that any such visits here would be cleared via CLF. I provided him with [ ] and [ ] phone numbers. CLF coordinated with JFCOM and SOUTHCOM, and verified bona fides of [ ] I have been provided with a POC [ ] locally based and phone number [ ] and advised he will be contacting me to make arrangements for the visit. To date [ ] (b)(6) [ ] has not contacted me or my staff. Saw the detainee during my rounds earlier today. Only query concerned Health and Comfort issues. He requested a finger nail clipper, shave cream, razor, shampoo, writing pad, pen, socks and tennis shoes. Told him I would be back with him tomorrow. Per the Camp X-Ray SOP, their medical staff handled hair cuts/beard trimming, I intend to use my staff barber and perform the trimming in the A-Block area (I'll bring the barber to him), therefore no need to move him from the Block and no need for a razor or shave cream. I will be present for the event.

- Thursday 25 April 02, received a call this morning from [ ] from the ICRC. She (b)(6) indicated her agency was responsible for visiting the detainees at Camp X-Ray and was inquiring who she needed to coordinate a visit with, to see our detainee. I informed her all visits with my detainee were coordinated through CLF, your office and that once cleared, I would be the local POC for coordinating and overseeing the visit. Provided her with [ ] number. CLF passed to JFCOM/JS who (b)(6) verified [ ]

[ ] to contact [ ] 26 April 02, to discuss coordination/planning. It appears the visit is not being planned to actually occur for another couple of weeks. Detainee was seen this morning by the assigned doctor and [ ] indicated (b)(6) the detainee was doing fine with no medical conditions to report and the Chaplain reported the detainee had no complaints.

- Friday 26 April 02, detainee provided all approved H&C items requested 24 April 02. Detainee forwarded one

post card for mailing to his family in Saudi Arabia. Post Card was verified to have the correct return address, per previously provided mailing instructions. The post card was placed in a enveloped, with my return address and addressed to the Mail Coordinator, 160 Camp X-Ray, Washington DC 20355 for scanning, processing and forwarding. For info, to date the detainee has received no mail other than the two letters received 12 April 02, which were mailed directly to this command and forwarded to the Camp X-Ray for scanning, 17 April 02.

Perimeter defense remains in place and affective and as reported last week, we have not had an unauthorized visitor gain access to the facility. Nothing else to report.

Good afternoon [redacted] as follow-up to the meeting with CINC and DCINC discussions centered primarily around bringing [redacted] into the fold, addressing the CINC/DCINC's desires to be the clearing house for all "Other Detainee" access, chain of command for issues, manning issues, FP issues, reporting requirements, chaplain duties and directions to both CO's. The following was discussed. (b)(6)

- Clearing house for issues, CLF Legal staff continues to be the POC for all matters pertaining to both "Other Detainees". Nothing new for us, business as usual. In the case of Charleston (since they are owned/operated by PERS 84) CINC indicated PERS 84 was in the loop and concurred with the fact the COC would now include CLF for all OD matters. CINC/DCINC made it clear, all access to the OD's will be cleared by one of them, personally. CINC provided [redacted] a letter similar to the one he provided me a couple of weeks back to indicate that the CJCS has directed the detainees are not permitted visits from legal counsel, family members or others unless specified by SECDEF or his designee. Unless we receive direction from CINC or DCINC, we are not to permit access. (b)(6)

- Manning issues, [redacted] indicated she could operate for about one month without serious impact to manning, with readjustments to her facilities watch bill. She quoted some figures for personnel requirements and associated cost. I briefed we had completed a ER/FAR conducted by CLF CMAT and that their findings drive a requirement for (12) additional guard force personnel. I also mentioned that funding the billets would normally come from CNRMA and that there inlaid a problem with regard to other installation priorities and where another facility could take a cut. I expressed, I had little confidence this would occur. I reminded them as mentioned from the start, I could operate until this fall without serious impact due my 104% BA (made up of LIMDU and Non-Sea-Duty screen personnel). After that, I would need help. I also addressed the perimeter defense established by NAVSTA Security and that with the demobilization process these assets would be coming solely from and already shorthanded force. I estimated between 36-42 personnel are committed to this function daily and that I believed NAVSTA CO and his Security Officer were working this particular manning issue. DCINC indicated that he would take on the manning issues for both facilities and work the problems with CLF N1. I intend to email to [redacted] a copy of the FAR results conducted by CLF CMAT, such take he can pass to DCINC for discussions with CLF N1. (b)(6)

- Reporting requirements, CINC/DCINC were both pleased with the process we currently have in place. Daily and Weekly updates to CLF Legal, with SETREP when required. They in turn pull from these inputs and forward updates to JFCOM, etc. They expect Charleston to follow suit.

- Chaplain requirements, CINC wanted to know how often Charleston was planning to have a Muslim Chaplain visit, she indicated once a month. CINC wants the visits to occur once a week. He asked how many Muslim Chaplains were in the Navy, I told him there were three, where they were located, when they were due to transfer and that [redacted] was already on loan to us. CINC indicated he wanted [redacted] assigned to the Norfolk Brig, such that he could be TAD to cover the Charleston weekly visit requirement. Not sure how this will (b)(6)

work out. Also advised CINC that it was my understanding the Muslim Chaplain was scheduled to transfer and report to NAVSTA Norfolk sometime later this year.

-- Perimeter Defense, CINC was satisfied with what is in place here at Norfolk, but was not happy with the Charleston plan. Gave direction to the Brig CO on how he envisioned the perimeter should be set up.

-- Security Improvements inside the facility, CINC wants a CCTV system installed in my Alpha Block. I will have my Director of Corrections gather information and sources, have a estimate conducted and move forward. Funding or a lack there of will be the biggest issue to overcome, as there are any number of companies and systems available on the market, some local. The system would help, should additional detainees be sent to our facility. CINC would not speculate as to rather additional detainees are coming in the future.

-- CLF Legal, briefed CINC/DCINC of the current legal status and issues surrounding both detainees.

In closing, both CINC/DCINC were complementary on the efforts put forth to date by all concerned, to make accommodations in support of the new missions. As you can imagine most of this was a rehash, of what we are already doing and designed primarily to get Charleston up to speed. As mentioned above, I have a couple of taskers (forward the CLF CMAT results justifying the 12 member guard force increase and look into installing a CCTV monitoring system for Alpha Block). Will keep you appraised of our efforts and cc you on what we forward.

Good evening [redacted], the following weekly update is provided. All privileges in NAVBRIG Norfolk message 061400Z APR 02 continue to be observed, as our detainee remains complaint with the Brigs established rules and regulations. I continue to see him on an almost daily basis during regular rounds. In my absence he is seen by the CDO. He continues to be seen by [redacted] both of which continue to keep me informed of their visits and observations. The detainee remains in a Maximum Custody status, isolated from the general population and under two guard control (one E-7 and one E-6) at all times. The only time the detainee is permitted out of his cell is shower and recreation calls (combined 1 hour total each day) and when out of his cell during these times, prescribed restraints are applied. Specific events/issues and actions taken this week include:

-- Monday 17 June 02, saw the detainee this morning during regular rounds. He made no requests of me and had no complaints. He indicated he was feeling fine and that [redacted] was in to see him Saturday evening. In addition, I received (3) additional letters addressed directly to the detainee this morning. They were postmarked 11, 12 and 13 June 02 respectively. The 11th and 13th letters were from the Clerk's Office, U.S. District Court, Eastern District of Virginia, 600 Granby Street Norfolk Va., while the letter dated the 12th was from the Clerk's Office, U.S. District Court, Eastern District of Virginia, Walter E. Hoffman U.S. Courthouse, 600 Granby Street, 1ST Floor, Norfolk Va. For [redacted] unless otherwise directed and as previously directed, I have not delivered this mail to the detainee, have placed the letters in the office safe, unsealed. To date, I am holding a total of (7) pieces of what appears to be legal correspondence, from the detainee. As follow-up to the Friday afternoon meeting with CINC/DCINC and the discussion concerning manning, attached is a copy of the CLF (N17) CMAT Functional Area Review conducted at my facility, justifying an increase of (12) personnel to support the "Other Detainee" mission. Per conversation with CNRMA Manpower shop [redacted] these additional requirements were entered into the Total Force Manpower Management System (TFMMS) this morning. We were informed that the AMD Change request should be approved in about two weeks and that the (12) billets are only "Approved Requirements" and that until such time CNRMA receives additional funding for the billets, they would not be authorized. Since DCINC gave me the impression he was going to take on the manning issues of both commands (Charleston and Norfolk Brigs) with CLF N1, I wanted to pass along (for DCINC's info) what has already been completed for my facility and where it stands, as was discussed Friday

-- Tuesday 18 June 02, saw the detainee this morning during regular rounds. He made two requests of me, which I indicated I would forward up the COC. He requested a deck of Pinuckle Cards and a Game Boy, pocket size

computer game. These two requests are discussed below. He indicated [redacted] was not over yesterday evening but he expected him by tonight. In addition and as follow-up to the meeting and direction received from CINC/DCINC, Friday 14 June 02, I had [redacted] of NAVSTA Norfolk's ET Shop over this afternoon to investigate the installation of a CCTV system, in my Alpha Block. Told him I was interested in a system to monitor all (12) cells, the entire block area, to include shower, watch supervisor station and recreation area. Also wanted the ability to monitor the cameras from my watch supervisor station and from my Central Control Center, with record capability. [redacted] indicated he would have me the Low/Med/High range cost for such a system by COB Friday 21 June 02. [redacted] Sir in order for me to complete the inspection of Alpha Block, to determine a cost for a CCTV system and to secure access to the detainee, I moved him into my #12 cell on the block, locked the other steel door and posted a guard force member at the steel door entrance. My cells #11 and #12 are solitary confinement facilities. The difference between these two cells and the other (10) on the block is, the other (10) have barred doors which open onto the block, where as #11 and #12 open into a vestibule which can be isolated from the block by closing and locking the other steel doors to these two cells. I briefed the detainee in advance of the inter-block move and he understood, without complaint. To meet the CINC's intend "no visitors without his approval and meet the requirement to complete the survey for CCTV installation cost, movement within the block to a solitary confinement cell, is the extent of my options. In addition, I will have to perform similar moves, once a system has been procured and ready for installation. With regard to the detainees request for a deck of cards and a game boy, I recommend approval for the following reasons: as reported he has been a model detainee since his arrival, unlike at Camp X-Ray this detainee has no other contact with his countrymen (as was and is still the case there) with nothing but time on his hands, I want the ability to use an incentive program (for good behavior which is standard practice throughout the Corrections Community) and most importantly, I have to the ability to exercise some discretion when I believe it best for the Health and Welfare of those assigned to my facility, while maintaining Good Order and Discipline. Know discussion has been to the extent possible we are to remain consistent with the procedures that were/are in place at Camp X-Ray, but we are not Camp X-Ray with 300+ other detainees who do have the ability to communicate with one another. I believe both of these requests would be considered under Authorized Recreation Books/Games and Games For One Person; No Pieces That Can Be Used As Weapons, section of the Detainee Issues (0900, 5 April) paper, provided in advance of receiving the detainee. I have asked in the past for similar requests (a soccer ball for the detainee to use when in the recreation area and a checker board) both were disapproved, as not being consistent with the Camp X-Ray procedures.

Informed him that I had forwarded his requests (deck of pinuckle cards and game boy as reported in yesterday evening update) up the COC for consideration and that I should know something within the next couple of days. All privileges in NAVBRIG Norfolk message 061400Z APR 02 continue to be observed, as our detainee remains complaint with the Brigs established rules and regulations. I continue to see him on an almost daily basis during regular rounds. Only noted problem this week occurred on Wednesday, when the detainee appeared to be going [ ] As before, I attribute the down (b)(6) turn in spirit to the uncertainty of the detainees future and the unknown length of time he is to be incarcerated. I have made mention of this fact to both [ ] for their attention, consultation and monitoring. This is (b)(6) the second time I have seen the detainee go through this stage, since his arrival at my facility (first report made in my 27 May 02, daily update). Specifics addressed below. He continues to be seen by [ ] both of (b)(6) which continue to keep me informed of their visits and observations. The detainee remains in a Maximum Custody status, isolated from the general population and under two guard control (one E-7 and one E-6) at all times. The only time the detainee is permitted out of his cell is shower and recreation calls (combined 1 hour total each day) and when out of his cell during these times, prescribed restraints are applied. Specific events/issues and actions taken this week include:

- Monday 24 June 02, saw the detainee this morning during daily rounds. He asked if I had heard anything new concerning his length of stay here. Told him I had nothing new to pass along. I asked if [ ] had been in over (b)(6) the weekend and he indicated he had not. The detainee also requested the services of the barber for a beard and mustache trim. Told him I would schedule for tomorrow afternoon. I spoke with [ ] this afternoon and he indicated he would be over this evening. During our conversation [ ] also indicated that his relief was onboard (b)(6) and that they were planning to have their turnover process completed by 15 July 02. He went on to indicate, once the turn over was complete that he would be in excess onboard, until his August transfer date. Apparently, he has discussed with CAG and they would be willing to TAD him to me, until his transfer rounds around if this is still CINC's desire. In addition and as required, I have scanned the detainees letter to his parents (received Friday 21 June 02 for mailing) and forwarded to [ ] as a file for forwarding and review by the COC. Once it has been cleared and I have authorization, I'll place it in the mail. For [ ] Sir as a follow-up to our meeting with CINC/DCINC of 14 June 02, should we proceed with TAD orders ICO [ ] once his turn over is complete. In addition and as follow-up, received a brief this afternoon from DATALINE Incorporation (the company that provided the cost estimates for CCTV in my Alpha block forwarded Friday 21 June 02). They are scheduled to be over tomorrow morning to scope the project and fine tune their estimates. I have asked for a Statement of Work from this company by Friday 28 June 02. I have also asked [ ] (NAVSTA Norfolk ET Shop) for the cost of a similar system from another vendor, by Friday as well. Once I have the Statement of Work, I will forward to [ ] who is standing by to process and forward to FISC Contracting. To accommodate the contractors visit and as was the case previously during [ ] I will (b)(6) have the detainee moved to one of my two solitary confinement cells with the door guarded, while the contractor is conducting the visit

- Tuesday 23 June 02, the detainee received a visit today from the assigned Brig barber as requested and reported in yesterday evening update. Mustache and beard trim completed at 0830. While out of his cell for this event, I had him placed in cell #12 (solitary confinement) cell, with a guard posted in preparation for DATALINE Incorporation's site visit for CCTV installation. The detainee was briefed last week and again this morning on the need for this and future moves, during the installation phase of the project. He indicated he understood. The detainee was returned to his assign cell #1 at 1045. DATALINE Corporation representatives arrived at 1000 as planned and conducted a detail site survey. Discussions surrounded, selection of Option "A" for their install, that no work will start until the contractor has all pieces of the system in hand, that work will be completed in two phases, with all inside the Block work to be completed first and all exterior work (outside the Block) to be accomplished during the second phase of the project. I want the work performed in this manner to lessen the time I have to place the detainee in a solitary confinement cell, considering his Health and Welfare. The time in the block will be minimal (I have also requested a detailed timeline) for installation of (3) cameras in this area. These (3) cameras will be placed in the Block passageway/shower area, watch supervisors station and cell #1, with the installation including the associated cableway conduit and monitor at the watch supervisors station. All other work to be installed during phase two to include installation of the remaining (14) cameras, one in each of the remaining (11) cells, (2) in the recreation area and (1) in the passageway leading to Alpha Block. All (17) cameras are designed for correctional facility use, will be installed in the upper corner of each cell and installed from the back side of the cell from the Block cableway and pumping/pipe space. All conduit will be ran to the Central Control Center, where the power supply will be installed along with the second monitor. All security requirements were covered with the contractor. I expect their Statement of Work by Friday 28 June 02, at which time it will be forwarded to CNRMA Comptrollers shop. The contractor departed at 1205. I will keep all informed as this project develops.

- Wednesday 26 June 02, saw the detainee this morning during regular rounds. He is [ ] (b)(6) [ ] as he is continuing to question how much long he going to be here and why he has not been afforded to meet with a lawyer. He questions why when requests are made, it takes so long for a response. I try to assure him that his situation is under review and outside the control of this facility and that his requests are forwarded for consideration approval/disapproval, again beyond locate control authority when making a decision. I continue to tell him to have faith

and that in time these matters will work themselves out. After eight months of incarceration in detention facilities (Kandahar, Camp X-Ray, Norfolk Brig) with no potential end in site and no encouraging news and isolated from his countryman, I can understand how he feels. Once [redacted] returns this evening, I will pass this info along to him for discussion with the detainee. [redacted] was not over yesterday evening due to his arrangements to visit the detainee in Charleston. I will continue to do what I can to help this individual maintain his sanity, but in my opinion we're working with borrowed time. For [redacted], Sir the following issues remain outstanding, pending disposition: Requested permission (11 June 02) to deliver the two letters cleared by JTF-160, requested permission (18 June 02) to provide the detainee a deck of penguin cards and gameboy hand computer game, requested permission (21 June 02) to mail the detainee's letter to his family. In addition, I continue to hold (7) letters that appear to be legal correspondence for the detainee from the Clerk's Office U.S. District Court, Eastern District of Virginia. Know these items are working through the upper levels of government and that they are only small issues by comparison, but here at the deckplate level I am seeing a morale issue developing and any help with resolving some of the above issues would help in this area. -- Thursday 27 June 02, saw the detainee this morning during regular rounds. He was in much better spirits today and made no additional requests. Told him I could possibly have him some feedback tomorrow on some of his previous requests (per email from [redacted] this morning). The only time the detainee is permitted out of his cell is during shower and recreation calls (combined 1 hour total each day) and when out of his cell during these times, prescribed restraints are applied. Specific events/issues and actions taken this week include:

- Monday 9 September 02, saw the detainee today during morning rounds. He was in good spirits, had no complaints, no medical issues and made no requests. For [redacted] Sir received a call this afternoon from [redacted] (local area DHS office) requesting a follow up meeting with the detainee. [redacted] indicated that he and [redacted] (DHS Washington office) would like to conduct the visit on Thursday at 1500, 12 September 02. The purpose of the visit would be to provide the detainee feed back as a result of the meeting held with DHS and CIA, 7 August 02. Good evening (b)(6) the following weekly update is provided. All privileges in NAVBRIG Norfolk message 061400Z APR 02 continue to be observed, as our detainee remains compliant with the Brig established rules and regulations. I continue to see him on an almost daily basis. He continues to be seen by the (b)(6) both of which continue to keep me informed of their visits and observations. We completed the detainees third visit by (b)(6) on Tuesday, 10 December 02. The visit went extremely well, with the (b)(6) making some recommendations to improve the detainees quality of life, while in confinement. Those recommendations are noted below and forwarded for consideration. The detainee remains in a Maximum Custody status, isolated from the general population and under two guard control (one E-7 and one E-6) at all times. The only time the detainee is permitted out of his cell is during shower and recreation calls (combined 1 hour total each day) and when out of his cell during these times, prescribed restraints are applied. Specific events/issues and actions taken this week include:

Monday 9 December 02, I saw the detainee this morning during routine daily rounds. He was in good spirits, good health, had no complaints and no requests. Also, no problems to report as a result of the Flu shot administered by the attending physician last Friday morning. All preparations are in place for tomorrow afternoon's visit by (b)(6) scheduled for 1400. The detainee will be pre-positioned at the table in Alpha Block passageway by 1345, with two guards and the Watch Supervisor posted. The detainee will have his legs shackled and wearing a transportation belt. His left wrist will be cuffed, with the opposite end of the hand cuff attached to the transportation belt "D" ring. His right wrist (writing hand) will be unshackled for the duration of the visit. The right wrist unshackled for the duration of the visit is a change from the previous two visits, as was raised an issue by (b)(6) during his last visit. I am comfortable with the arrangement and have the approval of CLF. As before, I will brief the detainees status/H&C since the last (b)(6) visit and escort (b)(6) to the Block and direct him to the table. I will have my guards remain out of ear shot and I will remain on the Block until completion of the visit. I have no reason to believe (b)(6) will have any major issues to report, as a result of the visit.

Tuesday 10 December 02, I saw the detainee this morning during routine daily rounds. He was in good spirits, good health, had no complaints, made no requests and looking forward to meeting with (b)(6) this afternoon. Also delivered an AMCROSS message from his mother and father dated, 29 November 02. The message was forwarded to me earlier this morning by (b)(6) (CLF Legal). All preparations were in place for (b)(6) visit. The detainee was pre-positioned at the table in Alpha Block, in the appropriate restraints with two guards posted at 1350. (b)(6) from CLF arrived at 1330. (b)(6) arrived at 1345. I briefed him on the detainees medical status and all associated H&C matters since his last visit, to include mail and AMCROSS messages sent and received. Also briefed him that the issue of handcuffs, addressed during the last visit had been resolved for the purposes of the visit. We proceeded to the Block at 1405 and commenced the visit. The visit concluded at 1600. (b)(6) debriefed (b)(6) and I at 1605. He was most impressed with the overall condition of the living facilities, the detainees health and mental status and the staffs support. He inquired if the detainee was allowed to received pictures. I told him it was my understanding that family pictures were authorized, but that I would confirm. He also asked if he could send the detainee additional reading materials in Arabic. I informed him that I would treat anything he sent, as mail and forward accordingly for review and authorization to deliver. (b)(6) made mention that clearing books typically take longer to clear, when their in the Arabic language. He also make mention of providing additional tapes for the detainee to listen to and the possibility of board games for recreation. He also inquired about the possibility of TV. I told him TV was not authorized, and that I have already requested the use of board games and that this was denied. I did tell him I would inquire as to if a VCR type movie could be approved. His concern remained the isolation and he felt anything that we could do to help ease the degree of isolation would help. Believe (b)(6) will provide a more detailed briefing of the in-brief/out-brief. (b)(6) (b)(6) also left four books in Arabic for review and consideration for delivery to the detainee. (b)(6) has the books and the message drafted by the detainee for review and forwarding. The detainee was returned to his cell at 1607. Next proposed visit is scheduled for the late January/ early February 03 time frame. All in all, I think we had a good visit with positive results and some requests from (b)(6) to consider.

Wednesday 11 December 02, I saw the detainee this morning during routine daily rounds. He was in good spirits, had no complaints and made no requests. For (b)(6) Sir information contained in the OSD document conveyed to the detainee verbatim. The back-up talking point was also conveyed, as the detainee asked the question about the rights waiver.

Thursday 12 December 02, the detainee was seen this morning by my assigned CDO as I was meeting with PERS-84 and CLF N16. The CDO reported the detainee was in good spirits, had no complaints and made no requests. I expect the assigned physician over tomorrow morning to conduct his weekly visit.

Friday 13 December 02, I saw the detainee this morning during routine daily rounds. He had no complaints and made no requests. His spirits continue to be good and he has no complaints with my assigned staff. He was seen this morning by the attending physician (b)(6) who reported to me that the detainee was in excellent health. (b)(6) also

(b)(6) He indicates there is (b)(6) and that he recommended the detainee discontinue push-ups for the time being. He also recommended (b)(6) if the detainee desires to continue push-ups. (b)(6) if the detainee so desires and does not wish to take the prescribed medication. A determination will be made when the doctor conducts his next weekly visit on Friday, 20 December 02. I expect the (b)(6) over this evening or tomorrow to conduct his visit. For (b)(6) Sir any consideration given to the entertainment items recommended by (b)(6) to help improve the detainees morale and loneliness. Just wanted you to know Alpha Block was fitted with TV capability and cable hook-up, but I had it removed prior to the detainees arrival. Selected viewing times and programs to be viewed can be controlled, if approved. Cassette/VCR tapes and individual games are also available and can be controlled, as we currently control the books he receives, if approved. The Block is already equipped with a cassette player (provided for playing the five calls to prayer tape). As you have indicated before, know we want to stay consistent with the privileges afforded the detainees at Camp Delta, but I have little else to offer this individual and I continue to be ever vigilant of his mental state. I would like to have some form of an incentive program in place to reward him for his continued good behavior, but more so, to keep him from Whacking out on me.

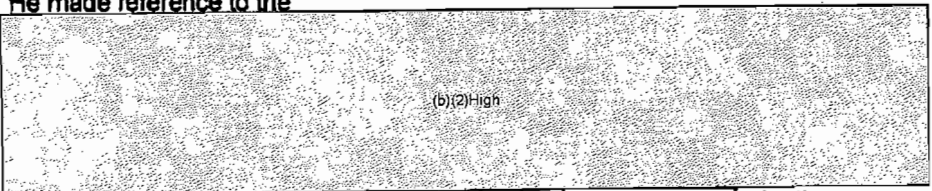

Monday 14 April 03, the detainee was seen this morning during my routine rounds of the facility. I found him to be in good spirits, good health and without complaint. When asked about treatment, he indicated that my staff continues to treat him well and that he no complaints with the accommodations being provided. I suspect the requirement is the same, but figured I would ask in the event there may have been a change in the requirement that I was not aware of and given most of the

Afternoon Sir, as a follow-up the following procedures, movie listing and board games input is submitted for your review, consideration and approval. For info, I have made available one portable TV/VCR Combo for use in Alpha Block. The Combo has been placed on a wheeled cart, as the original mounting bracket for a TV in the Block had been removed some years ago, when the Block was closed. Considering the amount of time required to have PWC installed a new mounting bracket, decided the cart was a better option. The movies listed below are at No Expense to the facility, as they are the personal property of my staff and I. Once I had approval to provide movies, my staff and I decided to pool our assets for this purpose. The board games listed below are from the facilities inventory and therefore, there is No Expense incurred. Once I have your approval, I will issue a Transmittal change to the Alpha Block SOP covering the new incentives and procedures for implementation and management.

Procedures for Movie Viewing:

- Movie Call will be conducted Wednesday, Saturday and Sunday.
- Movie Calltimes will be between 1900-2200.
- Only those movies approved by higher authority are authorized to be shown.
- All movies will be maintained at the Watch Supervisors station and controlled by the Watch Supervisor.
- The detainee is permitted to view authorized movies from his cell, only. Under NO CIRCUMSTANCES is he permitted to view movies from outside his assigned cell.
- At movie call the Block assigned Guard Force member will retrieve the movie to be shown from the Watch Supervisor.
- The Block Guard Force member will position the TV/VCR Combo cart in front of the detainees cell to permit viewing and far enough away from the cell, such that the detainee does not have direct access to the controls.
- The Block Guard Force member will turn on TV/VCR, insert the movie to be shown, make any required adjustments, to include volume control. Volume will be set such that it is not greater than that volume produced by the installed General Announcing speaker located in the space.
- Upon completion of the movie the Block Guard Force member will rewind the movie shown, secure power to the TV/VCR Combo cart, reposition the cart to it's designated stowage area and return the movie to the Watch Supervisor for stowage.
- In the event of Code Blue/Man Down/Lock Down is called away during movie call the Block Guard Force member will secure the movie until such time the facility has secured from the condition.
- Any equipment difficulties encountered during movie that can be accomplished with onboard staff will be attempted. All equipment problems will be reported to the Brig CO during rounds the next work day.
- The assigned Block Guard Force member is permitted to view the movie with the detainee, if he so desires and so long as it does not interfere with his primary duties.

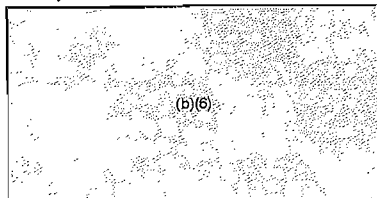

Here is our response to your request. Please let me know if you need anything further.

1) Recommendation for 2-hours recreation time. If this is improved, how will this impact the Brig staff (impact on manpower, scheduling, and separation from regular prisoners)?

\* Two hour recreation will not impact manpower (on routine days; may impact on days where there are visitors) or separation from regular prisoners. It will, however, impact ongoing contract work on the roof and elsewhere in the brig, to include the lighting project. To avoid impacting roof work, recommend we schedule two two-hour blocks of recreation before and after working hours. Our flexibility to schedule recreation hours will be enhanced when the lighting project is complete (approx Sept) thus allowing night-time recreation if desired.

\* If directed, #1 and #3 can be rec'd outdoors at the same time--they would be separated by a concrete wall. A threat to security could arise if communication between the two occurs. This can be alleviated with staff directing the two ECs that should any form of communication occur, recreation call will be terminated.

\* Currently the regular prisoner population is not allowed outside for recreation in black flag conditions. The policy for ECs could be modified to allow recreation during black flag, however, this raises concern for the staff members monitoring them. While guarding the ECs, staff are required to wear protective gear that is not conducive to spending long periods of time outdoors during black flag conditions. Although the Red Cross noted that the ECs are accustomed to hot weather, it should be noted that there are differences in the weather conditions in their native countries and here in SC (in terms of humidity, potential allergens, etc.).

2) Less light for #1. Please have a staff member talk to him about this so we can clarify whether he means less wattage or less hours. If it's less wattage, let us know if that's possible. If its less hours, let us know what the standard light-hours are for the detainees and for regular population.

\* #1 clarified that the issue is wattage. To fix this, a light bulb cover can be affixed to the light in his cell in order to dim it. His real request is to see outside; for us to scrape the paint off his window so the cell is lit by natural light only. Both of these solutions negatively impact on the camera's view of cell from the Control Center. As he already uses reading glasses, recommend we issue him a set of eye glasses with light sensitive shading for use while in his cell.

3) Natural lighting for all. Review the reasonableness of allowing some natural light (what can be done, how expensive) & safety concerns & make a recommendation.

\* To provide natural lighting would simply require scraping paint off the windows - an easy, no-cost fix. #1 and #3 would have views of the SHU recreation yard (where they currently do outside rec). #2 is more problematic. To ensure he that has no view of the regular brig rec yard and no one can see him, would require that we relocate him to the same side currently occupied by #1 and #3. This raises very serious security concerns if #2 is given the ability to view external layouts of the facility and if able to see/hear the other ECs. For these reasons, recommend status quo for #2.

4) Arabic commentary for Koran. Please find out if his current Koran has commentary and, if so, whether it's in Arabic.

\* Current Koran does not have commentary. #2 wants a TAFSIR Koran that has the commentary to the side. Two books that fit this request are Butter of TAFSIR or TAFSIR Ibn Katheer. He does not want both; one or the other will fit the requirement.

When you get a chance, please let me know if the books were delivered to #3.

\* Books were delivered to #3 last night.

Also, I was supposed to pick up a document that #1 signed for his attorneys -- I believe [redacted] had him sign it. Do you know where it is?

\* Due to a miscommunication you did not receive the document but it is on its way to you via FedEx today.

Finally - [redacted] asked whether the Brig should serve meals after evening prayer (rather than the regular meal times) when #2 decides to fast. Here's his answer: #2 should be told that, if he notifies the staff in the morning that he intends to fast for religious purposes, then we will delay MREs until after the evening prayer. He must notify us in the morning at the first morning staff visit. If he does not notify the staff in the morning, meals will be served at the regular time. Late meals will always be MREs - even if he returns to hot meals.

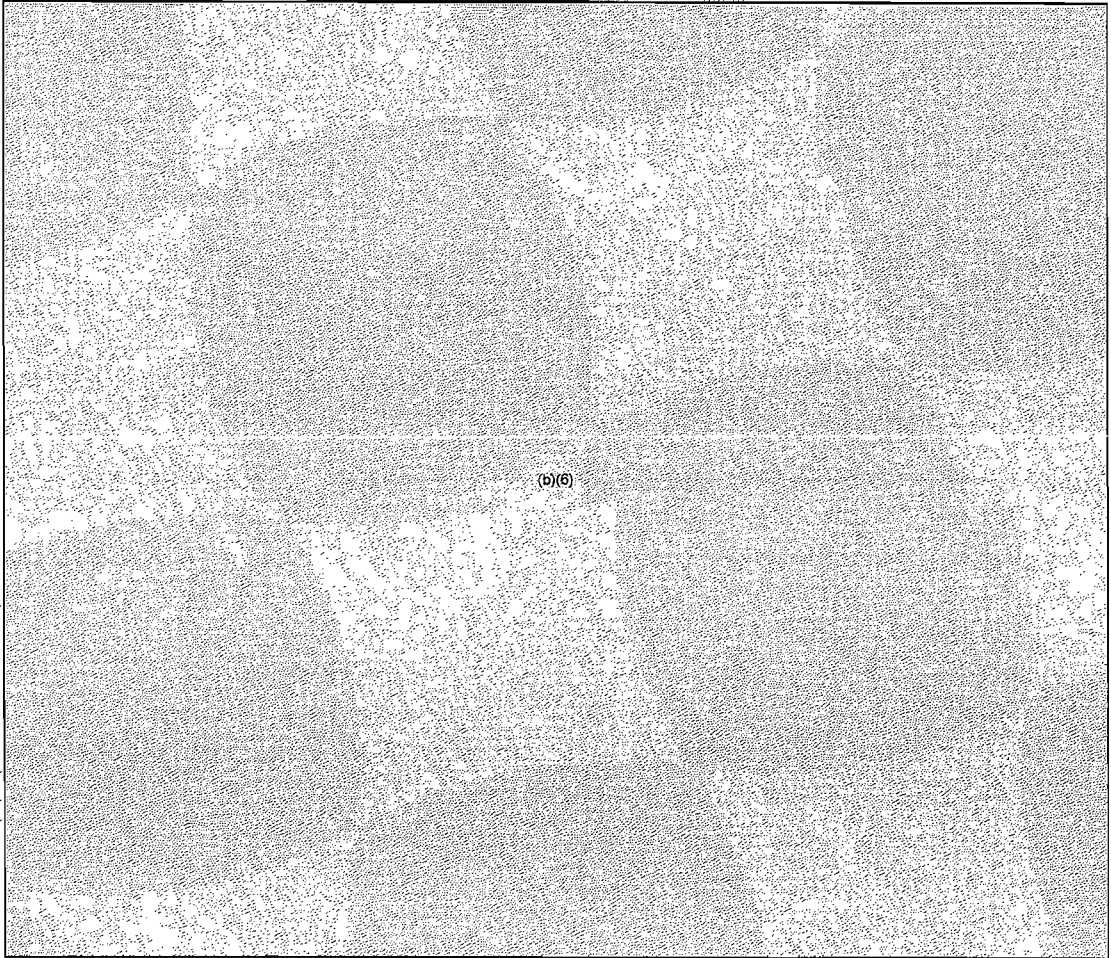

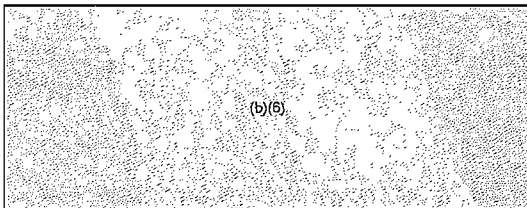

Ref the tasker received by JFCOM yesterday, the following USJFCOM steps have been taken to implement the FY05 NDAA (section 1092) provisions regarding actions to prevent the abuse of detainees held at the Charleston Naval Brig:

"Provides all assigned personnel with training, and documented acknowledgement of receiving training, regarding the law of war, including the Geneva Conventions." During CY 2004 (b)(6) Deputy Fleet Judge Advocate, U.S. Fleet Forces Command (CFFC), provided on-site training for the staff members of the Naval Consolidated Brig Charleston (NAVCONBRIG) that interact with the detainees. The training included information and discussion on the Law of Armed Conflict, the Geneva Conventions, and other applicable domestic and international law.

"Establishes standard operating procedures for the treatment of detainees." NAVCONBRIG currently has such an SOP in place.

"Providing all detainees with information, in their own language, of the applicable protections afforded under the Geneva Conventions." The sections of the Geneva Conventions relevant to the housing of Enemy Combatants (EC) were utilized to develop the NAVCONBRIG house rules.

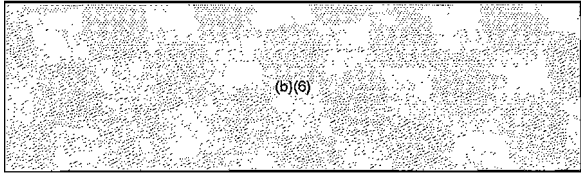
These rules are posted in the NAVCONBRIG conspicuously so that the detainees could review them when transiting to and from outdoor recreation. Additionally, each EC was provided with a copy of the Brig rules to review and then sign. The language utilized is English; both ECs at the NAVCONBRIG speak and read English fluently.

"Conducting periodic unannounced and announced inspections of detention facilities in order to provide continued oversight of interrogation and detention operations." CFFC has periodically conducted announced inspections of the NAVCONBRIG.

"Ensuring that, to the maximum extent practicable, detainees and detention facility of a different gender are not alone together." The NAVCONBRIG only houses male detainees; furthermore, the NAVCONBRIG rules for the Special Handling Unit ensure that no staff member, of either sex, is ever alone with a detainee.

I also understand that there will be further guidance (in the form of a tasker) forthcoming from your office as it concerns the reporting requirements established in section 1093 of the 2005 NDAAA and that the first report required by that section will be due to the Joint Staff approximately 23 JUN 05 (covering the period from 15 JUN 04 to 15 JUN 05).

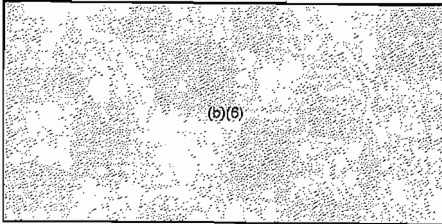

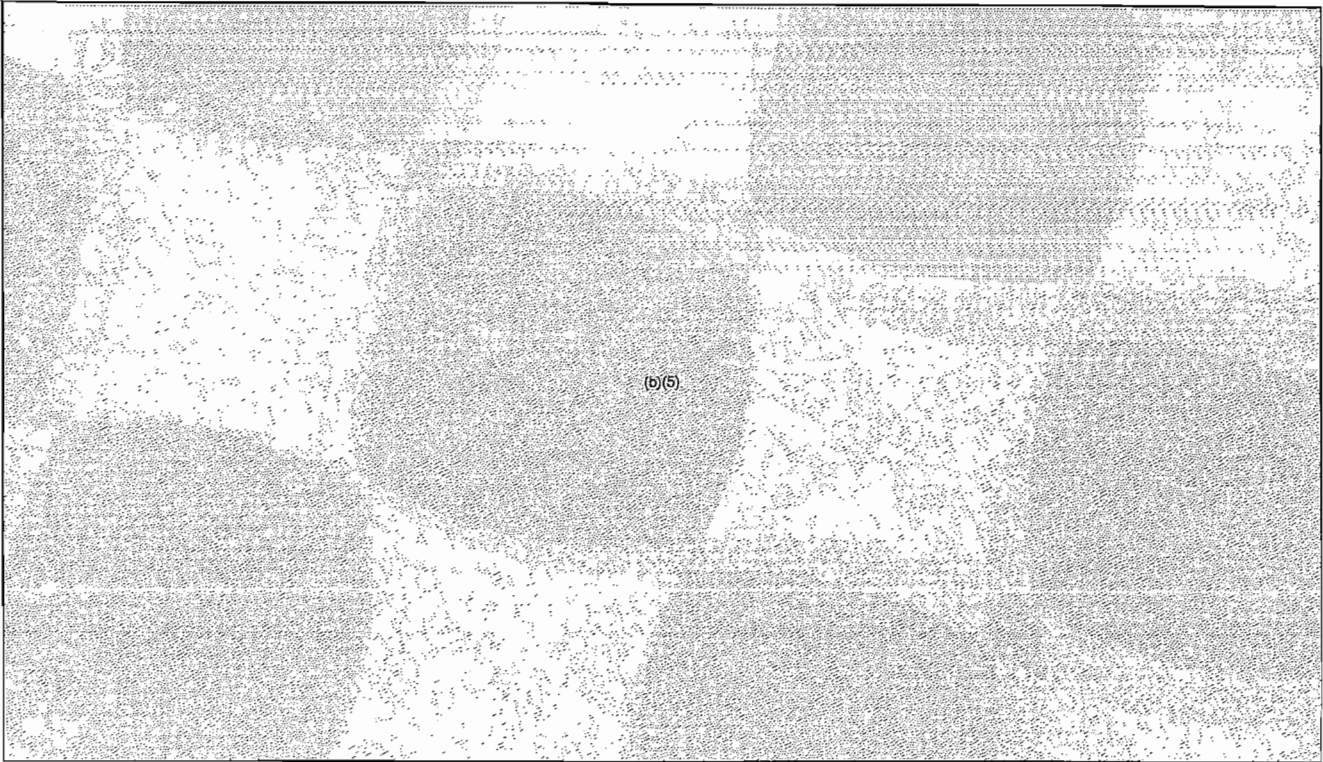

>Here's what I said last October and the same holds true today.

>The ECs are held in the Special Housing Unit, away from the general prison population, in order to ensure their physical safety. The UCMJ population detained at the Brig consists of individuals who have been adjudged guilty and sentenced for committing crimes - in the majority of cases, violent crimes. There are many among them who have displayed violent tendencies. At the same time, given their backgrounds in the United States Military, they tend to profess loyalty to their country and hostility toward persons whom they perceive to be enemies of the United States. They have access to outside media and are familiar with the terrorist attacks of September 11, 2001, ongoing conflicts in the Middle East and Afghanistan, and the fact that two ECs are being detained at the Brig. If the ECs are allowed to socialize with this general population, I would have grave concerns about the serious possibility that one or more of the UCMJ prisoners would try to inflict physical harm on them. Despite strenuous efforts to prevent violence and protect staff and prisoners, inmate-on-inmate violence is unfortunately a common problem at correctional facilities in general, and the risk of such violence is expanded when the situation involves a larger number of prisoners with United States military backgrounds commingled with a single or a small group of enemy combatant detainees. Without keeping the ECs physically separate from the general population, I would not be able to guarantee their safety. For this reason, among others, the UCMJ at Article 12 prohibits me from mixing U.S. military prisoners with enemy prisoners or other foreign nationals not members of the U.S. armed forces. Also, Navy regulations, specifically Secretary of the Navy Instruction 1640.9B, the Navy Corrections Manual, require that detainees be separated from adjudged, that is convicted, prisoners.

>

>The two ECs are likewise separated from each other. Just as allowing socialization of the ECs with the general UCMJ population, allowing them to socialize with each other raises concerns for their physical safety. If one detainee perceives (rightly or wrongly) that another detainee was/is cooperating with the United States and/or had abandoned or was disloyal to their original cause, the latter detainee might be placed in danger of attack. The same risk of physical danger pertains if one detainee perceives (rightly or wrongly) that another detainee is being treated differently somehow (e.g., that the detainee might be released imminently on certain conditions acceptable to the detainee and to the United States, or that one detainee has more privileges than another). Thus, for the safety of both ECs, it is imperative that they be kept separate from one another.

>In addition to the concern for their physical safety, there is a concern that were the ECs placed together they could share information in a way that would be harmful to national security interests. For instance, we have instituted extensive precautions and procedures so that the ECs will not accumulate knowledge and information (some of which is classified) about the Brig facility (the physical layout of the facility; the names and backgrounds of facility personnel; operational patterns at the facility; interrogation methods, etc.) that, in the wrong hands, could be used to the detriment of the United States. If the ECs were permitted to socialize and communicate with each other and "compare notes" about their respective experiences, these risks would be greatly magnified. Commingling the ECs could disrupt/prevent/compromise the gathering of information that could aid in our nation's war on terrorism.

>2. Separate Issue: Unless otherwise directed, it is my intent to allow Padilla to "self-escort" himself for shower time and to remove the magnet cover from his cell window.

> a) My staff agrees that the risks of self-escorting to shower is the potential that he could try to throw himself from the second deck in a suicide attempt or he could fall down and injure himself in the shower and we may not be immediately aware of it. We think those risks are minimal. As we give him free-range of the dayroom during TV time, if he really wants to throw himself off the second deck, it is unlikely we could stop him.

> b) It has come to my attention that the magnet cover on the window was condition determined by (b)(6) in consultation with (b)(2) High. It no longer makes sense given how much access Padilla already has to dayroom. I am exploring the potential of removing #2's magnet as well...would connect it to moving him to category one currently scheduled to happen 7 September if he remains compliant.

>3. We are providing Al Marri with a CD-player, CDs of Koran, and the library list today. Per (b)(6) guidance she has asked that we not give him all his Level Two privileges at one time so we're holding off on the playing cards. Our current intent is to provide playing cards upon request and secure them when he is done. We'll let him keep them in his cell fulltime at level one. Question: Do you know if Gitmo detainees are allowed to keep cards in their cell at Level Two?

Short answer: No we have not posted the Geneva Conventions.

Long answer: My reading is that Section 1092(b)(3) states that we have to have procedures ensuring that "each commander of a Department of Defense detention facility ... (3) Providing all detainees with information, in their own language, of the applicable protections afforded under the Geneva Conventions." The United States government has determined that the detainees at GTMO are unlawful enemy combatants and are therefore not entitled to protections under the Geneva Conventions. Although we treat detainees "consistent with" the Geneva Conventions, the Geneva Conventions do not apply to them.

Therefore, there are no "applicable protections under the Geneva Conventions" that the JDG Commander is required to post.

Ultimately, this is a policy decision. To the best of my knowledge, the detainee rights have never been posted at Guantanamo. The new draft DoD Directive 2310.1E, at paragraph E.3.1.6, states: "Combatant Commanders will ensure detainees are provided with information, in their own language, on the applicable protections afforded under the Geneva Conventions." While there are no "applicable protections under the Geneva Conventions" I can draft a comparison chart of detainee rights if you determine that we should post.

In fact, our JDG commander has asked to either be allowed to post a notice that the Geneva conventions do not apply or to be able to post those protections that do apply.

>I spoke with Mr. al-Marri on 29 Mar, 5 Apr and 12 Apr regarding medical concerns. The most important, recurring issue involves Mr. al-Marri's family. He has requested repeatedly for the opportunity to speak to his family in English or Arabic, as well as the opportunity to receive DVDs of his family. Mr. al-Marri was initially not going to see me today because he was a little upset about receiving pictures of his children who he has not seen in 5 yrs. After one of the MAs returned a book that Mr. al-Marri had asked me to review, Mr. al-Marri agreed to talk with me. The book contains passages for the Qur'aan that are meant to be used to cope with difficult situations. Mr. al-Marri and I discussed his family, and how much he misses them. I believe that it is in Mr. al-Marri's and our best interest for him to be able to communicate in some way with his family. Five years is too long.

>I have also reviewed the daily log for the last week (had previously reviewed all weeks up to 5 Apr) and observed the EC. In addition, I spoke with SHU staff regarding the EC. No changes were noted in his activities of daily living. Overall, there were no signs or

>I spent a total of 36 minutes talking with the Mr. al-Marri and 17 minutes reviewing the logs. I will continue to routinely review the daily logs, observe the EC's interactions with staff members, and speak with him weekly.

>Again, I believe that it essential that we do all we can to support him being able to speak to his family and/or see them via DVDs/videos.

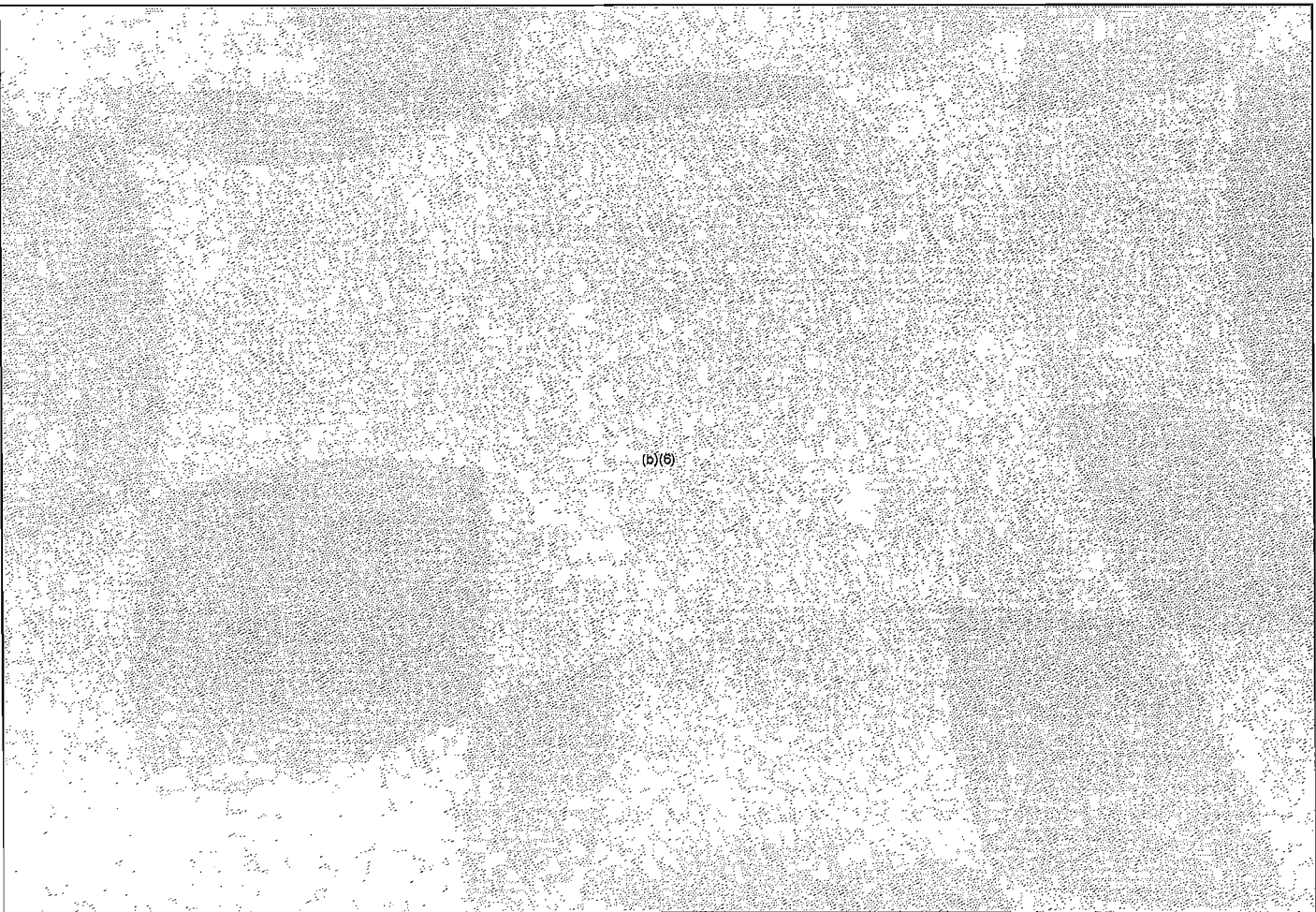

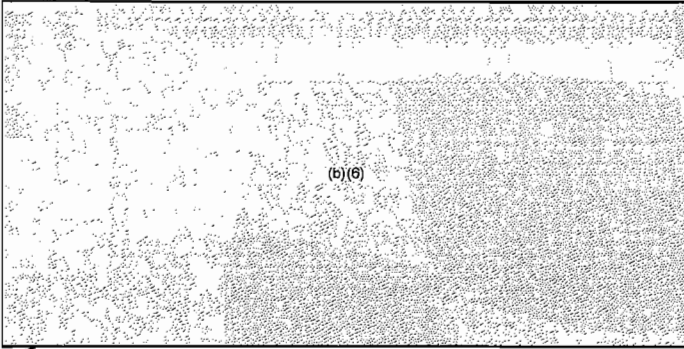
