**Program restrictions:**

- Must not purchase or renew a long-term permit for the academic year starting Sep. 1, 2015.
- Must join the Commute Club\* (Clean Air Cash or Carpool Credit) by Sep. 15, 2015, to participate. Instructions for enrolling can be found at <http://commuteclub.stanford.edu>.
- Monthly and daily permits are not eligible for this promotion. Residential permits are also ineligible.
- Must not purchase or utilize a parking permit (other than daily scratchers or carpool permit) during the commitment period.
- Must be an eligible commuter, required to be on campus at least 20 hours a week during normal weekday business hours, through the commitment period.
- Participants in previous permit-return/permit non-renewal promotions who have received a bonus in the last four years. Participants who have been in the Commute Club during the previous academic year (2014-15) are ineligible.
- Participants apply for one of the incentive amounts listed above, not for all or a combination of the amounts.
- Incentive amount will be paid after the participant completes all or an eligible part of the commitment period.
- If you repurchase a parking permit (other than daily or carpool permits) before your commitment ends, you may forfeit all or some portion of Clean Air Cash, Carpool Credit, and the Permit Non-Renewal promotion reward.

\* **Commute Club eligibility.** You are eligible for the Commute Club if you meet all of the criteria on the Commute Club application and the P&TS website: <http://commuteclub.stanford.edu>.
