Lab – Update on NPDES (National Discharge Elimination System) Water Board has agreed to a combined permit for adulticides and larvicides. Water testing will be required. MVCAC is working on a statewide monitoring program.

Continuing Education – MVCAC Annual Conference all district staff attended workshops on January 19 & 21. Several staff members will be attending the Vertebrate Pest Control Conference in Sacramento on February 22-25. Laboratory staff attended a workshop on Geographic Information Systems.

Operations – Mosquito control work is focused on seasonal impounds now, technicians are now treating mosquito larvae in numerous fresh and saltwater marshes throughout the county. Larvae of winter salt marsh mosquitoes have began appearing on Bair Island – helicopter treatment will begin in 2 weeks.

The City of Redwood City has been pumping water into an undeveloped parcel on the northeast corner of Redwood Shores as a part of a project to deepen their lagoons. This water has caused a large area of mosquito development. The district met with the city engineers on February 3rd. The city will be paying for the cost of controlling the mosquitoes in the newly flooded area.

District Manager's Report

Legislative Update.

AB 79 - (Duvall) Disaster Relief Support Letter Only

This bill allows for Orange, Riverside and San Bernardino Counties which were declared to be in a state of emergency due to wildfires to receive monies due to property tax revenue reductions resulting from reassessment for damages.

AB 155 - (Mendoza) Bankruptcy Oppose

This bill requires a public local entity filing for bankruptcy to get approval from a California Investment Advisory Commission.

AB 288 - (Nestande) Vector Control Neutral

This bill is a rehash of the audit bill. Requires MVCD's to conduct an annual audit, report accounting issues at a Board meeting and report to appointing authorities when levying special benefit assessments.

AB 622 - (Swanson) Pesticides Aerial Oppose Unless Amended

This bill has returned. It dealt with the drifting of pesticides applied aerially. Had to be a safety zone of 3.3. miles from the spray zone and residential areas.

Mosquito and Vector Control Association of California (MVCAC), Bob is now the President Elect on the Board of Directors for 2010.

The number one issue will be NPDES Permit for Adulticiding and Larviciding.

MVCAC 79th Annual Conference will be in Indian Wells in 2011.

Vector Control Joint Powers Agency (VCJPA), Bob was elevated to the 2nd seat Vice President on the Board of Directors. Next meeting set for March 5th at Napa, this is also the Annual VCJPA Conference which starts on March 4th at 0900.

ERMA - we have scheduled Gerry Preciado to provide our on-site training on Conflict Resolution March 18th at 0900. Our Safety Committee will review the Target safety training modules.

Liability Claims – current claims: Bennett, Bryan v. San Mateo County MVCD Vega, Bosco v. San Mateo County MVCD Zheng, Xue v. San Mateo County MVCD

Financial Activity Ledger, we have some movement on one of our potential workers compensation cases where it is now being investigated.

Acturial Services for the GASB 45 Trust Program, we are using Ms. Catherine MacLeod, FSA, EA, MAAA to perform our actuarial services for the GASB 45 post retirement benefit review. We have started sending her the pertinent information. The review will take over 8 weeks.
