No later than December 7, 2005 (63.7(a)(2)(iii))	<i>Conduct Initial Performance Tests/Compliance Demonstrations</i>	By December 7, 2002 or within 180 days from startup, whichever is later (63.7(a)(2)(i), (ii))
Within 60 days following the completion of the performance test, but no later than February 5, 2006. (63.5180(e), 63.10(d)(2))	<i>Results of Initial Performance Tests</i>	By February 5, 2003 or within 60 days following the completion of the performance test whichever is later (63.5180(e), 63.10(d)(2))
July 30, 2006 (63.5180(d))	<i>Notification of Compliance Status</i>	Within 30 days after the end of the initial compliance period ⁴ (63.5180(d))
By January 31, 2007 and semiannually on July 31 and January 31 thereafter (63.5180(g)(1)(ii) and (iv))	<i>Semiannual Compliance Reports⁵</i>	By January 31, 2004 or 30 days after the initial reporting period, whichever date comes later and semiannually on July 31 and January 31 thereafter (63.5180(g)(ii) and (iv))

¹ This timeline does not take into account special situations such as compliance extensions.

² New affected source: An affected source that the construction or reconstruction of which is begun after July 18, 2000. (63.5110)

³ A title V permit application may be used in lieu of the initial notification, provided that the information specified in 63.9(b) is included, the State has an approved part 70 operating permit program and the State has received delegation of authority from EPA.

⁴ The initial compliance period for new sources begins upon startup or June 10, 2002, whichever is later, and ends on the last day of the 12th month following the compliance date. If the compliance date falls on any day other than the first day of a month, then the initial compliance period extends through that month plus the next 12 months. (63.5130(d))

⁵ The initial semiannual report must cover the initial reporting period beginning one day after the end of the initial compliance period and ends six months later.
