**ASSISTANT, ASSOCIATE OR FULL PROFESSOR OF PATHOLOGY
(Medical Center Line Professoriate or Clinician Educator Line) and
DIRECTOR OF CLINICAL HEMATOLOGY LABORATORY**

The Department of Pathology at Stanford University School of Medicine seeks academically-oriented diagnostic hematopathologist with an interest in clinical hematology, for appointment at the rank of Clinical Assistant Professor, Clinical Associate Professor or Clinical Full Professor in the Clinical Educator Line or at the rank of Assistant Professor, Associate Professor or Full Professor in the Medical Center Line (MCL) Professoriate, with the faculty rank and line of the academic appointment depending on the applicant's experience, interests and qualifications.

The major criteria for appointment for faculty in the MCL shall be excellence in the overall mix of clinical care, clinical teaching, scholarly activity that advances clinical medicine, and institutional service appropriate to the programmatic need the individual is expected to fulfill. The major criteria for appointment for Clinician Educators is excellence in the overall mix of clinical care and clinical teaching appropriate to the programmatic need the individual is expected to fulfill. All candidates must demonstrate excellence or promise of excellence in a combination of clinical performance and clinical teaching that advances clinical medicine appropriate to the programmatic need upon which the appointment will be based. This position requires the ability to interact effectively with faculty colleagues in the department. There are many opportunities for research, for those MCL candidates who wish to pursue clinical, translational or basic research. We also encourage our Clinical Educators to participate in research projects of interest to them, as their clinical and educational responsibilities permit.

The individual will be Director of the Hematology Laboratory. Candidates must be board certified in clinical pathology, anatomic pathology or both and hematopathology and are required to obtain or hold a current license to practice medicine in the State of California. Administrative responsibilities will include overseeing the daily operations of an automated hematology laboratory. Sign-out responsibilities will include interpretation of peripheral blood smears, bone marrow biopsies and aspirates, body fluids, flow cytometry, and optionally, lymph node pathology. A record of scholarly contributions in clinical, translational or basic research is desirable for candidates seeking appointment in the Clinician Educator Line, and is required for candidates who wish to be appointed in the Medical Center Line, since the successful candidate in that line will be expected to establish a research program in hematology/hematopathology. Participation in the teaching of fellows, residents and medical students is required.

Applicants should submit a curriculum vitae, as well as a brief description of research accomplishments and plans for future research. These, with the names of five references, should be sent to Stephen J.
