## ADJUSTING PROJECT TRANSACTION CONTROLS - CAPITAL EQUIPMENT /CAPITAL FABRICATIONS DO NOT VEST WITH STANFORD

The Chart of Accounts uses separate expenditure types to identify capital equipment or capital fabrications as vesting (SU) or not vesting (Non-SU) with Stanford. The project templates **assume** that capital equipment or capital fabrications vest with Stanford. Adjustments to transaction controls need to be made if vesting is not with Stanford. Appendix A documents the transactions controls by template for Stanford and Non-Stanford owned equipment and fabrications.

## **PROCEDURE**

- 1. At award/project set-up, the OSR set-up accountant is responsible for noting that capital equipment and/or fabrication vests with the sponsor. (PMO may also request the vesting to be changed.)
- 2. After the project template has been selected and applied to the project, the set-up accountant modifies the transaction controls on the project to make the SU-owned expenditure types non-chargeable and the Non-SU expenditure types chargeable by referring to the table below.
  - a. For all projects except fabrications and capital equipment award projects, procedures for adding/deleting project transaction controls are at Add or Delete Project Transaction Controls "Limit To Transaction Controls" box is not checked
  - b. For fabrication projects and (capital) equipment award projects, procedures for adding/deleting project transaction controls are at Add or Delete Project Transaction Controls "Limit To Transaction Controls" box is checked
- 3. After all transaction controls have been adjusted, run the RM3 180 PTA Configuration report to verify the project transaction controls were correctly updated.

## CHANGING VESTING FROM STANFORD (SU) TO NON-STANFORD (NON SU)
