American Oversight seeks all responsive records regardless of format, medium, or physical characteristics. In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or

discussions. Our request includes any attachments to these records. No category of material should be omitted from search, collection, and production.

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency's implementing regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to public understanding of those operations. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is in the public interest because it is likely to contribute significantly to public understanding of activities of the government. The disclosure of the information sought under this request will document and reveal the operations of the federal government, including how an advocacy organization is influencing federal government activities and policies. The disclosure of the requested information may further reveal the extent of influence private individuals are exerting on federal government activities and policies by virtue of their personal relationship with the president. The American people deserve to know if private individuals without official government roles or responsibilities are unduly affecting federal government policies. And, as described below, American Oversight has the intention and ability to disseminate the records it receives to a broad audience.

This request is primarily and fundamentally not for commercial purposes, but rather the primary interest is in public disclosure of responsive records. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter. American Oversight has demonstrated its commitment to the public disclosure of documents and creation of editorial content. For example, after receiving records regarding an ethics waiver received by a senior DOJ attorney, American Oversight promptly posted the records to its website and published an analysis of what the records

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and your agency's implementing regulations, American Oversight makes the following request for records.

Press reporting indicates the significant degree of influence that Concerned Veterans for America, a Koch-backed advocacy group, has amassed during the Trump administration. Concerned Veterans for America has former employees placed throughout executive branch agencies, including the U.S. Department of Veterans Affairs, the U.S. Department of Energy, the U.S. Department of Defense, the U.S. Department of Transportation, and the U.S. Department of Housing and Urban Development. Public reports, and released public records, further suggest that private individuals—including Bruce Moskowitz, Isaac "Ike" Perlmutter, and March Sherman—with personal connections to the president have held sway over issues affecting veterans affairs.

American Oversight seeks records to understand the degree and nature of influence that Concerned Veterans for America is having on wide-ranging policy discussions that affect millions of Americans, as well as influence of private individuals with connections to the president on federal government actions and policies.

Under the FOIA Improvement Act of 2016, agencies must adopt a presumption of disclosure, withholding information "only if . . . disclosure would harm an interest protected by an exemption" or "disclosure is prohibited by law." Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency's implementing regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to public understanding of those operations. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is in the public interest because it is likely to contribute significantly to public understanding of activities of the government. The disclosure of the information sought under this request will document and reveal the operations of the federal government, including how an advocacy organization is influencing federal government activities and policies. The disclosure of the requested information may further reveal the extent of influence private individuals are exerting on federal government activities and policies by virtue of their personal relationship with the president. Dear Freedom of Information Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and your agency's implementing regulations, American Oversight makes the following request for records.

Press reporting indicates the significant degree of influence that Concerned Veterans for America, a Koch-backed advocacy group, has amassed during the Trump administration. Concerned Veterans for America has former employees placed throughout executive branch agencies, including the U.S. Department of Veterans Affairs, the U.S. Department of Energy, the U.S. Department of Defense, the U.S. Department of Transportation, and the U.S. Department of Housing and Urban Development. Public reports, and released public records, further suggest that private individuals—including Bruce Moskowitz, Isaac "Ike" Perlmutter, and March Sherman—with personal connections to the president have held sway over issues affecting veterans affairs.

American Oversight seeks records to understand the degree and nature of influence that Concerned Veterans for America is having on wide-ranging policy discussions that affect millions of Americans, as well as influence of private individuals with connections to the president on federal government actions and policies.


ProPublica has been working on this story for weeks and has sent inquiries to me, the White House, Cam Sandoval and now Peter O'Rourke.



- 13. What will be the role of Bruce Moskowitz, Aaron Moskowitz, and/or the Biomedical Research and Education Foundation in the implementation of the VA's new medical device registry?

- 14. What was the cost of the Medical Device Registry Summit?
- 15. Why does Camilo Sandoval describe himself as Perlmutter's spy and compare himself with Mr. Fox from "Pulp Fiction"? What is his relationship with Perlmutter and Jared Kushner?
- 16. Why did Sandoval move to VA from Treasury?
- 17. What is Sandoval's response to the sexual harassment allegations against him?
- 18. Who asked Jake Leinenkugel to prepare the Dec. 4 memo to Sandoval? Who did Sandoval share the memo with?
- 19. On Sept. 18, 2017, in an email to VA officials, Perlmutter wrote: "We have been talking to Dr. Shulkin for many months about identifying the existence of healthcare delivery issues at VA medical centers... Strategic Priorities

Priority 1: Greater Choice for Veterans

The MISSION Act passed with overwhelming bipartisan support through both chambers and was signed into law by the President on June 6, 2018. The link to read the Act is https://www.congress.gov/115/bills/s2372/BILLS-115s2372enr.pdf.

Priority 2: Focus Resources

The President's FY 2019 Budget requests \$198.6 billion for VA — \$88.9 billion in discretionary funding (including medical care collections), of which \$76.5 billion is requested as the FY 2019 AA for Medical Care including collections.

In total, the discretionary request is an increase of \$6.8 billion, or 8.3 percent, over the President's FY 2018 Budget request. It will sustain the progress we have made and provide additional resources to improve patient access and timeliness of

medical care services, while improving benefits delivery for our Veterans and their beneficiaries.

Priority 3: Modernizing VA Systems and Services

EHRM -- adopt the same electronic health record (EHR) system as the Department of Defense (DoD). This transformation is about improving VA services and significantly enhancing the coordination of care for Veterans who receive medical care not only from VA, but DoD and our community partners.

Continue IT Modernization through the incorporation of business process reengineering to support Financial Management Business Transformation across the Department.

This approach would continue modernization of our financial management system by transforming the Department from numerous stovepipe legacy systems to a service business transaction environment.

Priority 4: Improve Timeliness

In FY 2019, VA will expand Veteran access to medical care by increasing medical and clinical staff, improving its facilities, and expanding care provided in the community. The FY 2019 request will support nearly 315,688 medical care FTE, an increase of 5,792 above the 2018 level.

VBA is also undertaking a similar approach to modernize its appeals process through legislative reform, increased resources, technology, process improvements, and increased efficiencies. The requested \$74 million for appeals processing increases VBA's appeals FTEs by 605, more than 40 percent above 2018.

Priority 5: Suicide Prevention

The VA continues to expand Veterans' mental health services, utilizing process modernization, executive orders, and budgetary expansion.

Follow-on Actions from 2017 Legislation

Congress expects measurable results through the utilization of new tools provided in legislation.

July 17, 2018: GAO presented its findings on *Information Technology Cloud Computing* (Job Code 102299). This review was conducted in response to a request made by the Chairman of the House Committee on Oversight and Government Reform and its Subcommittee on Government Operations and Information Technology.

GAO's key questions were:

- Evaluate selected agencies' progress in implementing cloud services and determine the extent to which the agencies have experienced cost savings.
- Describe agency-reported examples of successful cloud migrations and deployments.

<u>Meeting Summary:</u> GAO provided a statement of facts prior to the meeting. OIT agreed to provide recent data to more accurately reflect progress VA has made by July 31. GAO stated that recommendations to VA will be based on what additional information is provided.

GAO anticipates providing its report for comment in Fall 2018 and allowing 30 days for comment. GAO anticipates issuing its final report in winter 2018.

July 17, 2018: GAO presented its findings on **Veterans Choice Program Providers Payment Timeliness** (Job Code 102637). This review was conducted in response to a request made by the Ranking Member of the Senate Committee on Veterans Affairs.

GAO's key questions were:

- 1. To what extent have the Department of Veterans Affairs and its third party administrations (TPA) established requirements related to the timeliness of payments to community care providers and what mechanisms do VA and the TPAs have in place to monitor compliance with those requirements?
- 2. How and to what extent has VA monitored the TPA's timeliness in processing payments to community care providers and what actions has VA taken to address any identified timeliness issues and to hold TPAs accountable?

<u>Meeting Summary:</u> GAO provided a statement of facts prior to the meeting that VA agreed with, and provided minor clarifying edits. GAO anticipates making recommendations in the areas of timeliness of approvals for secondary authorization requests, and requirements for customer service calls.

GAO anticipates providing its report for comment in mid-August 2018 and allowing 30 days for comment. GAO anticipates issuing its final report in September 2018.

GAO Final Reports:

VA HEALTH CARE: Progress Made Towards Improving Opioid Safety, but Further Efforts to Assess Progress and Reduce Risk Are Needed (GAO-18-380). VA's 60-day update is due to GAO July 27, 2018. GAO made five recommendations to VA:

- <u>Recommendation 1</u>: The Undersecretary for Health should ensure that Central Office, VISNs, and medical facilities document the actions they take towards achieving OSI goals.
- Recommendation 2: The Undersecretary for Health should ensure that any OSI goals that have not been met have clearly defined, measurable outcomes, including milestones or numerical targets, as appropriate, and timeframes.
- Recommendation 3: The Undersecretary for Health should track the use of the OTRR (or any subsequent tool) by providers prior to initiating opioid therapy.
- <u>Recommendation 4</u>: The Undersecretary for Health should ensure that all VISNs have implemented an academic detailing program that supports all medical facilities in the VISN and that all VHA medical facilities have a designated primary care pain champion as required.
- <u>Recommendation 5</u>: The Undersecretary for Health should require VHA medical facilities to take steps to ensure provider adherence to opioid risk mitigation strategies, including querying PDMPs, obtaining written informed consent, and conducting urine drug screening. For example, these steps could include creating alerts in the electronic medical record system to remind primary care teams when these actions should be completed or strengthening facility monitoring of providers.

VETERANS CHOICE PROGRAM: Improvements Needed to Address Access-Related Challenges as VA Plans Consolidation of its Community Care Programs **Needed** (GAO-18-281). VA's 60-day update is due to GAO August 3, 2018. GAO made ten recommendations to VA:

- Recommendation 1: The Under Secretary for Health should establish an
 achievable wait-time goal for the consolidated community care program that VA
 plans to implement that will permit VHA to monitor whether veterans are
 receiving VA community care within time frames that are comparable to the
 amount of time they would otherwise wait to receive care at VHA medical
 facilities.
- Recommendation 2: The Under Secretary for Health should design an appointment scheduling process for the consolidated community care program that VA plans to implement that sets forth time frames within which (1) veterans' referrals must be processed, (2) veterans' appointments must be scheduled, and (3) veterans' appointments must occur, which are consistent with the wait-time goal VHA has established for the program.
- Recommendation 3: The Under Secretary for Health should establish a
 mechanism that will allow VHA to systematically monitor the average number of
 days it takes for VAMCs to prepare referrals, for VAMCs or TPAs to schedule
 veterans' appointments, and for veterans' appointments to occur, under the
 consolidated community care program that VA plans to implement.
- Recommendation 4: The Under Secretary for Health should implement a
 mechanism to prevent veterans' clinically indicated dates from being modified by
 individuals other than VHA clinicians when veterans are referred to the
 consolidated community care program that VA plans to implement.
- <u>Recommendation 5</u>: The Under Secretary for Health should implement a
 mechanism to separate clinically urgent referrals and authorizations from those
 for which the VAMC or the TPA has decided to expedite appointment scheduling
 for administrative reasons.
- Recommendation 6: The Under Secretary for Health should (1) establish
 oversight mechanisms to ensure that VHA is collecting reliable data on the
 reasons that VAMC or TPA staff are unsuccessful in scheduling veterans'
 appointments through the consolidated community care program VA plans to
 implement, and (2) demonstrate that it has corrected any identified deficiencies.
- <u>Recommendation 7</u>: The Secretary of Veterans Affairs should ensure that the
 contracts for the consolidated community care program VA plans to implement
 include performance metrics that will allow VHA to monitor average driving times
 between veterans' homes and the practice locations of community providers that
 participate in the TPAs' networks.

- <u>Recommendation 8</u>: The Secretary of Veterans Affairs should establish a
 system for the consolidated community care program VA plans to implement to
 help facilitate seamless, efficient information sharing among VAMCs, VHA
 clinicians, TPAs, community providers, and veterans. Specifically, this system
 should allow all of these entities to electronically exchange information for the
 purposes of care coordination.
- Recommendation 9: The Under Secretary for Health should conduct a comprehensive evaluation of the outcomes of the two appointment scheduling pilots it established at the Alaska and Fargo VA Health Care Systems (where VAMC staff, rather than TPA staff, are responsible for scheduling veterans' Choice Program appointments), which should include a comparison of the timeliness with which VAMC staff and TPA staff completed each step of the Choice Program appointment scheduling process, as well as the overall timeliness with which veterans received appointments.
- Recommendation 10: The Under Secretary for Health should issue a
 comprehensive policy directive and operations manual for the consolidated
 community care program VA plans to implement and ensure that these
 documents are reviewed and updated in a timely manner after any significant
 changes to the program occur.





Current state of VA

- Product recall office in the VA takes 0-10 days to initiate a recall, with an estimated 99% recall rate
- Bruce is conducting a stop-gap analysis focusing on implants, both biologic and non-biologic (mostly biological tissue in the VA population)

dle minor ailments, maybe checking blood pressure and hemoglobin levels occasionally. After all, the retail clinic chains have been saving for years that they will expand significantly into chronic care management; if the value were so compelling (or access to new patients so likely), that should have happened already. Insurers could have created joint ventures with retail clinics or benefit designs that more strongly encouraged use of those clinics. The fact that they haven't could indicate that clinics have less potential than the framers of NewCo claim. Providers can return to business as usual.

I would argue that providers' reaction should be the same whether they believe CVS-Aetna is a game changer or merely a pocket liner for executives and their advisors. If CVS-Aetna cannot lure patients away with lower prices and convenient services, some other player will surely try.

Medical Devices in the Real World

Mhen it comes to medical devices, the Food and Drug Administration (FDA) is tasked with the herculean balancing act of ensuring efficacy and safety while accelerating access to new technologies for patients most likely to benefit from them. These two goals are inherently in conflict, but the FDA must make decisions daily, with imperfect information, regarding the approval and continued use of devices.

The approval process has been criticized for being burdensome and slow, and new medical devices are frequently available for use outside the United States well before FDA review and clearance occur. Yet the FDA has also been criticized for inadequate evaluation of medical devices, and there have been notable recalls due to serious and occasionally fatal consequences of device failures. Further challenging this balancing act is the dynamic nature of medical devices, which, unlike drugs, undergo continuous iteration and design improvements.

The recently passed 21st Century Cures Act provides guidance in balancing these competing priorities by directing the FDA to consider how best to use realworld evidence (RWE) for reasonable assurance of device safety and effectiveness while accelerating access to important new technologies.¹ RWE includes information generated through routine health care delivery, including electronic health records (EHRs), billing data, clinical registries, and other data sources. Unfortunately, this information is inherently flawed by inconsistency, incompleteness, and bias from the very treatment decisions we might wish to elucidate. For these reasons, rigorous observational statistical methods are required to mitigate the limitations of real-world data.

. As EHRs are adopted ever more broadly, RWE will become a more accessible and lower-cost source of detailed clinical information that could help clinicians and regulators understand the performance of medical devices in real-world practice. The recently implemented FDA regulations requiring use of a structured unique device identifier (UDI) will also help to unlock RWE for medical devices. Whereas drugs have had a standardized coding system for many years, the lack of a UDI for devices has greatly hampered use of RWE for evaluation of medical devices after market release. As UDIs become used routinely throughout our purchasing, inventory, clinical documentation, and billing systems, the ability of RWE to associate a particular device with a particular patient at a specific point in time will make it an ever more powerful resource.

As clinicians with responsibility for our patients' well-being, we should carefully consider how RWE could be used, and potentially misused, in support of complex regulatory decisions regarding medical devices. The FDA recently published guidance on potential use of RWE for supporting initial decisions to approve

or clear devices for use in the United States as well as postmarketing assurance of medical device safety and performance.2 Although there are substantial opportunities for applying RWE to both these domains, we believe that such evidence will be most valuable in the near future for postmarketing, since it is particularly in this setting that our current systems are inadequate for ensuring the safety and evaluating the performance of modern medical devices. The largest gaps in our understanding of devices relate to use outside the context of controlled clinical trials, and it is there that the majority of RWE will be collected.

For the past 40 years, the FDA has relied extensively on physicians to report adverse events suspected to be related to a medical device. Unfortunately, clinicians significantly underreport such events: some estimates suggest that only 0.5% of all devicerelated adverse events are reported to the FDA. Meanwhile, traditional postapproval studies, frequently required as a condition of approval, are often far too small, lack adequate controls, are expensive to conduct, and rarely lead to actionable information regarding safety or performance of the device.

RWE from high-quality sources could supplement the adverse-event reporting process and might be able to replace many postapproval studies that are currently required, saving substantial expense and time. The routine use of RWE for active surveillance of devices, through routine monitoring of patients' experiences, offers tremendous opportunities for early identification of safety signals, which can inform clini-

cians, patients, and regulators about potential problems and inform manufacturers where they might focus redesign efforts to improve the device. Studies of active surveillance have demonstrated its ability to identify performance differences between approved devices and to save significant time as compared with traditional adverse-event reporting.

In contrast, we believe that the FDA should adopt a more cautious approach to using RWE to support device-approval decisions. Perhaps the best initial use of RWE in the premarketing setting is to leverage electronic clinical data resources to support pragmatic clinical trials by embedding the necessary data collection into ongoing registries or EHR systems. Such approaches could significantly reduce the cost and time required to complete a study as compared with traditional randomized clinical trials. Clinical follow-up through routine care or prespecified electronic patient contact could offer tremendous efficiencies, while also permitting broader patient populations to participate in trials of innovative therapies.

Another application of RWE could be to support expansion of the populations or conditions for which a device is approved. The value of RWE for this purpose has been borne out by recent experience with transcatheter aorticvalve replacement (TAVR) devices: the FDA broadened the indications for TAVR use on the basis of an analysis of the RWE from the national Transcatheter Valve Therapy registry. The first TAVR device was approved in 2011 for insertion either through the femoral artery or through a small chest incision and direct placement through the apex of the heart. However, many patients who would benefit from TAVR could not be treated using these vascular access options. Within 2 years, the FDA leveraged the early national experience using the registry to expand the options to include access routes such as the subclavian artery and the thoracic aorta.3 By all accounts, this approach cost substantially less and took significantly less time than the studies that would otherwise have been required to demonstrate efficacy in new groups of patients.

We believe, however, that there are important risks in basing initial market-approval decisions for high-risk medical devices on contemporary RWE. Even with the most stringent methods of statistical adjustment, RWE-based analyses are observational in nature, with inherent biases in treatment choice coloring the patterns and associations that might be observed. An example of the risks posed by reliance on imperfect clinical data can be found in the recently evaluated device designed for treating poorly controlled hypertension with radiofrequency ablation of the autonomic nerves supplying the kidneys. Although

early European randomized, but unblinded, trials and extensive postapproval clinical studies had shown that this new technology had impressive efficacy, the pivotal FDA-mandated, U.S., blinded, sham-controlled study revealed no advantage of the device over the best medical therapy.4 This example highlights the potential risks of basing regulatory approval on imperfect clinical evidence; reliance on the best available RWE for this device would probably have exposed many U.S. patients to an invasive procedure, with all its attendant risks, for no clinical benefit.

Over the next few years, the accelerating adoption of integrated EHR systems and information standards will undoubtedly provide us with many new opportunities to leverage RWB to elucidate which patients could benefit the most from medical devices, while assisting manufacturers in improving their products. The FDA and the clinical community can work together to maximize the impact of these emerging new sources of rich clinical information to support regulatory decisions and clinical choices. Our collective efforts can focus initially on active surveillance and other postapproval applications of RWE that can improve our understanding of the performance of medical devices, including which patients benefit the most from particular technologies. As experience grows with the application of RWE, extending its use into phases of the review process will become more reliable and appropriate.

Melissa,

I have seen nor heard of any movement on this plan since early January. VHA is in the process of hiring new managers for several areas. I am of the opinion that the hiring of new managers is not truly what is needed, but rather a restructuring of the entire VA supply chain to address our many shortcomings. We have more than enough people. What is lacking is the right mix of talent and vision.

Of import is the need to consolidate leadership and the entire supply chain into a centralized support service providing much needed leadership throughout the organization, with centralized control of the budget for all positions (contracting, logistics) and development of service level agreements between supply chain and the three administrations it will serve (NCA, VBA and VHA). The supply fund must necessarily be under the control of the office of the CSCO. If the VA is to gain control of its ENTIRE supply chain and be effective in managing the same, I can see no other way.

I know this is a big leap for VA. I know it runs counter to the culture of this organization and impinges on the autonomy the facilities and VISN's enjoy. I also know it runs counter to the culture of VACO. The VA currently has three supply chains: the VISN and Facility level supply chain, OALC and Contracting, and VHA Supply Chain "leadership". The continuation of this "tri"-furcated supply chain only guarantees, in my opinion, the continuation of its failures. I honestly believe it will impact the DMLSS implementation, the fix of the current MSPV (J&A is still not done) and the roll out of the new one. The VA absolutely needs one CSCO,

reporting to the DepSec, with the charge of fixing this in as rapid a fashion as possible and it needs to occur much sooner rather than later. Time is running out.

If nothing else, this reorg plan proposed in December and January allows the VA the chance to change the dynamic: this is a culture of "No, we can't do that and I am offering no alternatives" from various offices that have NO responsibility for the outcomes associated with their decisions to "The order of the day is to find the way to get it done."

There is, of course, an alternative: turn VHA's entire supply chain, including all contracting for all things patient care, over to DLA/DHA. They have leadership that knows what a healthcare supply chain is all about and can provide the levels of service, product mix, standardized operations and processes, etc., that we seem unable to provide. It fits with Congress's directive to share services and information to streamline operations and save money, it fits with the Administration's desire for fast and effective action.

I cannot stress how important this is.




