- Proposal Central application submission: helpful hints

Letter of intent/pre-application/pre-proposal submission: typically PIs do not have to submit their LOIs, pre-applications, or pre-proposals through their RPMs in RMG or CGOs in OSR.

Exception: CE faculty must submit and obtain approval for their [CE faculty PI waivers >>](#) through their RPMs at least one week prior to the sponsor’s LOI, pre-proposal, or pre-application deadline if the sponsor uses those to screen and then invite PIs to submit full proposals.

Mission Boost Grant

These grants are opportunities for ACS grantees to seek additional, or “boost,” resources for innovative, high-risk/high-reward projects. MBGs offer 2 stages of funding.

Primary Mission Boost – A maximum \$100,000 Direct plus 20% Indirect costs per year may be requested for up to 2 years (Total: \$240,000).

Secondary Mission Boost – A maximum of \$300,000 Direct plus 20% Indirect costs (Total: \$360,000) may be requested for up to 18 months.

Applicants must be either current or past ACS grantees who:

--Have **held or currently hold** one of these grants (or previous versions of such awards): Research Scholarship Grant (RSG), Mentored Research Scholar Grant (MRSRG), Cancer Control Career Development Awards (CCFDA), or Pilot and Exploratory Projects in Palliative Care (PEP) award.

This RFP fosters the development of clinicians to clinician scientists. **Clinician scientists are investigators licensed to provide patient care** and trained to conduct research. They pursue research questions across the cancer research continuum of relevance to improving health.

Per the above policy, the internal proposal/institutional representative deadline is **the complete by date**--your fully approved and completed PDRF form and application materials must be provided to your RPM/RMG or OSR.

Proposal Central application submission: helpful hints

IMPORTANT:

SoM PIs: How to delegate the authority to submit your proposal to the RPM*.

In order for RPMs to review and submit grants through Proposal Central, the PI has to go to the section of the application titled "Enable Other Users to Access this Proposal." The PI should scroll to the bottom of the page, enter the RPM's email address, then give the RPM "administrative" permission. The "administrative" permission allows the RPM to view, edit and submit the application. If the RPM is not given "administrative" permission, the RPM will not be able to access the submit button.

*For PIs in other schools- substitute your OSR contract officer's name/email where RPM appears.

Special Note: Selecting the Institution's Name

School of Medicine PIs: select item #6 (following the "MDA clinic" listing) when they search for Stanford University. This one has our Porter Drive address.

PIs in other schools: Select "the Board of Trustees of the Leland Stanford Junior University" which will display the OSR address.

Selecting a signing official: the "Stanford University" profile will include the list of RPMs. If "the Board of Trustees of the Leland Stanford Junior University" is selected, this profile will show the OSR signing officials.
