# SANTA CLARA COUNTY FIRE DEPARTMENT 2015 Annual Report

#### **Mission Statement**

The Santa Clara County Fire Department exists to protect the lives, property, and environment from fires, emergency incidents, and disasters through preparedness, prevention, education, and emergency response.

# **About County Fire**

Santa Clara County Fire Department (County Fire) is an internationally accredited agency that serves over 226,700 residents and 128.3 square miles of territory within the communities of Campbell, Cupertino, Los Altos,

Los Altos Hills, Los Gatos, Monte Sereno, Saratoga, and adjacent unincorporated areas.

Governed by the Santa Clara



County Board of Supervisors, County Fire is divided into the following service divisions: Administration, Fire Prevention, Operations,

Training, Personnel Services, Support Services, as well

as the Office of Emergency Management and Community Education.

County Fire has approximately 280 employees. Daily 24-hour emergency response staffing consists of 66 firefighters and officers operating out of 15 fire stations with 19 pieces of apparatus and 3 command vehicles. The fire suppression force is augmented by 27 trained volunteer firefighters.

# **PARTNERSHIPS AND RESOURCE SHARING**

#### **2015 Wildfire Season**

County Fire deployed resources throughout California and Washington during the 2015 fire season. Allocated resources included strike teams as well as emergency management and specialized support personnel. Reserve apparatus were placed into service to maintain a high level of staffing at the local level.





#### **Urban Shield**

Urban Shield is a regional exercise that tests emergency response capabilities through specialized scenarios. County Fire's Hazardous Materials team took 1st place and the Urban Search & Rescue team placed 2nd in their respective disciplines.



# **PERFORMANCE MEASURES**

#### **Customer Service**

Maintain a rating at or above 95%. Result: 98%

#### **Community Education**

Make contact with 20% or more of the population served. Result: 30%

#### **Fire Prevention**

Limit commercial fires to 4 per 1,000 occupancies inspected. Result: 0.1 per 1,000

Limit hazardous materials responses to 1 per 100 permitted occupancies. Result: 0.6 per 100

#### **Emergency Response Times**

EMS Calls: 90% of the time, a fire company with one paramedic arrives in under 8 minutes.

**Result:** In the metropolitan and urban areas, County Fire arrived in 7 minutes 28 seconds or faster.

# Structure Fire Calls: 90% of the time, the first unit arrives in under 8 minutes.

**Result:** In the metropolitan and urban areas, County Fire arrived in 8 minutes 28 seconds or faster.

#### Structure Fire Calls: Establish OSHA firefighter safety standard "2-in/2out" on structural fires in less than 9 minutes from dispatch of alarm at least 90% of the time.

**Result:** In the metropolitan and urban areas, County Fire established "2-in/2out" in 12 minutes 8 seconds or faster.

Structure Fire Calls: Have an effective firefighting force on-scene in less than 15 minutes from dispatch of alarm at least 90% of the time. Result: In the metropolitan and urban areas, County Fire established an

effective response force in 15 minutes 6 seconds or faster.

#### **Emergency Medical Services**

Obtain return of circulation or shock rhythm on cardiac arrest patients in the field at least 15% of the time. Result: 24%

911 dispatchers screen for pre-arrival instructions in at least 65% of EMS calls and provide instructions as warranted. Result: 80%

#### Safety

Limit the number of reported job related employee illnesses and injuries to less than .33 per capita. Result: .19

#### **Finance**

Receive a "Clean" opinion on audited financial statements and comply with generally accepted acounting standards including any new pronouncements.

**Result:** Successfully received a clean opinion from an outside CPA on District's comprehensive annual financial report and successfully implemented GASB Statement No.68, Accounting and Reporting for Pensions.

Limit employee usage of sick leave, including all protected leaves, to less than 50% of annual accrual rate. Result: 32%



## **Community Toy Program**

County Fire participated in local community toy programs by collecting toys at fire stations during the holidays.

Balls, books, and crafts were just some of the toys that were provided to over 2,500 local children of economically disadvantaged families.

County Fire launched a "Find the AED" contest. Using the PulsePoint application, community residents competed to locate and submit the highest number of unregistered automated external defibrillators (AED) for a chance to win an Apple Watch. Through the contest, a total of 100 new AEDs were located throughout County Fire's jurisdiction.

The PulsePoint registery gives professional first responders and citizens responding to PulsePoint alerts the ability to quickly find and use AEDs during cardiac emergencies.
