# CURRENT AND FUTURE RESEARCH

My research lies at the intersection of philosophy and economics, covering both historical and systematic aspects. While working on my first book, *Inventing the* Market, I developed an interest in meso-level institutions such as corporations or bureaucratic organizations, which mediate the relation between individuals and society. Hence, in my next book project (provisionally entitled Reclaiming the Systems. Moral Agency in Organizations), I explore the relation between individual moral agency and organizational contexts, which is often neglected in normative theorizing because it falls in between moral and political theory. A driving assumption is that many moral ills are caused not by individuals' evil intentions, but by organizational failures. Another driving assumption is that individual behavior is often influenced by social contexts, but that this should not lead us to give up the idea of the morally responsible individual, but rather to include a collective responsibility for social contexts into the individual's set of duties. In order to think about these questions, I integrate various discourses in moral and political philosophy, but also social psychology and organizational studies, including some of my own empirical research (qualitative interviews). The book will center on themes such as the relation between private self and professional role, responsible handling of information, and the responsibility for a culture in which moral concerns can be addressed.

In addition, I work on a number of projects that concern normative aspects of markets, broadly understood. What connects them is the attempt to think about reallife problems at a "non-ideal" level, but without giving up the aspirational character of normative theorizing.

- In the paper "The multiple values of work" (co-authored with Anca Gheaus, currently under review), we argue that theories of distributive justice need to take into account not only the distribution of income through the labor market, but also the distribution of non-monetary features of work, for example opportunities to develop one's skills or to make a social contribution.
- In the paper "The normative stakes of economic growth. Distribution, opportunities and independence in Adam Smith and today" (advanced draft stage) I analyze Smith's reasons for endorsing economic growth. I argue that he saw growth as a means for achieving three desiderata: a distribution that benefits the poor, a harmonization of individual and societal interests, and the independent standing of citizens. Today, however, economic growth is neither sufficient nor necessary for achieving these desiderata, so different means should be chosen to achieve them.
- In the paper "Feasibility, motivation, and economic ideology" (advanced draft stage) I analyze the ways in which an economic ideology, which sees human nature as fundamentally egoistic, shapes the limits of feasibility with regard to egalitarian reforms.
- In the paper "No Company is an Island. The corporate responsibility for the morality of industries" (early draft stage) I analyze the ways in which the behavior

of companies has an impact on, and is impacted by, decisions of competitors in the same industry. Based on a case study in development finance, I argue that companies have a duty to contribute to the moral development of their industry, especially when there are path dependencies.

• In the paper "Two kinds of professional ethos" (early draft stage) I argue that the traditional understanding of professional ethos is tied to an understanding of local moral risks in principal-agent-relations; hence, a different understanding of professional ethos is needed to address systemic risks, as they occur in highly interconnected systems.
