Water use facts and tips:

 Replace older washers with high efficiency machines (mostly front-loading varieties),

which use about 50% less water and 70% less energy than older washers.



Ask your route operator about these machines. A rebate may be available for the replacement of your old washing machine. Call the district at (408) 265-2607, extension 2707 for more details

- Adjust your watering schedule at least every month. Plants require only one-third as much water in October as they do in July.
- Leaks can account for 10-20% of an apartment building's water use. Check and repair all leaks.
- Check your sprinkler system at least once a month between April and October. Otherwise, broken and misaligned sprinklers can go undetected for months.
- The average apartment unit with ultra-low flush toilets uses approximately 17,000 fewer gallons of water per year than units with older toilets. Ask about our free or low cost toilet replacement programs.

During the house call, we'll:

- Check your toilets for leaks and replace toilet flapper valves if needed and requested.
- Measure your showerhead flow rates and install free showerheads if needed and requested.
- Measure faucet flow rates and provide faucet aerators for kitchens and bathrooms.
- Evaluate the efficiency of your irrigation system.
- Provide you with a personalized irrigation schedule if appropriate.
- Identify irrigation leaks, broken or mismatched sprinkler heads, high water pressure and other common problems.
