3. MINUTES OF THE JANUARY 9, 2001 MEETING

Ritchie/Sternberg Moved/Seconded to approve the meeting minutes. Passed unanimously with White abstaining.

Sternberg/Ritchie Moved/Seconded to amend the PRC Council item to include language that the PRC and the Peace and Justice Commission be given the opportunity to review the draft of the proposed intelligence policy before it is finalized. Passed unanimously.

Barbara Attard reported to the Commission that there were approximately 40 candidates for investigator, and eight were interviewed by a panel. The candidate pool was reduced to four and second interviews would be conducted.
