Chair Ritchie asked staff to write a letter to the Council inviting the Council members to participate in the planning.

 - a. DEA Raids of Medical Marijuana Facilities

Commissioner Sherman presented two items for the PRC to forward to the Council regarding the Commission's concerns about U.S. DEA raids of medical marijuana facilities in San Francisco and Oakland and the arrest of Mr. Ed Rosenthal, a medical marijuana expert and activist. The items were revised by the PRC.
