Helicopters were banned by the City Council and use of helicopters from other jurisdictions are allowed only in specified circumstances as stated in Resolution No. 51,408-N.S. **Sternberg/Ritchie** (**Moved/Seconded**) **That the Council** 

resolution regarding helicopters be reiterated and that a Training and Information Bulletin be issued—Include language regarding other jurisdictions. Passed unanimously.
