5. BPD CHIEF'S REPORT

Lt. Yuen reported for Chief Meisner that BPD held its Annual Berkeley Safe Neighborhoods meeting at BPD and it went well.

In the upcoming budget several BPD positions will be eliminated to include: a BART Safety Escort, 2 Berkeley Guides, 2 community service officer, positions, 5 bike officers, and one Domestic Violence officer; the positions are presently vacant.

Chair Sternberg reported that the shooting investigation committee has met with the City Manager and asked for documents needed for the investigation of this case as many documents had been withheld. Interview tapes and or/transcripts of interviews were requested and transcripts of interviews with officers involved with and present during the shooting were received on April 19.

The committee has made the following conclusions:

- 1. All interviews suffer from heavy redaction. In this case and for future cases it is important to clarify the redaction policy and the use of redactions in documents received.
- 2. The April 19 letter received from the City Manager contains a statement that there was not an agreement between BPD and OPD, but careful reading of transcripts implies some agreement or protocols in responding to bank robberies.
- 3. The committee has some forensic-specific concerns about the incident.
- 4. The committee is requesting a meeting with Chief Meisner to clarify some questions.
- 5. There is a discussion in the Ford Foundation/PARC report in the PRC packet for tonight's meeting regarding dangers involved in foot pursuits. The committee feels that some of the issues addressed are pertinent to this investigation.

Commissioner Radisch stated that the subcommittee is requesting meeting with Chief Meisner because of a pattern of redactions that makes it difficult to investigate cases.

Andrea Prichett stated that the PRC has the authority to follow up on the origins of the gun that was attributed to Mr. Givens.

Ritchie/Radisch to open an investigation of the in-custody death of Tyrone Hughes. Passed unanimously.
