4. PRC OFFICER'S REPORT (For Discussion or Action)

5. BPD CHIEF'S REPORT

Lieutenant Williams reported that it was U.C. P. D. and not B.P.D. that was involved in the demonstration that took place at the U.C. Santa Cruz campus, around April 24<sup>th</sup>, 2005.

Lieutenant Williams reported that the City's budget process continues to move forward. In addition to the reduction of seven officer positions, the budget also eliminates the Berkeley Booster Guide Program and the B.A.R.T. Escort Program. There will be reductions in the School Crossing Guard Program from twenty three (23) posts to fifteen (15) posts. In addition to these changes, the Department will not replace one (1) Lieutenant position and there will be some middle management restructuring. A Captain will be promoted to fill the position that Chief Hambleton vacated.
