2. PUBLIC COMMENT

He informed the Commission of his position, as the Council aide to Kriss Worthington, which is located at the Civic Center, 5th Floor, and welcomed the Commissioners to visit.

Commissioner Sherman and Smith stated that Michael Sheen could possibly become involved with another Commission.
