The Berkeley Police Review Commission (PRC), established by voter initiative in 1973, has independent authority to investigate complaints filed against employees of the Berkeley Police Department (BPD) and to provide for *community participation* in setting and reviewing BPD policies, practices, and procedures. The Commission is made of nine members, one each appointed by the City Council and the Mayor.

BERKELEY MUNICIPAL CODE

Section 3.32.080 Special meetings--Petition requirements: On the petition of fifty (50) or more citizens in the City of Berkeley filed in the office of the Secretary of the Commission, the Commission shall hold a special meeting in an appropriate and convenient location for the individuals so petitioning for the purpose of responding to the petition and hearing and inquiring into matters identified therein as the concern of the petitioners.

CITIZEN PETITION

On October 19, 2006, the PRC received a petition of eighty-four (84) citizens of the City of Berkeley requesting a special public hearing to discuss: "The Future of the Police Review Commission." Pursuant to B.M.C. Section 3.32.080, the PRC is required to hold a public hearing on the above matter on Wednesday, October 25, 2006, 7:30 P.M. at the North Berkeley Senior Center, 1901 Hearst Avenue (at Martin Luther King, Jr. Way) in Berkeley (wheelchair accessible).
