#### 5. BERKELEY POLICE DEPARTMENT CHIEF'S REPORT

A. BPD representative report: 5 officers were hired and are scheduled for academy. The BDP has over-hired 3 positions, but this over-hiring has been approved by the City Manager due to upcoming retirements. The Chief of the BPD plans to discuss internally the evidence handling recommendations and then make a presentation at a PRC meeting. An internal administrative investigation is underway in the BPD, which should end in about a month.

# 6. COMMITTEE REPORTS (For Discussion or Action)

- A. Subcommittee: Draft Regulations for Investigations of First Amendment Activities.
  - a. Staff Report: The meeting scheduled for November 8, 2006 was cancelled due to the limited availability of some commission members. Captain Gustafson will provide an update on the proposed policy in about 2 weeks. The subcommittee will wait for BPD's response and meet when the draft is ready. The subcommittee will then bring the draft to the full commission for approval sometime in December or January.
  - b. Meeting Update: None
  - c. Discussion: PRC Officer Victoria Urbi stated that Captain Gustafson has been preparing the draft regulations. He was invited to the subcommittee meeting, so that BPD could provide information on the status of the draft. The purpose of the subcommittee meeting on November 8 was to set up a timeline and what the next steps should be. Since the subcommittee members cancelled the meeting, it would have been preferable in the future for staff to receive earlier notice, so that the public could be properly notified.

- B. Subcommittee: Review of BPD's Evidence Theft Issues
  - a. Staff Report: PRC Officer Urbi states that the subcommittee is on hold until after the November 14, 2006 court hearing so that the PRC can figure out how to deal with the confidentiality of police officers' identities, and how to continue with the investigations.
