e. Homeless Encampment Subcommittee

Approve follow-up letter to the City Manager and Council asking her/them to identify who is responsible for confiscating personal property from homeless encampments, and requesting that they establish a clear procedure for accounting for and returning property.

9. OLD BUSINESS (discussion & action)

- a. Proposed Body-Worn Camera policy
 - i) Approve change to section 450.5.4 (Cessation of Recording) of PRC proposed policy, to provide that, once the BWC is activated, it "shall" (not "should") remain on continuously until the incident is complete, etc.

- b. Amending PRC Regulations for Handling Complaints Against Members of the Police Department.
 - Review draft language regarding Challenge of BOI Commissioner (Section VI.C.)

By general consent, the Commission agreed to these ideas for a revised regulation:

- -- A challenge to a commissioner must be filed within 7 days of notice of hearing, or 10 days prior to the BOI hearing, whichever occurs first.
- -- All argument and evidence in support must be filed with the challenge.
- -- The PRC Officer has one day to notify the challenged commissioner, and if he or she objects, challenged commissioner has three days to file an optional written response with supporting materials.
- -- No further written arguments/evidence.
- -- Challenger and commissioner challenged are present at a special meeting to hear the challenge; they will have the opportunity to present arguments and evidence, and question any witnesses.
- -- If challenge upheld, the two commissioners issue written findings, which are confidential.

The Commission further agreed to have the PRC Officer bring back language for review and discussion at the next meeting.

- ii) Review draft language regarding Summary Disposition (Section VII.C.3.) (Item postponed to the next meeting for PRC Officer input.)
- c. Review City Attorney's opinion classifying communications complaining about specific officer conduct as "informal complaints" and prohibiting their disclosure to the full Police Review Commission, and consider procedures for handling

"informal complaints," as suggested by City Attorney, including possible amendment to PRC Regulations.

Motion to propose an amendment to the Regulations, such that when staff receives an informal complaint as defined in the City Attorney's memorandum to the PRC of February 15, 2017, the matter be agendized for next meeting in for closed session; that the informal complaint be distributed in closed session, and that the full Commission recommends to PRC Officer what action if any the staff should take, which may involve contacting the complainant and explaining the policy complaint and formal complaint processes.

 (Commissioner Prichett asked that this item be removed, as it is part of Item #9.d.)
- f. Prepare annual Commission Work Plan, as directed by City Council. (Item postponed to the next meeting.)
- g. Amendment of Standing Rules to provide a mechanism whereby Commissioners can view motions in writing before voting.

By general consent, the Commission asked the PRC Officer, who agreed, to try using Google Docs with those Commissioners who choose to use it, for drafting and viewing motions; PRC Officer to arrange to have wifi turned on at next meeting.

10. NEW BUSINESS (discussion & action)

- a. Discussion and potential action regarding failure of BPD to communicate with the PRC about planned police training using blank firing ammunition within city limits and that result in road closures.
