Re: Proposed amendment to Lexipol Policy 318, Victim and Witness Assistance

On March 13, 2019, the Subcommittee voted 4-0 to recommend that the following section 318.3.2 be added to Lexipol Policy 318:

This policy formalizes the Department's existing prioritization of violent-crime investigations and aims to ensure persons engaged in sex work and other forms of sex trade, including trafficked persons, feel safe to report that they have been the victim of a violent crime. Accordingly, officers will not arrest persons for offenses, include California Penal Code sections 647(a), 647(b), 653.22, 372 and misdemeanor drug offenses, when a person is the victim or witness of a sexual assault, human trafficking, stalking, robbery, assault, kidnapping, threats, blackmail, extortion, burglary or other violent crime.

Victim and Witness Assistance

318.1 PURPOSE AND SCOPE

The purpose of this policy is to ensure that crime victims and witnesses receive appropriate assistance, that they are provided with information from government and private resources, and that the agency meets all related legal mandates.

318.2 POLICY

The Berkeley Police Department is committed to providing guidance and assistance to the victims and witnesses of crime. The members of the Berkeley Police Department will show compassion and understanding for victims and witnesses and will make reasonable efforts to provide the support and information identified in this policy.

318.3 CRIME VICTIMS

Officers should provide all victims with the applicable victim information handouts.

Officers should never guarantee a victim's safety from future harm but may make practical safety suggestions to victims who express fear of future harm or retaliation. Officers should never guarantee that a person qualifies as a victim for the purpose of compensation or restitution but may direct him/her to the proper written department material or available victim resources.

318.3.1 VICTIMS OF HUMAN TRAFFICKING

Officers investigating or receiving a report involving a victim of human trafficking shall inform the victim, or the victim's parent or guardian if the victim is a minor, that upon the request of the victim the names and images of the victim and his/her immediate family members may be withheld from becoming a matter of public record until the conclusion of the investigation or prosecution (Penal Code § 293).

318.4 VICTIM INFORMATION

The Detective Bureau Lieutenant shall ensure that victim information handouts are available and current. These should include as appropriate:

- (a) Shelters and other community resources for victims of domestic violence.
- (b) Community resources for victims of sexual assault.
- (c) Assurance that sexual assault victims will not incur out-of-pocket expenses for forensic medical exams, and information about evidence collection, storage and preservation in sexual assault cases (34 USC § 10449; 34 USC § 20109; Penal Code § 13823.95(a)).
- (d) An explanation that victims of sexual assault who seek a medical evidentiary examination shall not be required to participate or agree to participate in the criminal justice system, either prior to the examination or at any other time (Penal Code § 13823.95(b)).

- (e) An advisement that a person who was arrested may be released on bond or some other form of release and that the victim should not rely upon an arrest as a guarantee of safety.
- (f) A clear explanation of relevant court orders and how they can be obtained.
- (g) Information regarding available compensation for qualifying victims of crime (Government Code § 13962).
- (h) VINE® information (Victim Information and Notification Everyday), including the telephone number and whether this free service is available to allow victims to check on an offender's custody status and to register for automatic notification when a person is released from jail.
- (i) Notice regarding U Visa and T Visa application processes.
- (j) A place for the officer's name, badge number and any applicable case or incident number.
- (k) The "Victims of Domestic Violence" card containing the names, phone numbers or local county hotlines of local shelters for battered women and rape victim counseling centers within the county and their 24-hour counseling service telephone numbers (Penal Code § 264.2).
- (I) The rights of sexual assault victims card with the required information as provided in Penal Code § 680.2.
- (m) Any additional information required by state law (Penal Code § 13701; Penal Code § 679.02; Penal Code § 679.04; Penal Code § 679.05; Penal Code § 679.026).

318.5 WITNESSES

Officers should never guarantee a witness' safety from future harm or that his/her identity will always remain confidential. Officers may make practical safety suggestions to witnesses who express fear of future harm or retaliation.

Officers should investigate allegations of witness intimidation and take enforcement action when lawful and reasonable.

Attached is the email we discussed, that Jon Walsh sent to his two supervisors early yesterday morning. Since his supervisors are the only ones he apparently wants to interact with, I'm going to have them reply to his email with some close out issues he needs to take care of with the Laboratory/government and direct that he call and/or meet with you or Det. White if he wants to no longer be considered a "missing person," as he eluded to in his post script. I did call his parents and summarized what he said in the email. They said that they haven't heard anything from him either and sent him an email the other day saying, whatever it is that he's choosing to do, they will support him. They are disappointed in how he handled this situation and very appreciative of all the work that everyone put into trying to locate him and getting him to resurface, however nominally.

We really appreciate all of the work your staff put into this case. Your agency was fantastic from the dispatcher (#505) that took my initial call, to Officer Rego who did the welfare check and called with the results, and Det. White and his partners who put considerable effort into this missing persons case. We work with a lot of different state and federal agencies on a variety of issues, but Berkeley PD has by far been one of the most responsive and proactive of them all. It's unfortunate for all of us that this appears to have turned out to be what I would characterize as a case of a very inconsiderate Millennial who was dissatisfied with his job and has a serious communication issue.

If you or Det. White could please let me know if/when you hear from him, I would appreciate it.

Chief Greenwood.

Good afternoon, happy summer, and I hope you're well.

I wanted to take a few moments in the quieter time right now before students and teachers report back to school to thank you for the partnerships we have with BPD via the placement of Sgt. McGee here at BHS as our School Resource Officer. I hope you'll have a few minutes to read this email, as I want to give a few specific examples of how effective and appreciated it is to have someone like Matt who is familiar with our school and our students.

In any given year at Berkeley High School there are inevitably tense moments, and sometimes even whole days when that tension is high and we are working closely with Sgt. Mcgee, who is in turn communicating with the broader dept. for updates and information. Examples that immediately spring to mind include the days when the alt-right took over Civic Center Park, the two days after what turned out to be an internet-based threat about a shooting with an AR-15 at Berkeley High, and several interactions with students who were particularly volatile, including the events following "Rally Day" in October 2017.

I am as well aware as anyone that any interaction with police, particularly in our city, is fraught with potential complications. We have all witnessed tense situations in which both adults and students are yelling, phone cameras are out, and physical violence is either happening or about to happen. As hard as my staff of administrators and safety officers work to mitigate those situations when they involve our students, I want to highlight the incredible value of having someone like Sgt. McGee on hand to help us. His knowledge of the physical layout of our campus is valuable as he directs other officers in supporting roles when something happens, but what I also appreciate is his depth of knowledge and experience with our student body. This was highlighted for me personally one day the past Spring in Civic Center Park when a relatively new and unfamiliar officer was dealing with one of our most difficult students, a female who has already had numerous encounters with the police and escalates very quickly. Watching officers who did not know her or the situation try their best to de-escalate and not be able to do so impressed upon me even more how helpful it is to have Matt with us. He is able to talk to even the most upset student - forcefully of course if needed - in such a way that de-escalation can occur, enabling us to avoid huge public disruptions whenever possible.

I am aware of the financial and budgetary constraints that you face, as well as the reality of Matt's promotion to Sergeant last year, and I feel sure that deciding to continue to allocate his position here must be a difficult one as you weigh costs and benefits elsewhere. I want you to know how much I appreciate the continued support,

and how much we rely on his deep experience with our student body to continue to do the joint work that we do.

SUMMARY:

Officers responded to a call where an autistic 15 year old who was having a "mental breakdown," according to his mother, was armed with scissors. To complicate things, the 15 year old had barricaded himself in his mother's room and had threatened to harm himself. Officers responded to the incident and represented the Berkeley Police Department well.

BACKGROUND:

On 8/6/18 at approximately 2130 hours, a mother who resides a _______. called the police and reported that her 15 year old autistic was having a "mental breakdown." She reported that her child broke things in the house and had barricaded himself in a bedroom. She also reported that the child said that he had a pair of scissors and was going to harm himself and anyone who tried to enter the room.

The priority in this incident is the safety of the 15 year old, but the threat and danger to officers is also created by this same subject. It should be noted that this 15 year old is 6' and 200 lbs.

Ofc. S. Martinez #21, Ofc. Haney #102. Ofc. Pickett# 81, and Ofc. Morales# 47 responded to the scene and made contact with the mother. They had the mother stay outside as Ofc. S. Martinez, Ofc. Haney, and Ofc. Pickett made entry into the residence with Ofc. Morales equipped with less lethal. The 15 year old was still barricaded in a room and refused to allow officers in.

Officers didn't give up and continued to use de-escalation techniques and convinced the 15 year old to open the door. After about 30 minutes they succeeded in convincing him to open the door. They went inside and calmed the subject and spoke to him about random things like the Marvel Avengers movie. Ofc. S. Martinez and Ofc. Haney's favorite movie; or at least that what they made it seem to the subject which won his trust.

CONCLUSION:

Officers worked as a team and deescalated a situation that could have ended tragically. All 4 officers displayed what it means to be a Berkeley Police Officer and the incident concluded with the 15 year old willingly entering a BFD ambulance and transported to Children's Hospital.

On 7/28/18 at approximately 2206 hours, Berkeley Police received a report of a possible kidnapping for ransom. The incident occurred two hours prior to the report, in an unknown room at the Knights Inn, located at 1512 University Avenue, Berkeley. Berkeley Police contacted the reporting party and learned the suspected kidnappers were demanding nine pounds of marijuana and \$30,0000 in cash be delivered to a location in the city of Tracy.

The suspected kidnappers were contacting the reporting party via the victim's phone. Berkeley Police immediately initiated an emergency ping on the hostage's phone number. The initial ping showed a location of 3339 meters from

Berkeley Police contacted the management at the Knights Inn and determined that the room the suspected kidnapers had rented was room #122. The manager further advised police that the suspects had called him about an hour prior to their arrival to check out of the room, and that the suspects were no longer occupying the room. The manager provided police with the phone number the suspects had called from. An emergency ping was initiated on the phone number. The ping was a more accurate ping of 364 meters in the city of Patterson, CA.

Officers were able to view the surveillance video from the Knights Inn. From the video, they obtained images of some of the suspects, as well as the suspect's vehicle, bearing unreadable out of state plates. Berkeley Police contacted Sergeant Clayton of the Patterson Police at this point, and requested assistance with this case. Berkeley Police provided Sergeant Clayton with images of the suspects, images of the suspect's vehicle and most current pings of of the suspect's phone, as well as the location the suspects were giving the reporting party as the location for the ransom drop. Berkeley Police also asked Sergeant Clayton to have his deputies attempt to locate the suspect and the victim in this case.

A short while later, Sergeant Clayton contacted Berkeley Police and advised that Patterson Police had located the suspect vehicle in their jurisdiction, which was occupied by five suspects and the hostage. Sergeant Clayton further advised they were able to obtain all parties, without incident. He further advised Patterson Police had recovered an assault rifle and loaded magazine from the suspect vehicle. The hostage was treated for his visible injuries by medical personnel in Patterson. It was later determined the victim sustained a fractured orbital bone from the beating he received during the kidnapping. Further investigation revealed the suspects had used the assault rifle to threaten the hostage's life during the kidnapping and that they repeatedly told the hostage they were going to kill him if his friend didn't deliver the ransom.

I would like to commend all personnel involved in this case for their exemplary efforts. Without their quick response and investigation in this case, I believe the victim would have been killed by the suspects. The suspects in this case traveled to Berkeley from South Carolina with the intent of robbing the victim of a large amount of marijuana and cash. When the victim didn't show up with the amount of marijuana initially agreed upon, the suspects decided to initiate a kidnapping of the victim for ransom, in order to get nine pounds of marijuana and \$30,000 in cash from the victim's associates.

Due to the exemplary initial dispatch by Communications Center Personnel and their phone ping efforts, initial investigation by Patrol, response from the Patterson Police, and the follow-up investigation by the Berkeley PD Detective Division, all five suspects in this case were charged in Alameda County. The charges included kidnapping for ransom and robbery with the use of a firearm enhancement, great bodily injury enhancement and various gun violations.

August 14, 2018

With everyone upset, Officer Gordon proceeded to calmly and professionally handle all the competing concerns even handedly while simultaneously dealing with the bicyclist, the paramedics, bystanders and me. He listened, took notes, photos, talked to everyone so that, at least from my perspective, we all felt things were in competent hands.

From the point of view of the priorities of policing, I'm sure that this was a minor problem, but to those of us involved, it was very upsetting. Officer Gordon treated us all with respect and seriousness. I know there's a lot of what Steph Curry calls "The Noise" these days that has painted, in my opinion, a very inaccurate picture of how BPD interacts with people. So I want to commend Officer Gordon for demonstrating that it is just "noise" and thank him as well as let you know how much I appreciated his command of our minor situation.

Hi Erin -

I'm writing this now while it is fresh in my mind.

I felt the speakers knew their audience. Very good tone. I liked that they did not pretend to have all the answers. I liked that they spoke to us as adults. They modeled how we could talk to kids about this.

I went into the training feeling really uncomfortable. I've shared with you that my cousin and her daughter survived Sandy Hook. I kind of resent having to rehearse my own murder at school and preparing the kids for the same. But ALICE offers options. Locking down is disempowering.

ALICE offers options for fight (counter), flight (evacuate) and freeze (lockdown). Different responses are appropriate for different scenarios and the trainers encourage us to use our best judgment.

I came back to my classroom and realized that my students can engage in whichever impulse is activated in one of these scenarios. They can evacuate out the windows. They can hide in the closet. And some of them will choose to engage with a gunman if he comes through the door. My role is to offer them these choices and facilitate - clear desks and have three kids lift others out the window. Open the closet door. Instruct in barricading the class door and give kids things to throw.

So I feel better and I know my kids will feel better knowing the adult in charge has a clear plan. This adult is going to encourage them to lean into their instincts and there's a plan for each one. They don't all respond the same way and they won't have to.

Thanks for giving us the amount of time the training deserves.

I'm really getting all the details, but I need to see you in person." requested meeting with Quezada. aid she saw one of the BFD medics at the hospital and the paramedic "broke down the moments in the back of that truck. I would really like to talk to you. Thank you."

The victim and his family have a contentious relationship with law enforcement. This is yet another example of BPD officers being effective in breaking down barriers and opening up the possibility of building positive (or neutral) relationships with crime victims, families, and other community members.

Commendation for Detective Darren Kacalek

I wanted to take some time to commend Detective Darren Kacalek. During the last year Darren has conducted extraordinary investigations that have not gone unnoticed. For most of the year, Darren was the only Sexual Assault Investigator in a Special Victims Unit that was down to 3 of 6 authorized detectives. Sex Crimes reports went up from a typical rate of around 75 per year to over 185 during this time period. Darren worked incredibly hard to keep up during this time and achieved extraordinary results.

In December 2017, a woman was attacked by a sex registrant posing as a UBER driver. She was kidnapped and assaulted, she jumped from a moving vehicle to escape. Detective Kacalek came in on his weekend and got to work securing a confession from the suspect. The suspect was charged and faces 60 years to life in prison. It does not go unnoticed that Detective Kacalek constantly fields phone calls from officers seeking advice, comes in on his time off to help his team and his victims.

In March 2018, 5 suspects trapped 5 runaway girls and committed multiple sexual assaults after threatening the victims with a firearm. Patrol Officers captured the suspects at the scene and a complicated investigation and series of interviews and sexual assault exams of the 5 victims and 5 suspects ensued. Detective Kacalek worked the case through the weekend and charges were brought against the suspects who face 75 years to life exposure for their crimes.

In April 2018, we received a report of a stranger rape of a 14 year old girl. Detective Kacalek quickly created a rapport with the victim and helped her remember key details about the suspect's description and clothing. Darren had already developed professional relationships with lab personnel and was able to get a technician to rush the testing even coming in on the weekend to help in the case. Less than a week later, we received a DNA match for our suspect.

Once identified, detectives realized the suspect also connected to an attempted rape on UC Berkeley property. Detective Kacalek took over that investigation from UCPD. A manhunt for the suspect began as soon as he was identified and he was taken into custody less than 24 hours later. Detective Kacalek wrote search warrants for multiple addresses and was able to recover nearly all of the evidence he was seeking including distinctive clothing from both assaults and a replica firearm. A cell phone search warrant for the suspect's phone produced evidence that the suspect was at both locations at the time of

the assaults. The suspect was charged in both cases and faces 286 years to life exposure for his crimes. If Detective Kacalek had not caught the suspect so quickly, I have no doubt he would have continued his brazen attacks on young women until captured.

Detective Kacalek has developed a professional relationship with our Sexual Assault Charging DA and this has paid dividends. Their relationship and mutual respect has enhanced his ability to obtain justice for his victims.

Darren's work ethic is unmatched. He seeks justice for his victims and is relentless in pursuit of suspects. Darren is an invaluable part of the team and has shouldered more work than could reasonably be expected of him. His peers, recognizing this, nominated him as Investigator of the Year. While all of these cases were a team effort, Darren was the common denominator. I wanted to take the time to thank him and make sure his contributions are properly recognized.

On August 18, 2018 at approximately 1730 hours Berkeley P.D. officers responded to a shooting at San Pablo Park. Officers found three victims with gunshot wounds among the hundreds of people who were attending various parties/gatherings at the park.

Due to his strong ties to this community, a citizen informant reached out to Officer Quezada-Garcia and provided him with specific information regarding the shooting.

Officer Quezada-Garcia took this information and was able show how this shooting was related to recent gang-related shootings and incidents (some that were unreported to law enforcement). Officer Quezada then collaborated with the Oakland Police Department. By the next day, Officer Quezada-Garcia created an intelligence/officer-safety document that included: specific information regarding this incident, information regarding previous incidents and how they were all related to one-another. Officer Quezada-Garcia immediately provided this document to the Homicide Detail.

It has come to my attention that this is not the only time that Officer Quezada-Garcia has provided information/intelligence to the Homicide Detail regarding gang-related shootings/incidents. As it turns out, Officer Quezada-Garcia has provided timely and actionable intelligence to the Homicide Detail that has resulted in the identification and arrest of numerous felons, numerous times.

Officer Quezada-Garcia is a dedicated member of the Departmental Situational Awareness Group (SAG) and often uses his training and experience to gather information/intelligence; oftentimes, without being asked to do so.

This level of initiative, commitment, dedication and hard work exemplifies the Mission, Vision and Values of the Berkeley Police Department. I respectfully request that this memorandum be processed as a commendation for Officer Quezada-Garcia.



Lt. Durbin,

Please process this email as a commendation for Officer Emelson #108, Officer Egbert #103, and Officer Patrick #126. On 9-28-18, at about 1400 hrs, they responded to a burglary just prior on 10th St ne ar Cedar St. Two juvenile suspects ran from the house when the homeowner confronted them.

One of the items stolen was an IPad with tracking software. Officers were able to identify an address on Kains St where the IPad was still showing active. They went to make contact at the address when the two juveniles began to walk out of an upstairs apartment. Officers saw they matched the description of the suspects. Officer Egbert pinged the IPad, which made an audible alert from one of the juveniles backpack. Officer detained the two juveniles for suspicion of burglary. The juveniles were arrested for burglary after positive in-field show-ups and several pieces of stolen property were located during a search. The items stolen from 10th St were returned to the owner and several other items, which were suspected to have been stolen, were seized.

Officer Emelson researched other residential burglaries in the area to see if any of the evidence found on the juveniles had been stolen in a burglary. He found a set of keys with the dealer sale fob still attached. It listed a VIN, which was registered to an address in the 1500 block of Belvedere. Officer Emelson found that a residential burglary had been reported in the 1500 block of Belvedere, but the report did not list many items stolen. He contacted the registered owner and discovered that the key belonged to the burglary victim in the rear cottage. He was able to return the car key to the victim and save them from having to pay for that car to get re-keyed.

Most of the content of the attached email is details of stolen items that were not captured in the original report. Officer Emelson, without hesitation, took on the follow-up in order to complete the case.

I just want to share with you the great work that Officer Steve Rego is doing for Tyler Tech and other agencies. I've attended the Tyler/New World User Group Conference for at least four years and Rego has always been willing to provide helpful information to other agencies but during the recent conference that took place on October 1st and 2nd, I noticed how much of an expert Rego is and his willingness to share his knowledge with the group. There were several times throughout the conference where Lindsay Kavulish the presenter and our Customer Service Account Manager (CSAM), defaulted to Rego and/or was going to get back to a person and Rego immediately volunteered the information. There was also a new CSAM (David), who Rego assisted with answering questions that he was faced with while he was presenting. Actually, I believe that Rego has more Tyler Tech experience than all of Tyler's current CSAM's. Rego was also asked to give an Advisory Board update regarding Enterprise Law Enforcement Mobile, which he didn't know he was going to have to do but he did it and you would have thought that he had planned for providing the update.

Hello Officer Rosato,

I decided to write to you again, because I wish to get a closure on the stalking/harassment issue concerning my report with number and I think it definitely needs to end with a thank you note.

You went out of your way to help me deal with the situation by talking to that person on the phone, and I inadvertently ended up benefiting from your call in my last days of living in that Kensington location. He did shape up considerably, and I thought it was my relentless yelling at him that eventually generated an effect.

Until that day when I got to read my report, did I realize that you had done a huge favor for me that I didn't bother to ask for. It was completely unexpected. Although you tried to portray a balanced scenario by presenting the narratives from both sides in reporting the issue, your voluntary intervention nonetheless straightened out the other party and thus made my life easier afterwards. (He did have repercussions later on, but it was his ego struggling to gain one-uppingness, I guess)

It is the extra mile that you decided to go that warms my heart. It was also the silver lining in a rather stressful situation. THANK YOU.

Even if you might be "just doing your job", it indicates a sense of duty and pride you feel about what you do. People with these qualities, among others, are the ones who tend to get much further than their peers in their careers. And I have a good reason to believe that you will be one of them.

It's been 6 months since I first filed the report. It seems a long time for someone to conclude such an event without pursuing further legal actions. I decided not to file a civil harassment restraining order, because given the non-spousal, non-relationship partnership nature between me and the other party, the court will require much more stringent evidence than what I have. I figured that the odds of my winning the case would be small. And more important, the court proceedings along with a potentially negative outcome would, in all likelihood, provoke a greater need for power struggle in that person and engage him more obsessively in his harassing behavior. I could anticipate a new round of crazed behaviors by someone who ties his identity and ego to how much he would one-up a woman who doesn't want to have anything to do with him in the first place. That is the "business" he has been running "in Berkeley". Speaking of being "emotionally unstable", I could expect a lot more of that on his part. So I opted for staying away from that person as much as I could after I had already moved out.

(By the way, in your attempt to be thorough and prudent, you reached out to the Kensington PD, I hope that they didn't give you a hard time for inquiring about an issue that involved two of their residents with a prior history of interpersonal conflict. They unfortunately didn't take my local

reports as seriously, which partially contributes to the meager evidence that I have. If they did, I will apologize to you.)

Last but not least, I still remember your cold hand. I've shaken hands with a great many people so far, you are probably the only man whose hand was so cold. It's very likely your very warm heart is balancing out the low temperature of your hand(s) to reach a homeostasis.

That being said, if that's a constant state, assuming that it's not a serious symptom, I'd like to suggest that you try "warming foods" (as opposed to cooling foods), which are foods that tend to stimulate blood circulation and the flow of vital energy in your body (a concept of traditional Chinese medicine about how bodily energy operates). Some of the foods are ginger, lamb, onion, curry, basil, and etc. If you are interested in what they are, you will find lists of such foods along with personal testimonies when you google the term. Officer Pock asked if she wanted to look in the car for the DMV registration. Whil was looking for the paperwork in the vehicle, Officer Pock saw a social security card in plain view that did not belong to either s. Officer Pock decided to conduct a search of the vehicle based upon probable cause for suspected stolen property, identity theft items, and for an inventory search pursuant to 22651(0) VC tow, since they could not provide current registration.

A search of the vehicle revealed a locked safe that contained approximately 14 ½ ounces of methamphetamine packaged for sales. I'd like to commend Officers Pock, Phelps, Baker, Ludovico, and Sergeants Lee and Landrum for their exemplary work in this case. This was an example of excellent police work and teamwork, which resulted in approximately 1 pound of methamphetamine being taken off the streets of Berkeley and two very problematic Berkeley career criminals being arrested.







Greetings Drs. Newman, Esherick and Clarke and the Wright Institute community,

My classmates and I count watched Lee Mun Wah's, Last Chance at Eden and The Color of Fear. I found the themes similar and compelling. ..., one of the participants in Last Chance at Eden, sums it up with the following quote:

"If a white person starts to cry or admits to having racist feelings and tendencies, then everybody immediately starts taking care of that person, and the whole world stops."

Over the past 8 days within the Wright Institute, this theme feels relevant.

As I move into the 9th day of forced exile from my learning community, as I log my third request for information on the status of my Letter of Accommodation (an application I began in Aug. 1st), as I wait in a curious limbo--uncharged, not suspended or disciplined, but most certainly impacted by the actions of Dr. Newman, Dr. Esherick, and Dr. Clarke, I wonder if we as a learning community will be able to pull back from the brink of destructive, limbic system-oriented decision making.

As a gesture of good will and in the interest of finding a mutually beneficial path toward settlement, resolution, reconciliation and healing, I offer to meet with you in a professional manner, speaking in English or using a translator, at the location of your choosing.

Although you objected to my Service Animal being on the Dwight campus without a Letter of Accommodation, he remained with me for nearly two hours during our Monday October 29th 4:00pm meeting. I acknowledge that you said our time together was not a meeting because I refused to honor multiple requests by you, Dr. Newman, and Dr. Clarke to be separated from my Service Animal and have him wait outside the building so the meeting could begin.

Given your position and my willingness to meet you on your terms, I make the following request as you consider a location for the meeting I am proposing:

- 1. Choose a public space for the meeting so my service dog and I can attend without a Letter of Accommodation
- 2. Hold off on any disciplinary charges or actions against me until the Accessibility Office has made a final ruling on my request for accommodation within the Wright Institute academic program
- 3. Allow me to host the meeting at a location of my choosing.

You have my permission, and I strongly encourage each of you, to circulate this e-mail to anyone with a "wi.edu" address.

P.S. I've CC'd the Berkeley Police Department's Police Chief Andrew Greenwood, as I wish to convey my deepest appreciation for the way the Berkeley Police Department officers responded to the call at 1000 Dwight Street in Berkeley CA, on 29OCT2018 a little after 1700hrs.

In stark contrast to Drs. Newman, Esherick and Clarke, Officer John, Badge #7, exemplified the best in trauma-informed care for an American with a disability, a citizen of a sovereign nation, a person with suspected mental impairment, a person in need of medical assistance, a person of color, and a human being.

I will outline how courageous, composed, attentive, respectful, observant, thorough, professional and responsive this officer was, having only had three years on the force, in a separate letter of commendation. Suffice it to say, he was the model of comportment

during a tense, uncertain and rapidly changing situation. I would also like to acknowledge Sgt. Wilson who arrived on scene, released me from my detention and safely escorted me back to public property.

I would respectfully ask that Wright Institute officials complete a Release of Information (ROI) so that the video footage captured by Ofc. John's body camera can be used for law enforcement training purposes.

Subject Commendation for Officers Involved in the Brooks Case

On October 29th 2018 Officers Loeliger and Kleppe responded to a disturbance at the Wright Institute located at 1000 Dwight Way. the subject of the disturbance call, was in the office, wearing handcuffs and a bulletproof vest while espousing Sovereign Citizen ideology and refusing to leave. In the course of their investigation they learned that s was a former OPD officer and a student at the who was facing discipline from the school for staging an active shooter scenario. Officers Loeliger and Kleppe determined there was no crime at the time and ultimately selection.

After this event **Sgt. B. Wilson** worked with **Ofc. Galvan** as well as **Jen Wydro** and other Berkeley Mental Health Staff to outline the history of mental health issues associated with based on both his extensive history mental illness and the potential threat he posed to the Wright Institute. On November 9th they completed a 5150 form which provided department staff with enough information to place on a hold during their next contact with him.

has lived on Ofc. Galvan's Beat for many years. Officer Galvan's long-standing relationship with and his family, and the trust he has built with ex-wife proved invaluable in accurately assessing and managing the risks associated with this case.

On November 15th **Sgt. Sabins** learned that a UCPD officer saw at Galls purchasing a concealable holster. Sgt. Sabins updated the forum with this information. Later that day Officer Galvan called to advise that had purchased a Glock .40 cal pistol on November 3rd and taken possession of it on the 13th. Around the same time **Ofc. Muratovic** obtained the same information from his contacts at OPD and began working with them to share information and develop response options. firearm purchase was particularly distressing when coupled with the fact that had already staged an active shooter scenario at the Wright Institute and his purchase coincided with his expulsion from the program.

Later that day, I met with officers Galvan and Muratovic, along with Sergeants Fomby, Rittenhouse, and Bonaventure and Lieutenants Durban and Hawk to discuss the best way to manage the potential public safety risk posed by . The group came up with a working plan; Ofc. Muratovic obtained a firearms EPO, drafted a firearms search warrant affidavit, submitted a SAR to NCRIC, and put out a Trax Flyer. While this was happening Sgt. Fomby coordinated with the Director of Berkeley Mental Health to ensure that John George staff was aware of the threat that I posed and would thoroughly evaluate him when admitted.

Sgt. Fomby posted a case update on the Forum to ensure the oncoming weekend teams were updated on the case.

Over the course of the weekend **Lt. Hong** reviewed and updated the draft affidavit and staged it in CRIMS so it could be immediately submitted once was contacted.

On November 19th we determined that the best option was to attempt to contact as he left his house at some point on the 20th. Sgt. Fomby and Lieutenants Durbin and <u>K. Reece</u> worked on an operations plan using Detectives as surveillance teams and SRT staff as stop teams. As this plan was coming together Ofc. Galvan advised us that Brooks was scheduled to leave his house at a particular time on November 20th. The morning of the 20th <u>Sergeants Lindenau, P. Lee, and Det. Morillas</u> worked as surveillance officers while <u>Officers Hom, Radey, Bold, Hunt, Valle, and Tinney</u> worked with Sgt. Fomby as stop teams.

was safely detained in a vehicle, served with the firearms EPO and 5150'ed.
refused to cooperate with the firearms EPO so Lt. Hong submitted the warrant which was signed by a judge within 10 minutes. SRT supported **Det. Edwards and Sgt. Landrum** in the search warrant service a ___' residence which ultimately recovered the Glock .40 cal handgun along with ammunition and OPD uniforms.

Officers Muratovic and <u>Ledoux</u> continue to track this case and coordinate with allied agencies.

This case represented a unique situation that required department staff to track and manage an escalating risk in the absence of a crime. Officers use of the Crime Forum allowed us to effectively communicate across teams and ensured everyone in the department was aware of and tracking the escalating threat. The spirit of collaboration, along with the flexibility and persistence demonstrated by everyone involved in this case enabled us to safety detain 5150 him, and recover his firearm.

I was grateful for this. and then he called us back to say he had to transport a prisoner & would not be at station, but would have another office meet us. When we arrived, someone met us with black plastic bag & we did find some things that were ours, like my 200.00 contacts I had just picked up & my sweater & a few other things. We still are missing quite a bit, but are so glad you took the time to help us out & made us feel like you cared. And officer Mitchell was very professional in the manner he accomplished this. 

Authorize the Police Review Commission to co-sponsor, with the National Association for Civilian Oversight of Law Enforcement (NACOLE) and the BART Office of the Independent Police Auditor, a regional training and networking event on May 3, 2019 in Oakland, California.

FISCAL IMPACTS OF RECOMMENDATION None.

CURRENT SITUATION AND ITS EFFECTS

Staff of the Police Review Commission have been working with staff from NACOLE and the BART Independent Police Auditor's Office to plan a Bay Area regional training and networking event, set for May 3, 2019, in Oakland. (See *Save the Date* announcement, attached.) The Commissioners of the PRC request the City Council's permission for the Commission to be listed as a co-sponsor of this program. The PRC voted to make this request at its February 13, 2019 meeting as follows: M/S/C Perezvelez/Allamby; Ayes -- Allamby, Calavita, Matthews, Mikiten, Perezvelez, Prichett, Ramsey, Yampolsky; Noes -- None; Abstain -- None; Absent -- Roberts.

BACKGROUND

NACOLE's mission is to enhance fair and professional law enforcement that is responsive to community needs. It is the largest civilian oversight organization in the country, with a membership comprised of oversight practitioners, community stakeholders, law enforcement personnel, elected officials, journalists, academics, students, and others. Each fall, NACOLE holds an annual conference attended by the organization's members and others from across the nation.

Additionally, NACOLE holds a series of regional training and networking events throughout the year. The regional gatherings are designed to allow more opportunities for civilian overseers and interested stakeholders to meet and exchange information and ideas about issues of local law enforcement oversight.

Police Review Commission's co-sponsorship of a NACOLE Regional Training and Networking Event

The May 3, 2019 event is expected to draw oversight practitioners and interested community members from Berkeley, Oakland, San Francisco, San Jose, Richmond, Sonoma County, Sacramento, and beyond. Topics to be addressed are: civilian oversight of county jails, release of police personnel records under SB 1421, and the strengths and limitations of different oversight models.




