5. CHAIR'S REPORT

-- NACOLE regional training May 3, 2019, at Kaiser Center in Oakland is open to all community members interested in civilian oversight. \$75 fee but can be waived.

-- Urban Shield exercises have been modified and will be geared towards disaster response and exclude SWAT-team scenarios.

PRC OFFICER'S REPORT

- -- Comm. Yampolsky's wife has been hired as an attorney in the City Attorney's office, so he will no longer be able to serve on the PRC. (The rules were suspended to allow Comm. Yampolsky to address the Commission.)
- -- More on NACOLE: while no one will be turned away for lack of ability to pay, do register in advance. Registration link was sent to Commissioners.
- -- No new complaints filed since last meeting except for one complaint alleging misconduct 6 years ago and thus too late.
- -- First BOI involving viewing of body-worn camera footage on Friday. Thanks to Comms. Calavita, Roberts, and Mikiten for enduring the technical problems, and to Lt. Hong for providing a number for tech support.

- -- City has hired a second Deputy City Manager, David White (currently Fairfield City Manager), to whom the PRC Officer will be reporting.
- -- Commissioners' Forms 700 are due to the City Clerk by the end of this month.
- -- Must adjourn by 9:45 p.m. tonight for Special BOI Meeting to consider complainant's request for continuance.

7. CHIEF OF POLICE'S REPORT

- Lt. Reece reported on behalf of Chief Greenwood:
- -- Currently at 165 sworn officers, which includes 7 in academy and 8 FTO (Field Training Officers) so actual strength is 150.
- -- Just finished an application period. 1 officer starting academy this week; reservations in 4 academies bt. March and July; last week 1 officer graduated. Promotions yesterday: an Office Specialist II to OSIII, PEO Supervisor Singleton, Sgts. Ledoux, Andersen, and P. Lee, Lt. K. Smith.
- -- Working on response to MOU Compendium Subcommittee. Date for bringing MOUs to Council hasn't been set yet.
- -- Last week Council approved retaining a marketing firm, Epic Recruiting. See Joinhaywardpd.com for a sample of their work.
- -- Last night Council approved raising the award maximum for homicides and other serious crimes from \$15K to \$50K. Relatives of homicide victim Alex Goodwin came to speak in support.
- -- Crime report to be presented to Council next week.

8. SUBCOMMITTEE REPORTS (discussion & action)

Report of activities and meeting scheduling for all Subcommittees, possible appointment of new members to all Subcommittees, and additional discussion and action as noted for specific Subcommittees:

- a. Prioritizing Safety for Sex Workers Subcommittee. Met right before this meeting and approved language for a recommended policy; to be agendized for future meeting.
- b. Lexipol Policies Subcommittee. Need to schedule next meeting and recruit another member to replace Comm. Yampolsky.
- c. MOU Compendium Subcommittee. Met on March 6 and March 13; Comm. Perezvelez elected Subcommittee Chair; have made recommendations and awaiting questions sent to the Chief. Expect to bring recommendations to full Commission two meetings from now.

9. OLD BUSINESS (discussion & action)

 Update on SB 1421: responding to Public Records Act requests; status of litigation and other actions statewide.

PRC Officer gave a report and answered questions from Commissioners, No action.

b. Commissioner training

 Follow-up to PRC's January 23, 2019 request to PRC Officer regarding nature of training to be presented.

By consensus, the Commission corrected the prior recommendation of January 10, 2019, to read that BPD, not BPA, do an orientation for commissioners each year.



Total Part 1 Property Crimes 2014-2018












Robbery Five Year Comparison Carjacking Pedestrian Home Invasion Bank Commercial




Bicycle Located at Raymond Davis' Residence:

Bicycle Thefts Down 37% over 3 years 40 arrests in 2018








