# 5. CHIEF OF POLICE'S REPORT

A. Update on in-custody death from 2/12/13.

Captain Greenwood addressed the Commission and responded to their questions. Capt. Greenwood stated that the Alameda County Coroner is investigating the cause of death and personnel from Detectives Division are conducting an investigation to determine whether any crime was committed. He was not able to comment further about specific details of the case or the on-going investigation.

B. Budget, staffing, training, and crime updates.

Command staff is currently working on the biennial budget proposal. Two new police officers are graduating from the academy March 9<sup>th</sup> which will bring the staffing level to 169 out of an authorized number of 175. Trainings will be taking place in computer systems, handling of hazardous materials, and firearms. An Alameda County Dep. District Attorney will be training patrol officers about elements of a strong investigation and report.

The Accreditation subcommittee met and reviewed three Lexipol policies (#'s 316, 336, and 338). The next meeting date is to be determined.
