#### 5. CHIEF OF POLICE'S REPORT

Capt. Harris reported that a BPD officer was recently beaten when responding to a call, but is expected to make a full recovery. There are currently 166 sworn officers, with one resigning soon. A test is being given in May for entry-level and lateral hires. There are two vacant dispatcher positions.

### **6. OLD BUSINESS** (discussion and action)

- a. Regarding the factual innocence finding, the PRC Officer informed the Commission that a complaint regarding this case had been filed that afternoon, and that, therefore, the Commissioners could not discuss the specifics of that case. The Commission thus did not discussed item 6.a.2), and discussed the remaining items in the following order (numbers correspond to numbers on the agenda):
  - 3) Review staff determination that a PRC complaint is beyond the one-year statute of limitations and possible redress by the public.
    - (The PRC Officer pointed out that the usual filing period is 90 days, and late-filed complaints are accepted up to 180 days, not one year, after the alleged misconduct.) Following discussion, Commissioners decided the issues raised could be discussed in the Regulations Subcommittee.
  - 1) BPD policies on referring cases to the District Attorney for prosecution.
    - There was discussion and questioning of Lt. Files regarding The Commission decided to **carry this item over** for further discussion at the next meeting, with a request that the department return .with any written policies or procedures they rely on pertinent to making the decision to refer cases to the D.A. for prosecution.
  - 4) Review role of the City Attorney in precluding matters from being agendized because of concerns regarding potential liability.
    - City Attorney's March 24, 2014 memo was discussed.
- b. Recommendation to request additional information from the BPD related to reporting requirement under Berkeley Municipal Code section 12.24.070 on enforcement of marijuana laws in the City of Berkeley.

Motion to request a supplemental report from the Chief of Police addressing the five points described in Commissioner Bernstein's memo attached to today's agenda packet, for the six-month period ending December 31, 2013.

- e. Correction of clerical error in citation to Calif. Penal Code section 13519.4(f) in the proposed General Order B-4 (Fair and Impartial Policing), which Commission voted to recommend to the City Manager at its March 26, 2014 meeting.

  Approved by consensus.
- f. Consider dissolution of Fair and Impartial Policing Subcommittee. The Commission took **no action**.

## 7. **NEW BUSINESS** (discussion and action)

a. Obtaining more complete and timely cooperation from the BPD in providing PRC investigators with copies of reports and interviews; and PRC's right to receive unredacted materials from the BPD.

Motion to have the PRC Officer write a letter to the City Attorney and Deputy City Manager asking what the barriers are to the PRC staff receiving BPD materials relevant to PRC investigations.

  - The PRC Officer reported that the Deputy City Manager has suggested aiming for a report back to the City Council at its December 9, 2014 meeting, meaning it must be submitted to the City Clerk by October 16; the City Manager would like to see it by October 9.
