- a. Presentation on Berkeley Police Department's Crisis Intervention Team by Officer Shannon. Officer Shannon gave a presentation on Berkeley Police Department's Crisis Intervention Team (CIT). Officer Shannon had 15 years of professional experience working in mental health before he became an officer and played a major role in the formation of CIT which formally went into operation in January of 2012. CIT involves collaboration between law enforcement and community mental health workers. The two main goals of CIT are safety (for both officers and mental health consumers) and diversion. BPD is aiming to have 20% of its officers trained in CIT. All CIT officers volunteer for the assignment.
- b. Input on Berkeley Police Department's draft of new policy on fair and impartial policing, and possible selection of a delegate to attend a further meeting with BPD.
 Motion to send a letter to the City Manager, Chief Meehan and Captain Harris expressing the commission's concerns about the process by which the PRC is being asked to participate in the creation and possible implementation of a new general order on Fair and Impartial Policing and requesting a formal presentation of the proposed policy to the full commission.
