- 1) Commissioner Allen corrected item 6.c. of the minutes, to show that on the motions to approved amendments #3 and #6, Commissioner Perezvelez was absent.
- 2) PRC Officer Lee proposed a correction to the motion in item 7.a. of the minutes to reflect that the letter be signed by the PRC Chair, not the PRC Officer, and that the inquiry refer to sustained findings resulting in discipline, not just discipline imposed following a City Manager recommendation.

5. RELEASE OF CONFIDENTIAL PERSONNEL INFORMATION (discussion and action)

a. Recommendation to take action affirming the Commission's commitment to the civilian oversight process, including the confidentiality of personnel records. Deputy City Manager William Rogers discussed the seriousness of the recent breach of confidentiality and the need to assure that such breaches will not again occur, to maintain the integrity of the oversight process.

1) Motion to adopt the following resolution:

The Berkeley Police Review Commission was created by the citizens of Berkeley to ensure that there is meaningful civilian oversight both in setting and reviewing police department policy and in the prompt and impartial investigation of any complaints brought against members of the Berkeley Police Department.

The confidentiality of personnel matters, including PRC proceedings, is of critical importance in insuring the dignity and fair working conditions of all city employees, including the women and men of the Berkeley Police Department.

The Commission reaffirms its understanding and commitment to maintaining the confidentiality of personnel matters in the course of PRC proceedings.

 Deputy City Manager Rogers said that the next step will be for the City Manager to meet with the BPA.

6. CHIEF OF POLICE'S REPORT

The budget beginning in fiscal year 2016 and the three years after will involve increasingly large deficits. The department is currently staffed at 165 officers; a new recruitment was just posted. There's been a 10% overall reduction in crime this year. Last night was the first beat analysis community meeting; three more are scheduled. The Chief will do a presentation on the beat analysis at the PRC's May 28 meeting.

The Chief answered questions about two recent incidents, one involving high school students fighting downtown and the other involving Cal students that was videotaped.
