#### **6. OLD BUSINESS** (discussion and action)

Both items below will be carried over to the December 10 meeting.

- a. Creation of a subcommittee to produce a General Order regarding the treatment of transgendered persons.
- b. Amend PRC Regulations to exempt certain types of cases from mediation.

#### **7. NEW BUSINESS** (discussion and action)

a. Obtaining redacted audio evidence from BPD.

Motion to write a letter to the City Manager and City Attorney asking for their assistance in resolving disagreements regarding the withholding of audio evidence from PRC staff in the course of their investigations; specifically, what is the review procedure and who is the arbiter.

  - ii.) By consensus, the Commission asked that, for commendations in future agendas, the PRC Officer list the commended officers in columns, alphabetically.
- c. Proposed change to PRC Regulation Section II.A., Filing a Complaint, to make clear that II.A.4.a., Sufficiency of Complaint, does not apply to Commission-initiated complaints authorized in II.A.3., Unavailability of Complainant.

Motion to amend the Regulations to add the following language to Section 11.A.4.a.: "This Section II.A.4.a. does not apply to complaints initiated by the Commission under Section II.A.3."

d. City Council's October 28, 2014 action on Mutual Aid agreements, including NCRIC accord, and referral regarding General Order N-17.

Motion to establish a subcommittee to review General Order N-17 in keeping with the Council's October 28, 2014 action, with the first order of business being to review the recording of the Council's meeting at which it took said action; and, if it is unclear, ask the Council for further guidance.

progress of the BPD's implementation of General Order B-4; he said that the BPD is
close, but he did not know the exact date.
