

2. APPROVAL OF AGENDA

The agenda was approved by general consent.

3. PUBLIC COMMENT

4. CHAIR'S REPORT

The Chair reminded Commissioners to do their homework (video-watching) and turn notes in to the PRC Officer.

5. CHIEF OF POLICE'S REPORT

Capt. Harris reported that the first reading of the proposed budget went to Council last night; the BPD budget does not propose any cuts. Currently staffed at 166 sworn of 176 budgeted positions. Lynne Olesen, the Public Safety Business Manager, retired last Friday. She was thanked for her many years working on the department's very complex budget. The new position will an Administrative & Fiscal Manager, to focus only on the budget and seeking grants, and not have ancillary duties overseeing other units.

Capt. Harris is temporarily absorbing some of Ms. Oleson's former duties, in addition to those of Capt. Upson (who recently left to become Chief of Police for Benecia), and will permanently serve as custodian of records. A promotional test for captain is upcoming. LGBTQ liaisons have been selected: Sgts. Melanie Turner and Ethell Wilson.

6. PRC OFFICER'S REPORT

Only change in status of complaints from last week is that a decision on a Caloca appeal was issued and reversed the BOI's finding of "sustained" to "not sustained." It will be agendized for a closed session discussion when Commissioner Bernstein, who served on the BOI, is back from leave. A candidate for the temporary investigator was chosen from 4 interviewed (of 15 applications submitted); now goes to HR Department for approvals, job offer, and background check, which typically take 6-7 business days to complete.



Re: Answering questions at May 27, 2015 PRC meeting

Thank you and Captain Harris for attending last night's Police Review Commission meeting to personally update the commissioners about the status of your department's report on its response to the protests in early December 2014. You stated that the Police Department will neither have its report done in advance of the PRC's May 27, 2015 meeting, nor be ready to make a presentation on that date; you are now aiming for the June 10, 2015 meeting.

Later in last night's meeting, the Commission voted to request that, notwithstanding this delay, you attend the May 27, 2015 meeting for the purpose of answering any of its questions that you are able. (A copy of those questions, part of the minutes of the PRC's April 22 meeting and attached to the May 6 agenda packet, is attached for your convenience.) As you heard, the Commission is concerned that the delay in the BPD's release of its report will cause a delay in the PRC's investigation into the events of December 2014, which Council has requested be completed by August 10, 2015.

The Commission believes that some of the questions it has posed to you can be readily answered, and that by responding to them on May 27, it will help the PRC keep its investigation on track. The Commission is committed to maintaining its schedule of special meetings through June and July for this purpose.

Please let me know if you will be able to meet this request, and if you have any other questions.
