

Capt. Frankel reported on the Chief's behalf that the department will be presenting its mid-year crime report to the City Council next week, and that they can make a presentation to the PRC if desired.

Motion to adopt, as an alternative to BPD Recommendation #22, Commissioner Bernstein's proposal:

The use of CS gas on December 6 is a cause of major concern. Not only is it unclear whether the actions of the crowd warranted such use, it is unclear how decisions were made to continue to deploy CS gas, and whether the continued use was necessary. Careful review of the policies regarding both the initial use of CS gas and its continued deployment must be undertaken by the BPD in conjunction with the PRC. New policies need to be drafted more carefully delineating when and how CS gas should be used in crowd management and control situations.

If and when CS gas is deployed, a public announcement regarding the impending use should be made, as well as radio broadcast to all law enforcement personnel.

- Whenever an officer uses less-lethal force in a crowd control situation, that officer is responsible for preparing an individual report of such use.
- ii) Review and approve findings.

By general consent, the Commission made a few changes to the staff's draft Findings and will review the next revision at the next meeting.

iii) Discuss remainder of report and its structure.

b. Disclosure of full Suspicious Activity Reports by BPD.

By general consent the Commission agreed to agendize Mutual Aid Pacts for the September 24, 2015 meeting, and asked the PRC Officer to report back regarding the grounds claimed by BPD for not furnishing full SARs to the Commission.

7. NEW BUSINESS (discussion and action)

a. Review General Order W-1, Right to Watch

(the Commission discussed this item after Item 7.b.)

By general consent, the Commission agreed to have the PRC Officer write a letter to the Chief, with copies to Capt. Harris and the City Manager,

expressing the PRC's concern that the BPD revised the Right to Watch policy without consulting the PRC or obtaining any other public input; and, because of the significance of the policy, request that until such time as community input is received and the PRC is consulted, the BPD revert to following the Right to Watch Training Bulletin.

b. Discuss proposed work plan for addressing PRC tasks, including reviving the work of the Transgender General Order Subcommittee and the possible establishment of several new subcommittees.

By general consent, the Commission agreed to schedule Special Meetings on September 16 and October 8, 2015, to have more time to devote to the investigation, with the goal of taking final action on it by its October 21 meeting, and to cancel the Regular Meeting of October 28.



Motion to adopt, as an alternative to BPD Recommendation #31: The PRC recognizes the need for the Department to make better-informed decisions in crowd control situations. Therefore, the department needs access to real time surveillance tools. Gathering such information will require some degree of surveillance, which raises concerns regarding citizens' privacy. We recommend that the Council make a determination of what, if any, surveillance tools should be considered for use, and then refer the matter to the PRC to obtain community input and work with the BPD to establish the appropriate guidelines for such use. journalists issue

Here is the language I would propose regarding the media recommendations.

The establishment by BPD of a regional media credentialing system is an issue that should be fully discussed with the community in order to assure that the varied interests and points of view of the journalists within our community are heard and considered. The PRC recommends that this issue be referred back to the PRC and a subcommittee be established which would solicit input from a broad community of journalists, including both full time employees of established media outlets and independent journalists.

I would note that both OPD and SFPD only give press passes to full time employees of media outlets of general interest who are required to report as part of their regular job. So, only the writers are able to get press passes, not editors, producers, etc. and no independent journalists. It might be a good idea for us to talk bout two different levels of press passes - one that is a pass - i.e. lets you pass behind a police line to report; and one that is a press ID - that is makes sure that the department understands you are there in a professional capacity.

I also have an independent recommendation:

For many years, the National Lawyers Guild had a team of legal observers who were present at protests in San Francisco. They were known to the OCC and the SFPD, wore special vests that said legal observers, and were allowed to remain in the area of a crowd and observe the events. I think that we should consider working the NLG or someone else to establish a squad of legal observers in Berkeley. This would be different than copwatch in that it is a neutral body - more like the UN peacekeepers then an advocate.

Mutual Aid discussions with BPD at PRC meetings

(Other than the one exception noted, these are summaries – and not verbatim transcripts of what was said – based on staff listening to meeting recordings. The times noted are those of the recording, for staff's reference.)

June 10, 2015

1:04 Lt. (Capt.) Frankel, as part of BPD presentation of report:

In conversation with Alameda Co. Mutual Aid (MA) coordinator, they agreed to send 250 officers.

MA covered under Calif. OES Guide for Emergency Ops

- Allowed to request when event or circumstances are beyond their local ability to handle. Request is made through the Co. MA coordinator. When authorized to make the call, they contact Sheriff's Dept. Discuss resources needed, the mission of responding officers, and what equipment is required to handle. Sheriff contacts law enforcement agencies within the operational area
- When they come to our City, WE are in charge of the operation. However, MA responders are required to follow their own policies, and to bring their state-approved equipment.
- To manage events involving multi-agency situations, required to use SEMS. Scalable tool for resource management. Mandated to do so by Govt Code sec. 8607(a).
- 1:06 Staging. Chose 2100 McKinley Ave. PSB parking lot too small. McKinley chosen due to proximity to PSB. Responding agencies check in there. Mutual aid commanders could easily access the DOC; responding officers could receive briefings in their briefing room; food and bathrooms avail. there.
- Issues: Could have chosen more remote site, but that presents other problems for security and communications.
- 1:07 On Dec. 6, briefing was at 3:30 p.m. All BPD resources and half MA responders there. Decided in planning only half would respond. And depend on how things went, decide whether other half needed. One BPD commander was designated MA liaison. Provided ops plan and briefed MA responders.

Vicente

Mutual Aid – what depts. and how many and what weapons? Whose armored truck and why?

Capt Harris: BPD doesn't have armored vehicles

Request for MA is made to Alameda Co. Sheriff's office and they call other agencies.

Sgt. Montgomery: 250 officers 1st night; 100 officers from 7 agencies 2nd night

Brought whatever equipment they had. State doesn't dictate. Nothing outrageous in

their mind about what was brought. Meehan: Hayward's armored vehicle?

Lippman

Mutual aid – Council adopted PRC recommendations re crowd control in 1992. One of them concerns mutual aid: BPD take direct supervisory ability . . . to maximum allowed by law. Abide by Berkeley policy. If can't, then BPD can choose to not use. Was Chief aware of this policy, passed in 1992?

Chief: Was not aware.

In 2009 redrafted Crowd Management policies. Assume done in consultation w/ community and with those docs.

GL: assume City law.

Chief[?]: Mayor has never prohibited using one [armored vehicle?]. But don't own one.

Chief, you said Sheriff chooses agencies in mutual aid.. Has dept. ever tried to provide input on what agencies participate?

Chief: Not local agency's role. We make a request; the Sheriff makes a determination based on their polling of the agencies in the area as to who is available. That's not how the system works. We're not in a position – suppose if we did want to cherry pick, and say we do want this or that agency to show up, we'd get same response when we asked for help: some would show up and some would not, and the system would simply break down.

GL: So there's no rule against it, but we don't find it advisable.

Chief: Not sure what the rules are, but we've never done it and not aware of any other agency that has. Due to the necessity of being able to rely on mutual aid. No agency is large enough to handle every eventuality. Mutual aid is critically important and state mandated rule. So we have to be open to the agencies who are willing to assist us.

GL: More info about who participated and what days? Incl. who supplied armored car. Chief: Have some info – can give short list today or longer list later:

Lt. Dave Frankel: Dec. 6 Alameda Co Sheriff's Office, Alameda PD, Hayward PD, Pleasanton PD, Livermore PD, Oakland PD, CHP and UCPD.

Dec. 7 Alameda Co Sheriff, Alameda PD, Fremont PD, Newark PD, CHP, Pleasanton PD, Livermore PD.

GL: Whose armored car? Media and eyewitnesses reports say Hayward. Can you confirm?

Chief: Believe Hayward; not sure.

GL: Position of dept. that it has no control over the makeup, conduct or equipment of other departments other than act according to law?

Chief: No.

GL: To what extent does inviting agency control equipment or conduct?

Chief: Equipment decided by agency who possesses it. We can provide general guidelines and provide a mission -- what we are trying to accomplish. And here are guidelines on how we'd like to do it. Have no authority to tell another agency what their policy should/shouldn't be and whether they should/shouldn't follow it. They're required to follow their policies and we're required to follow ours.

GL: And yet you do provide overall tactical [direction] to the event.

GL: Pathfinders -- a state or local concept? Part of mutual aid?

Chief: What we use to help liaison with mutual aid responders.

GL: Do the Pathfinders supervise the teams?

DF: Pathfinders are BPD sgts or officers assigned to mutual aid squads. They're riding with them, usually sitting next to commander of the squad. Primary role is to assist with communication and navigation issues. Relay taskings from the DOC to them.

GL: Do you have any accounting of their activities, such as their use of less than lethal force?

DF: No, pathfinders not tasked with tracking other agencies' use of force; they follow their own protocols re tracking.

GL: Are pathfinders riding with the other agencies supervising the other agencies?

DF: They are conveying commanders' directions from the DOC.

GL: Having seen/reviewed use of force doc from Hayward I see extensive use of less lethal force. Both sponge and rubber bullets. Were they directed to use those? Conveying orders to use from the command staff?

DF: Decisions to use less lethal were made by people in charge of those squads.

Chief: Would add that not only are they required follow their own policy, they're also expected to protect themselves. If they believe in a given situation that use of less lethal is to prevent further harm, then an agency would do that. They're not required to wait for our approval to do that.

1:10 GPV

Is it your understanding that the responding agencies follow their own general orders and state and federal law and state-mandated POST training?

Chief: Yes, they're required to follow the law and their own rules and policies. Presumably following the state-mandated training they received.

GPV: No other agency in county that answered call for mutual aid that would be in violation of any state or federal statute. We're talking about someone coming into our city following a G.O. that is much different from our approach to crowd control/management.

Is there any police dept in the state of California that doesn't follow federal and state regulations in terms of G.O.s for that to be such a concern? Want to make it clear that every police dept in the state, regardless of G.O.s, follows state and federal law. We can change our own G.O.s, affecting how we react, but we cannot change how other agencies operate.

Discussion of draft findings dated 8-10-15 16:20

Paragraph 7 line 8 ["Under the current BPD policy, mutual aid responders follow their own department's internal rules and protocol. footnote: "Footnote: BPD Report, Page 16, paragraph 3."]

TR: Is it BPD policy or per the Mutual Aid agreement? There's a difference.

AB: It's both in the current G.O. and I think in the Govt Code.

GL: State law is to the contrary. LEMA. All contradict this and say the inviting agency is responsible for what happens; conduct; materials.

AB: That's not what this says. BPD is responsible for setting and explaining the mission. But if Hayward PD says we always put 2 officers per car, and BPD says we only want one per, Hayward gets to put 2 officers.

Capt. D. Frankel: State guidelines say hosting agency is in charge, but individual responding agencies follow their own policies. For instance, when Oakland was on the line, they refused to do certain things b/c it was against their own policy; whereas, other agencies would do things differently.

DF: Several instances where other agencies wouldn't do things b/c it was not within their policy.

TR: So BPD couldn't require them to go against their own policy, just as if you're in another jurisdiction you follow your own policy.

Lt. D. Montgomery: Here's a concrete example of what actually happened. CHP arrived in our city on a mutual aid request that had gone beyond our county. They arrived with a squad of 50 officers; they consider their special response team to be 100 officers. When we asked them to deploy and start taking assignments, they refused and said we will not, until entire squad of 100 officers is here. The Govt Code allows them to 1) keep their chain of command and units together and intact; and 2) as well as follow own policies.


AB: Oakland PD doesn't allow for use of batons in crowd control. If BPD responds into OPD for cc, and BPD does allow batons for cc, will it use batons for cc?

DM: Yes, they will. But generally reconcile differences with command and give assignments that are appropriate to them, e.g., by not having BPD doing front line crowd stuff.

BV: What happens if Oakland comes in and brings dogs, for instance.

DM: We did have a canine unit respond; we asked them to keep the dog in staging area, which they did. Most of the time it's not a matter of them really wanting to use a particular resource; they bring what they think is appropriate and we ask them to make adjustments. We negotiate, and try to give them assignments. We're in charge of the event.

1. Preface

The Berkeley Police Review Commission (PRC) was created by Berkeley voters "...to provide for community participation in setting and reviewing Police Department policies, practices and procedures and to provide a means for prompt, impartial and fair investigation of complaints brought by individuals against the Berkeley Police Department." (Berkeley Municipal Code Sec. 3.32.010.) Established in 1973, it is one of the oldest civilian oversight agencies in the nation.

The nine members of the Commission are appointed by the Mayor and City Councilmembers. In addition to the current members of the PRC listed on the cover page, former Commissioners Bulmaro Vicente and Lowell Finley (a temporary appointment) contributed to the investigation.

PRC staff are part of the City Manager's Office. PRC Officer Katherine Lee and temporary Investigator Beneba Thomas assisted the Commissioners in conducting their investigation and producing this report.

2. Introduction

Beginning on December 6, 2014, the City of Berkeley experienced several days of protests sparked mainly by the deaths of black men at the hands of police officers in Ferguson, MO and Staten Island, NY. The first night of protests drew the largest crowds; unfortunately, the peaceful resolve of the vast majority of demonstrators was undermined by individuals intent on committing violent acts against people and property. But the response of the Berkeley Police Department, even by its own assessment, fell short of community expectations. The days and weeks that followed were marked by public outcry over perceived excessive use of force and infringement on First Amendment rights at the hands of police. The City Council and the Police Review Commission heard from scores of members of the public who witnessed or were victims of police action on December 6.

One of the several actions the Council took in response was, at its February 10, 2015 meeting, to ask the PRC to conduct an investigation:

Refer to the Police Review Commission to initiate an investigation into the police response to protests on December 6, 2014; the appropriateness of using tear gas, and other non-lethal munitions, and baton strikes to disperse the crowd; and make recommendations based on what was learned from the incident and what could be improved upon for revised policies and procedures on crowd control, the use of force in crowd control incidents (tear gas, non-lethal munitions, use of batons), as well as policies on mutual aid in First Amendment activity and crowd control incidents. . . .

The Council also refers the attached questions to the Police Review Commission to consider in conducting their investigation.¹

In conducting its investigation, the PRC listened to firsthand accounts of protestors' experiences at several of its meetings. On February 25, the PRC held a special meeting on the University of California campus to facilitate the ability of students – who comprised a large portions of the demonstrators – to speak about what they saw and experienced. Several Commissioners drew on their own experience, having themselves participated in the December 6 protests. Some Commissioners and staff attended the City Council's January 17 Worksession on Improving Police and Community Relations. Staff compiled written summaries of public comment from that Worksession and other City Council meetings for the PRC.

The PRC's investigation included review of dozens of documents the BPD supplied, along with some 400 video clips of the December 6 events taken by BPD, protesters, media, and other civilian observers. Collectively, the Commissioners viewed each one of those clips.

The Commission studied the BPD's applicable policies, including General Orders C-64 (Crowd Management and Control), U-2 (Use of Force), and M-2 (Mutual Aid and Agreements with Law Enforcement Agencies). It also reviewed the parallel policies of the Oakland and San Francisco police departments, as well as state law governing mutual aid.

On June 9, the BPD issued its report, "Response to Civil Unrest December 6th and 7th, 2014: A Review of the Berkeley Police Department's Actions and Events of December 6 and 7, 2014," which the Commission reviewed extensively. Police Chief Michael Meehan and the BPD Post-Incident Review Team presented the report to the PRC at its June 10 meeting, and then answered questions from the Commission. The Chief and/or review team members attended all subsequent PRC meetings, regular and special, to answer additional questions and provide clarifying information as the Commission continued its work.

The Commission appreciates the BPD's candor in spelling out in its report that the strategies used on December 6 did not achieve the desired outcome, and in identifying numerous areas for improvement. It is pleased to see the BPD reaffirm its commitment to protecting free speech and facilitating protests regardless of the message being expressed. At the same time, the PRC's views of what happened and how the BPD can improve future such responses diverge in some respects. The PRC questioned the accuracy of the BPD's characterization of who organized the protests and why, so the Commission produced its own findings of the events of December 6 (Section [3]).

Following the Findings, the PRC offers its analysis of those events in the Discussion section (Section [4]). Next, in the Recommendations section (Section [5]), the PRC assesses each of the 32 recommendations the BPD made in its report. The Commission agrees with some of the recommendations, offers alternatives to most others, and suggests [a few] recommendations of its own.

The Council asked the Commission to report its recommendations to the City Manager, Chief of Police and City Council by August 10. Due to the significance of the Council's charge, the PRC decided to handle its investigation as a full Commission, without establishing a subcommittee (other than a steering subcommittee to help organize

the Commission's work at the start.) The Commission worked diligently. Nonetheless, the PRC needed an additional 2-1/2 months to complete its work, due to the scope of the events and the policy issues raised. From the time of the Council's February referral until the final approval of this report, the PRC held ten special meetings to devote more time to the investigation, in addition to its 14 regular meetings, while clearing its agendas of all else but the most pressing matters. It took time to get a good picture of what unfolded over several hours, in protests that moved from the campus area to the I-80 freeway and back, and that involved crowds of up to 600 people. The police policies implicated – chief among them those regarding crowd control and crowd management, use of force, and mutual aid – are some of the most challenging and complex issues to tackle.

In a separate action in February, the City Council asked the PRC to review all BPD policies and orders and make recommendations for revisions that it deems appropriate. In the course of this investigation, the PRC reviewed many applicable policies of the BPD and other agencies, and made numerous general recommendations about policy, which are described in this report. Thus, much of the groundwork has been laid for developing specific revisions to the BPD's policies. The PRC looks forward to working with the BPD on these important next steps.





Narrative from report:

On 8-6-2015 at 0836 hrs, I responded to Camelia St. west of San Pablo Ave. to assist with a welfare check/5150 WI investigation involving of acting violent and causing a disturbance.

Ofc. Murray and I engaged and tried to communicate with him but he was totally uncooperative and belligerent, and at times threatening, saying he would become violent if we approached him. The entire time we were attempting to speak to , he flexed his chest, shoulder, and arm muscles, and made fists with both his hands. We asked several times to sit down (to better control him and maintain everyone's safety) but he refused to comply.

CIT trained Sgt. Delaluna #S-32 also attempted to communicate with but he continued to be belligerent, threatening, an non-compliant.

The decision was made that met the criteria for a 5150 WI hold/detention.

Because of his threatening behavior, I wanted to detain in handcuffs. I told of my intention to handcuff him and ordered him to turn away from me and place his hands behind his back. refused to comply. I again ordered him to turn around and place his hands behind his back, this time warning him that if he refused to comply, I would spray him with O.C. said, "Fuck you, go ahead."

I sprayed a burst of O.C. onto eyes and face; Ofc. Murray also sprayed with O.C. began wiping his hands down his face and appeared to be temporarily stunned by the O.C. We took the opportunity to take control of wrists and direct him to a prone position on the ground where we handcuffed him without incident.

We had BFD respond to the scene to provide post O.C. care to

SUMMARY

On May 6, 2014, the Council directed the City Manager to research and report back to the City Council regarding the history, potential benefits, impacts, and possible unintended consequences of allowing Berkeley police to carry and use Tasers, and to include in the report information regarding other jurisdictions "best practices" and protocols, an analysis of changes in technologies, and the feasibility of doing a pilot program, with further direction that the City Manager also consult with the Police Review Commission and the Community Health Commission.

After an extensive search for an organization that could best perform the necessary research and analysis, the City engaged the Stanford Criminal Justice Center (SCJC) to conduct such a study. The work was done by the SCJC on a pro bono basis. The selection of this organization was made with consultation from representatives of the two commissions.

Founded in 2005, SCJC serves as a research and policy institute focused on the criminal justice system. Its efforts are geared towards policy research for the public sector, as well as providing pedagogical opportunities to Stanford Law School students with academic or career interest in criminal law and crime policy. The report was written by Jena Neuscheler and Akiva Freidlin and overseen by SCJC Executive Director Debbie Mukamal and Professor David Sklansky. The work on the study began in January and concluded this summer.

The full SCJC study is appended to this report.

CURRENT SITUATION AND ITS EFFECTS

The Stanford Criminal Justice Center examined a number of issues involving electronic control weapons, a term that also includes devices with the trade name "Taser." The center's report looked at the devices themselves, the health effects of ECWs, how and when they are used, and effects on public safety.

The center was not asked to make a recommendation. Their research has shown that the extent to which local jurisdictions make decisions to use electronic control weapons depends on the values and needs of the particular community.

Part 1 includes a summary of the development of the technology, an analysis of how the devices work, and their reliability. The study also examines the health effects of the devices.

Part 2 examine how and when ECWs are used. The section also examines how widely they are used, who they are used upon, legal standards and use of force policies.

Part 3 assesses questions of whether ECWs replace use of lethal force, reduce injuries to officers, reduce non-lethal injuries to suspects and whether there have been study of other ways to achieve these goals.

BACKGROUND

The City Manager's Office issued an RFP to conduct the research in the Council referral. Proposals were reviewed by a panel that included representatives from the Police Review Commission, the Community Health Commission, the Police Department, and the Finance Department. The panel consensus was that the proposals did not adequately respond to the RFP or were too costly. The Stanford Criminal Justice Center has a highly regarded reputation for neutral, thorough and insightful research. They have done similar projects for other jurisdictions. The panel that included representatives of the two commissions convened to meet with and ask questions of the entire SCJC team. The panel supported the use of the SCJC to conduct this study.




