#### Below is a list of scholarships applicable to U.S. citizen and permanent resident MBA students. Please click on the scholarship organization to visit their web site.

<u>The American Association of University Women</u> offers fellowships to female international students studying in the United States. Some fellowships are available for minority women who are U.S. citizens or U.S. permanent residents.

<u>The American Indian Graduate Center</u> offers fellowships to Native American students who become eligible for need-based financial aid.

<u>The American Institute of Certified Public Accountants</u> (AICPA) has two scholarships for graduate students pursuing studies in finance.

- The Minority Accounting Scholarship
- <u>The AICPA Accountemps Student Scholarship</u> provides for students majoring in accounting, finance or information systems.

<u>The Association of Management Consulting Firms and Richard Metzler Scholarship</u> are for students who demonstrate a commitment to management consulting while pursuing their MBA.

<u>The Bodossaki Foundation Scholarship for Social-Economic Sciences: Economics/Political Economy</u> award is given to one student of Greek nationality, parentage or descent. Only persons born after December 31, 1967 are eligible. The selection of the winner will be based on exceptional achievements. For more information, please email secr@bodossaki.gr.

<u>The Bridgat Scholarship Program</u> is a merit-based fund awarded to one full-time graduate student who must be a citizen of an Asian country. This scholarship is only available to second year MBA students as it requires a minimum GPA of 3.0 on a 4.0 scale.

<u>Daughters of the American Revolution (DAR) American Indian Scholarship</u>. This scholarship is awarded to help Native Americans students of any age, any tribe and in any state striving to get an education at the undergraduate or graduate levels. However, undergraduate students are given preference. All awards are judged based on financial need and academic achievement. This is a one-time \$4,000 award.

<u>The Dolores Zhorab Liebmann</u> Fund awards graduate school fellowships in any recognized field of study in the humanities, social sciences, or natural sciences (including law, medicine, engineering, architecture, or other professional training) for independent research and study grants. Applications must be submitted through the dean.

<u>Don Kuhn Memorial Scholarship Fund</u> will provide a scholarship to a deserving graduate student with a demonstrated commitment to pursuing a career in non-profit/interactive marketing. The application is available <u>here</u>:

<u>Davis-Putter Scholarships</u> Need-based grants (up to \$6,000) to undergraduate or graduate students actively working for peace and justice on campus and/or in the community.

## U.S. Citizen/Permanent Resident External Scholarships

<u>Echoing Green Foundation Fellowships</u> Seeks to provide seed funding and support to more than 450 social entrepreneurs with bold ideas for social change in order to launch groundbreaking organizations around the world.

<u>The Federation Executive Recruitment and Education Scholarship Program (FEREP)</u> is a graduate scholarship program funded through the Jewish Federations of North America that recruits, supports and develops future professional leaders for the North American Jewish federation system. The program awards to specified areas of graduate study in return for a minimum two-year paid work commitment in a North American Jewish federation following graduate school. FEREP also provides supplemental professional and cohort development opportunities, and assists students with the placement process leading to their first federation position.

<u>The Financial Leadership Scholarships for Bay Area Women</u> is a scholarship for female students attending Bay Area universities or colleges pursuing a degree in business administration.

<u>The Fulbright Scholarship Program</u> offers awards to students who aim to increase mutual understanding between the peoples of the United States and other countries, through the exchange of persons, knowledge, and skills.

<u>The Fundação Estudar Scholarship</u> is for Brazilian students who demonstrate high intellectual potential. Multiple scholarships are awarded each year, many to students studying business. The application deadline is March 2013.

<u>Fundacion Rafael Del Pino</u> offers 15 scholarships to Spanish students to help create the next generation of Spanish leaders. Educational areas of interest to the foundation are: economy and company; economic analysis of the right; regulation and deregulation and economic analysis; and legality of competition and the markets.

<u>The Government Finance Officers Association</u> offers numerous scholarships to MBAs with a career interest in the efficient and productive investment of public funds in state and local government finance. <u>The Harvey Fellows</u> is a stipend amount of \$16,000 per year, up to two years. The fellowship is awarded to Christian graduate students attending a top five school to integrate their faith and vocation and pursue leadership positions in strategic fields where Christians tend to be underrepresented. The number of fellowships awarded each year varies according to available funds from the Mustard Seed Foundation.

<u>The HR Symposium Lynne Boone Memorial Scholarship Program</u> awards scholarships to graduate students enrolled in Human Resource and Organizational Development degree programs, as well as professionals enrolled in MBA programs with the objective of advancing in the HR field. The scholarships consist of three master's level scholarships, and the criteria for receiving the scholarships includes, but is not limited to: Academic excellence, work experience in HR, volunteer/extra-curricular activities and professional/faculty recommendations.

<u>Humane Studies Fellowships</u> For undergraduate and graduate students interested in the classical liberal/libertarian tradition of individual rights and market economies. More than 100 fellowships up to \$12,000 are awarded annually.



International Council of Shopping Centers (ICSC) Foundation is awarding two \$10,000 scholarships. An ideal candidate is a graduate student and ICSC member from anywhere in the world. S/he will be enrolled in the upcoming August/September academic term at an accredited university. Applicants with 3.0 GPAs, who are full-time will be considered. Candidates must demonstrate a record of dedication and participation in the industry.

<u>The Jewish Vocational Service (JVS) Scholarship Program</u> provides need-based scholarships for graduate school for Jewish students who are permanent residents of Los Angeles County. Scholarships range from \$500 - \$5,000.

<u>The Korean American Scholarship</u> awards numerous scholarships to Korean American college students across the country.

<u>Kosciuszko Foundation Tuition Scholarships</u> support American students of Polish descent for full-time graduate studies in the United States. Scholarships range from \$1,000 to \$7,000.

<u>Lebanese International Finance Executives (LIFE)</u> is a non-for profit membership organisation providing a platform to channel the influence of Lebanese Finance Executives worldwide in order to establish stronger bonds, nurture the next generation and promote Lebanon. The LIFE scholarship provides support to talented Lebanese students – or those of Lebanese descent – with financial needs, to pursue their academic aspirations in the field of finance. It is a unique combination of financial support and mentorship opportunity by a LIFE Senior Member who will provide guidance and advice to the scholars on their professional objectives.

<u>Lime Connect and BMO Capital Markets</u> are pleased to partner in offering the BMO Capital Markets Lime Connect Equity Through Education Scholarship for Students with Disabilities. The scholarships are intended for current undergraduate and graduate students enrolled in a four-year university program, who have any type of disability, and provides US\$10,000 or C\$5,000 in support of future studies in either the US or Canada.

<u>The Lynn Adamson Memorial Scholarship</u> sponsored by Women Health Care Executives, a professional association dedicated to career advancement of women in health care offers a scholarship to students currently enrolled in a graduate degree program.

<u>The Markowski-Leach Scholarship</u> is open to gay or lesbian students with a commitment to excellence and leadership, thereby improving the perception of gays and lesbians in society.

<u>The Memorial Education Fund (MEF) and the Stuart Cameron and Margaret McCloud Memorial (SCMS)</u> <u>Scholarships</u> are available to graduate students studying accounting or finance. The scholarships are awarded by the Institute of Management Accountants (IMA).

The Montgomery G.I. Bill has resources available to assist veterans with educational costs.

The National Black MBA Association, Inc. offers hundreds of thousands of dollars in scholarships annually.

<u>The National Federation of the Blind</u> offers a number of different scholarships to high-achieving legally blind students.

<u>The National Italian American Foundation</u> awards scholarships to Italian American students who demonstrate outstanding potential and high academic achievement.



<u>The Nova Scholarship</u> is awarded to Italian candidates who demonstrate academic and professional excellence. The grant, co-financed by the Italian branch of the Boston Consulting Group, will be awarded for the 2 year MBA program to cover part of tuition and fees. <u>The Orbis Investment Management Fellowship</u> is a cash award attributable towards tuition or course-related expenses for an exceptional, soon-to-be first-year MBA student, from any background, with any experience, who can demonstrate his or her talent and passion for investing.

<u>The Paul and Daisy Soros Fellowships for New Americans</u> is a maintenance grant and tuition support for naturalized citizens or permanent residents who retain loyalty and a sense of commitment to their country of origin as well as to the United States and will continue to regard the United States as their principal residence and focus of national identity.

<u>Pension Real Estate Association (PREA) Scholarship Program</u> awards scholarships on an annual basis to promising students studying real estate at the undergraduate and graduate levels.

<u>The Phi Kappa Phi Honor Society</u> offers multiple graduate scholarships and awards for the first year of professional study.

<u>The Point Foundation</u> is a national scholarship fund for high achieving lesbian, gay, bisexual, and transgender students in higher education.

<u>The Ray Greenly Scholarship</u> offers scholarship to students interested in digital retail. This scholarship is for continuing graduate students only. For more information about the application and eligibility requirements visit their web site.

<u>The Robert A. Toigo Foundation Fellowship</u> offers a stipend towards your tuition for two years, in addition to networking and mentorship opportunities. Eligible applicants include US Citizens and permanent residents who are also racial minorities as defined by the US Department of Labor.

<u>The Sainsbury Management Fellowships</u> awards Fellowships to EU /EEU citizens who are normally domiciled in the United Kingdom and who have a first degree in Engineering who are pursuing a fulltime MBA. Applicants should be able demonstrate how their MBA will enable them to contribute to UK engineering and business.

<u>The Scholarship Foundation of Santa Barbara</u> offers scholarships to students who attended at least four of the six secondary grade school years in Santa Barbara County **and** graduated from high school in Santa Barbara County.

<u>The Schmidt-MacArthur Fellowship</u> is awarded to students to undertake a Circular Economy Innovation Project (postgraduate work focused on creative and innovative models, concepts and tools that contribute towards the acceleration to a circular economy) as part of their postgraduate course. Requires recipient to secure a faculty mentor and attend a weeklong summer program.

<u>The Switzer Foundation</u> has fellowships specifically for graduate students who show a strong personal commitment to solving problems and effecting change in the environmental arena.

<u>The Thomas R. Pickering Foreign Affairs Graduate Fellowship</u> from the Woodrow Wilson National Fellowship Foundation provides for the cost of tuition, room, board, and mandatory fees for the first year and second year of graduate study, with reimbursement for books and one round-trip travel. This fellowship also includes summer internships after each year of study.

<u>The Transamerica Retirement Solutions Leaders in Health Care Scholarship</u> is available to first and second year graduate students who are pursuing degrees in healthcare administration or a comparable degree (i.e., MBA, MPH, MHA, MPA). Candidates must be a member of a federally classified ethnic minority group. Scholarships are open to both incoming and continuing students.

<u>UNCF Scholarships and Grants</u> A series of scholarships which hold their own eligibility criteria, open/close dates and required documents. In order to apply for a UNCF Program Services Scholarship, you must apply through the online application process.

<u>Women in International Trade Northern California Scholarship Program</u> will award one qualified student with career aspirations in the field of international trade, business or policy.
