County of Santa Clara Parking Administrative Guidelines Vehicles and Bicycles

The Administrative Guidelines ("Admin Guidelines" or "AG") cover parking designations, permits, and signage in accordance with County Ordinance Code Title B, Division B12, Chapter III, Article 3 Parking Regulations on County Property. Title B has additional references to parking that may be applicable to parking regulations.

The County Executive or designee has the responsibility to administer all parking regulations, to meet the objectives of efficient use of limited parking areas, ease of public and employee access to County facilities, and support of the County's environmental goals, including the support of alternative commuting and the reduction of greenhouse gas emissions.

These guidelines provide additional direction for the implementation of the Parking Regulations. Article 3 Parking Regulations are included in Appendix A. In addition, the guidelines provide information on bicycle parking at County facilities. Guidelines are updated periodically by the Parking Enforcement Regulations Committee (PERC).

1. Designated Parking County Ord. Code B12-157(a)

Designated Parking areas are for vehicles with specified characteristics or for conditions under which a vehicle may or may not be parked or left standing. The designated parking areas shall be identified by sufficient signage that clearly states the types of vehicles that can park there and any time limitations.

The following types of designated parking areas shall be established, as necessary, at County facilities.

a. Visitor/Public Parking (non-employee visitors doing business with the County) County Ord. Code B12-157(a)

Visitor/Public Parking sections are subject to time limitations, appropriate to the facility where they are located and which are indicated in signage. From 8:00 am to 5:00 pm, Mondays through Fridays, excluding holidays, Visitor/Public Parking areas are designated for members of the general public while using County buildings or facilities within the time limit specified in signage; any vehicle bearing a state "Disabled Person" license plate or placard may park there without time limits.

Vehicles of County employees and County vehicles shall not be parked in Visitor/Public Parking areas during the effective hours of the regulation.

b. Limited Time Parking County Ord. Code B12-157(a)

Signs for areas designated for short-term parking will clearly indicate the time limits. These areas may be used without time restriction by a vehicle with a state "Disabled Person" license plate or placard. Some timed areas are allowed only for designated users, e.g., employees. For these, signage will clearly indicate authorized users.

c. Loading Zone County Ord. Code B12-157(a)

Loading zones are painted and signed according to State regulations. These parking areas are designated for vehicles engaged in the loading or unloading of supplies, material or equipment for the period of time necessary to load and unload the vehicle, but not to exceed posted time limits.

d. Mail Drop-Off County Ord. Code B12-157(a)

Mail drop-off zones are designated for the purpose of delivering mail materials to a County facility and are time-limited as posted.

e. Specific Departmental Parking Areas (as noted on signs) Ord. Code B12-157(a)

Vehicles parking in these designated areas must have a card, a placard or a permit issued by the department that indicates permission to park there, or it may be a County vehicle with departmental identification painted on the door.

Confidential and under cover vehicles will be confidentially and specially marked to alert PEOs of their status. PERC maintains a master record of which departments have specified parking areas and issue special departmental permits.

f. "A" Parking Permit Areas County Ord. Code B12-157(a)

Vehicles must properly display an "A" permit.

g. "C" Parking Permit Areas County Ord. Code B12-157(a)

Vehicles must properly display a "C" permit or an "A" permit.

h. FAF Service Vehicle Parking Areas County Ord. Code B12-157(a)

FAF areas are designated for vehicles bearing a special "FAF" (Facilities and Fleet) permit or door insignia.

i. Employee Carpool Parking County Ord. Code B12-157(a)

Carpool spaces are assigned by number to specific carpool groups. Any vehicle parking in a carpool spot should have a permit visibly displayed, as instructed, that identifies the specific number of the parking space.

j. Employee Clean Air (Green) Vehicle Parking Areas County Ord. Code B12-157(a)

Green spaces are designated for employee vehicles bearing both a County Clean Air Vehicle (Green) permit and an "A" or "C" permit, or a combination permit, e.g., Green "A" or Green "C". County owned vehicles (E and FAF vehicles) with a County Clean Air Vehicle permit may also park in these spaces. meeting ATPZEV (Advanced Technology Partial-Zero Emissions Vehicle) standards or higher, including electric vehicles. See 11-8-12 UPDATE under 4.c.9) below.

k. Employee and Public Electric Vehicle (EV) Charging Stations County Ord. Code B12-15.2

EVs may park in the Green Vehicles Section (employees) or, while charging, at an EV charging station (employees and public). Non-electric vehicles may not park in these sections.

The County will install EV stations, starting with 70 West Hedding. These will be Coulomb charging stations that are part of the ChargePoint Network. Use of these stations will be available to both employees and public EV drivers.

Employees who are part of the ChargePoint Network may utilize these spaces to charge their EV, but must not leave vehicle there for longer than is designated by signage. It is the responsibility of the employee to move their vehicle during an authorized break time or lunchtime and within the posted time limitations.

I. Press Parking County Ord. Code B12-157(a); B12-158

Where the County provides designated parking for Press, vehicles must display a press permit or press photographer license plate.

- m. County E-Vehicle Parking County Ord. Code B12-157(a)
 Only a County CA exempt vehicle (vehicles with exempt or E license plates and other County identifying insignia, e.g., door seal, etc.) may park in areas designated for E vehicles.
- n. Motorcycle Parking County Ord. Code B12-157(a)

 Motorcycle parking areas are designated to be used only by motorcycles.

 Motorcycles must be parked within markings.

o. No Parking County Ord. Code B12-157(a)

Vehicles may not park in areas designated as no parking areas.

2. Reserved Parking County Ord. Code B12-157(b)

Reserved parking spaces shall be assigned to elected officials and executive managers at their place of work or to specific vehicles or classification of users to which a parking area is assigned. Parking spaces or signage should indicate the official position that the space is assigned to, or as in the case at 70 West Hedding, use a number system to assign spots. Authorized vehicles are to be distinguished by hangtags or other prescribed systems.

Reserved parking spaces are authorized by the County Executive or designee.

3. Disabled Person Parking County Ord. Code B12-157(c)

Disabled person parking (as required by the Americans with Disability Act and the California Building Code) is provided for vehicles displaying a state "Disabled Person" license plate or placard.

4. Permits - Issuance and Control County Ord. Code B12-157(a); B12-158.

Permits are issued by the County Executive or designee, or as listed here. It is the responsibility of the department to collect all permits, if practicable, when the employee, contractor or other authorized permit holder terminates employment /business with the County.

It is the responsibility of County employees and others giving service to or on behalf of the County to maintain possession and ensure proper placement of any parking permits that are issued. Replacement permits may be obtained from the Employee Service Center that services the employee's department.

Permits are divided into three categories, as follows: regular, temporary, and special permits.

- a. Regular Employee Permit: Employee permits shall be issued to all elected officials of the County, all County employees, board and commission members and other persons who provide services to the County, as determined by the County Executive or designee.
 - 1) "C" Parking Permit: "C" permits may be color-coded permits that contain the letter "C." "C" permits are given out to all employees and others giving service to, or on behalf of the County. These permits will be reissued on an as-needed basis in a different color.

- 2) "A" Parking Permit: "A" permits may be permits that contain a letter "A," the date of expiration and the permit number. "A" permits are given to County elected officials, executive management, boards and commission members, and as assigned by the County Executive.
- 3) Employee Carpool Permit: Carpool spaces are individually designated to groups of employees agreeing to carpool three or more days/week. Interested carpoolers should submit an application to her/her department administration using the carpool form found on the County web site (www.sccgov.org/transit), also attached to this document. The application will be logged and routed to the Facility Manager and/or FAF. Carpool permits are issued by FAF to each driver in the carpool. Permits are numbered according to an assigned space and have annual expiration dates. If demand exceeds supply, FAF maintains a waiting list and notifies the Facility Manager and/or department when a permit becomes available. Additional County commuting information can be found on the County intranet website (www.sccgovatwork/commute).
- b. Temporary Permit: The period of time that the permit is valid, including the expiration date of the permit, shall be noted on the face of the permit. A temporary permit which does not set forth the expiration date is invalid. Only the original temporary permit is valid; copies are not accepted. (Some temporary permits are color coded to identify the permit's time limitation.)

Temporary permits are offered in the following circumstances: new employees, employees under temporary assignment, contractors or volunteers who need to have access to parking for a limited time, and departmental guests who are visiting on County business.

Temporary disabled parking arrangements for employees are covered in the following Special Permits section.

- c. Special Permit: Special permits are issued by the County Executive or designee, or as listed here, to County employees and other persons who have special parking needs or who provide special services to or on behalf of the County. Additional special permit categories can be created, as needed, by adding to this list.
 - 1) Press Parking: Press permits are issued by the County Office of Public Affairs to duly accredited members of the press or other news media, or for vehicles with a press photographer license plate a license plate (displaying "PP" enclosed within a triangle) issued by the State Department of Motor Vehicles to statutorily authorized persons. Press parking is currently available at the old San Jose City Hall lot.

- 2) Official County Business Permit: These permits are issued to employees when required to conduct specified County business, e.g., to appear in court on behalf of the County, when delivering documents related to court cases, for onsite Fire Marshal inspections, etc.
- Departmental Permit: Departments with designated parking areas are responsible for distributing permits to their employees. Departmental permits must be reviewed and authorized by the Parking Enforcement Review Committee.
- 4) "Disabled Person" License Plate or Parking Placard: This permit consists of a license plate or placard and is issued by the State Department of Motor Vehicles due to the disability of a person.
- 5) Temporarily Disabled Permit: Arrangements can be made for special designated or reserved parking on recommendation of a physician to any County employee whose physical mobility has been temporarily impaired.
- 6) County E-Vehicles: These vehicles, as designated by license plate and other County identifying insignia, e.g., door seal, etc., may park in any designated E vehicle or "C" parking areas.
- 7) FAF Service Vehicle Permit: This permit is a hang tag distributed by Facilities and Fleet (FAF) to staff working on building operations and maintenance. FAF service vehicles may park in any FAF space, but must display an FAF hang tag.
- 8) Reserved Permit: This permit is a special hang tag or placard that states the number or type of the assigned parking space and area.
- 9) County Clean Air Vehicle (Green) Permit: Vehicle must meet the SULEV (Super Ultra Low Emissions Vehicle) ATPZEV (Advanced Technology Partial-Zero Emissions Vehicle) standards or higher, including electric vehicles. A list of qualifying vehicles is maintained by the California Air Resources Board (CARB) (www.arb.ca.gov/msprog/carpool/carpool.htm). Permit Issued by ESA. 11-8-12 UPDATE: Permitting Details ON HOLD, pending analysis of expected usage of Green parking areas. Until permits available, enforcement will be based on on-site compliance to above standard, confirmed by enforcement officer patrol procedures.

5. Permits - Position and Placement

Unless otherwise noted on the permit itself or in the instructions issued with the permit (e.g., hang tags, dashboard placards, other special permits), permits must

be affixed to the rear end of the vehicle, either on the back window or back bumper, so as to be clearly visible from the parking aisle. Careful attention should be given to the area immediately around the permit to avoid placing something that partially or fully blocks it from view.

Vehicles with permits that are obscured from visibility and/or readability due to window tinting or other obstruction are subject to citation. Ord. Code B12-157

6. Bicycle Parking

To support alternative commutes and to the extent practicable, the County provides safe parking areas for bicycles to be stored by employees riding to work and for others doing business with the County.

Bicycle parking coordination is the responsibility of the facility manager. There are four kinds of bike storage options in County facilities:

- a. Designated lockers: These are assigned by Facility Manager or designee and a waiting list is maintained, if necessary. Priority for these lockers should be given to employees who bike to work on a daily basis.
- b. BikeLink lockers: These do not require County maintenance or assignment. However, the Facility Managers should familiarize themselves with the system and contact information for BikeLink maintenance and service. Locker use requires a BikeLink card which is available online (www.bikelink.org).
- c. Bike Cage: Valley Medical Center (VMC) has one bike cage located in the basement of the Visitors Garage at Building N. VMC employees may request access to the bike cage or reserve a locker by contacting VMC Protective Services (408-885-5567).
- d. Bike Racks: Numerous bike racks are available at County facilities. Bikes should use bike racks as intended and not be locked to rack in such a way as to disallow other bicycles access to the bike rack. Additional Information on biking in the County can be found on the County website (www.sccgovatwork/commute).

7. Proper Positioning of Vehicles

As a general safety provision, for orderly traffic flow and to promote consistent practices, vehicles may not park in a backed-in position. Driving through a parking space in order to position the vehicle with the front end pointing towards the traffic aisle is prohibited. Vehicles who violate this provision are subject to citation.

Ord. Code B12-159

8. Signage

Signs will include designation and any time limitations. Draft wording for new designations will be reviewed and approved by appropriate facility staff, any related and standing parking committees, and the Parking Enforcement Review Committee (PERC) before signs are ordered. Signage language and design will be standardized across the County and will be consistent with ordinance and Administrative Guideline language and descriptions.

10. Citations and Citation Appeals Process

a. Paying for a Citation

Due date: Within 21 days of citation date.

Enclose a check or money order (no cash) payable to Santa Clara County Parking for the amount of the fine indicated, and mail it to the address on the reverse side of the citation (Santa Clara County Parking, PO Box 849, San Jose, CA 95106-0849) or pay online at www.CitationProcessingCenter.com or by phone at 408-299-8686 (weekdays from 8:00 am – 5:00 pm).

If you fail to respond, there will be additional fees and you will lose the option to dispute the citation. Noncompliance may result in a potential lien hold placed against your registration by the Department of Motor Vehicles. Any vehicle having five or more unpaid parking violations may be impounded and held by the Office of the Sheriff or immobilized. *CA Vehicle Code* 22651(i)(1); 22651.7.

b. Citation Appeals Process

To contest a citation, send your written dispute letter to the address on the reverse side of the citation (see above) or appeal online at above website. Failure to do this within 21 days from issuance of a notice of parking violation or 14 calendar days from the mailing of a delinquent notice of parking violation will result in the loss of your option to dispute the citation. Results of the initial review will be mailed to you, and will include reason for denial, if applicable.

If you are dissatisfied with the results of the initial review, you may request an administrative hearing of the violation no later than 21 calendar days following the mailing of the results of the County's initial review. If you are requesting an administrative hearing, you must deposit the amount of the parking fine with the processing agency, unless a waiver is granted due to satisfactory evidence of inability to pay. An administrative hearing shall be held within 90 calendar days following the receipt of a request for an administrative hearing. You may request one continuance, not to exceed 21 calendar days. *CA Vehicle Code 40215*.

You shall have the choice of a hearing by mail or in person. Hearings are held once monthly, at 1555 Berger Drive, San Jose. If you select an in-person hearing, you will be notified by mail of the scheduled date. The hearing shall provide an independent, objective, fair, and impartial review of contested parking violations. If you are a minor you shall be permitted to appear at a hearing or admit responsibility for the parking violation without the necessity of the appointment of a guardian. The processing agency may proceed against a minor in the same manner as against an adult.

Hearing examiners have the qualifications, training (minimum 20 hours), and objectivity necessary to conduct a fair and impartial review. An examiner may not be employed, managed, or controlled by a person whose primary duties are parking enforcement or parking citation processing, collection, or issuance. The examiner shall be separate and independent from the citation collection or processing function. Further, an examiner's continued employment, performance evaluation, compensation, and benefits are not, directly or indirectly, be linked to the amount of fines collected by the examiner.

The officer or person who issues a parking citation is not required to participate in an administrative hearing. The ticket issuing agency is not required to produce any evidence other than the notice of parking violation or copy thereof and information received from the Department of Motor Vehicles identifying the registered owner of the vehicle. The documentation in proper form shall be prima facie evidence of the violation.

The examiner's decision, following the administrative hearing, will be sent by first-class mail, and if the appeal has been denied, will include the reason for that denial. Following a determination by the examiner that a violation was committed, if you can provide satisfactory evidence of inability to pay the parking penalty in full, payment of the parking penalty may be allowed in installments.

If you are dissatisfied with the results of the administrative hearing, within 30 calendar days after mailing of the final decision, you may seek review by filing an appeal to be heard by the superior court. The contents of the processing agency's case file will be provided to the court as *prima facie* evidence. A copy of the notice of appeal must be served in person or by first-class mail upon the processing agency by the contestant (you). The court will notify the contestant of the appearance date by mail.

There is a Court fee for filing the notice of appeal, to be paid by the contestant, pending outcome of the civil hearing at the superior court. The court shall retain the fee regardless of the outcome of the appeal, however, if the case is found to be in favor of the contestant, the amount of the fee will be reimbursed to the contestant by the County, and any deposit of parking fine will be refunded by the County in accordance with the judgment of the court. *CA Vehicle Code 40230.*

If no notice of appeal of the County's decision is filed within the periods prescribed above the decision will be deemed final. If the parking fine has not been paid, and the decision is against the contestant, the County will, after the decision becomes final, proceed to collect the fine.

Administrative Guidelines (AG) and Parking Enforcement Review Committee (PERC)

Copies of parking regulations and the Admin Guidelines shall be available for examination by all interested persons at the offices of the Clerk of the Board of Supervisors, the Office of the County Executive, the Facilities and Fleet Department, the Department of Revenue, the Employee Services Agency, the Office of the Sheriff, and shall be posted on the official County website (www.sccgov.org/transit).

The Parking Ordinance (Title B, Division B12, Chapter III, Article 3), the Administrative Guidelines (AG) and the citation forms are interrelated. Therefore, changes to the AG must take into consideration how these changes will affect the citation forms and enforcement. Because the Department of Revenue (DOR) is directly involved with the oversight of parking citation processing services, appeal process and revenue from citations, the Office of the County Executive assigns responsibility for updates to the Director of DOR. DOR will establish a Parking Enforcement Review Committee (PERC) to review possible changes and update the AG when needed. All changes to the AG will be reviewed by this committee.

The PERC include representation as follows:

- 1) Chair: Director of DOR or designee
- 2) Parking Enforcement
- 3) Parking Appeals
- 4) Facilities and Fleet (FAF)
- 5) Employee Services Agency (ESA)
- 6) Office of County Executive

12. Parking Concerns

General Inquiries, FAQs: Public with questions regarding parking that are unrelated to citations, should be directed to the www.sccgov.org/transit page on the County website, where they can email appropriate staff with questions and concerns. (parkinginquiry@dor.sccgov.org)

Permits: Employees with questions or needs relating to their vehicle parking permits, such as replacing a lost permit, should contact their departmental human resources team (HRT).

Facility Issues: Employees with questions about facility parking issues or carpooling should contact their Facility Manager who will inform the FAF or appropriate parking committee staff support person.

Bikes, EV Charging Stations: Employees with questions about bike lockers or electric vehicle charging stations, should contact their Facility Manager.

Citations: All public and employee concerns regarding citations that have been issued should be addressed according to the process outlined on the citation and in section 9 above.

 - (6) Anderson Dam and Reservoir.
 - (7) Coyote Dam and Reservoir.
 - (8) Lexington Dam and Reservoir.
- (b) No person shall operate, drive, move or cause to be operated, driven or moved any vehicle upon or over any of the following dams and reservoirs, or the slopes, bottoms or other property thereof, under lease to the County of Santa Clara for public park purposes:
 - (1) Chesbro Dam and Reservoir.
 - (2) Uvas Dam and Reservoir. northerly direction only. Travel on such portion of such road in any direction other than that designated above shall constitute a violation of this section.

ARTICLE 8. PARKING*

Sec. B12-96.21. Parking of trucks exceeding 10,000 pounds, where prohibited.

- (a) No person shall park a commercial vehicle having a manufacturer's gross vehicle weight rating of 10,000 pounds or more, upon any street or portion thereof, in a residential district. This prohibition shall not apply to the parking of pickup trucks or mounted campers used in daily commuting, or any commercial vehicle parked or standing temporarily for the purpose of and while actually engaged in making pickups or deliveries of goods, wares or merchandise from or to any building or structure located on the restricted streets or highways or for the purpose of delivering materials to be used in the actual and bona fide repair, alteration, remodeling or construction of any building or structure upon the restricted streets or highways for which a building permit has been previously obtained.
- (b) Where any vehicle subject to this section is parked in violation thereof, and where such vehicle is left parked or standing beyond the time of 12:00 midnight on any given day, each such subsequent day shall constitute a separate violation under this section.
- (c) As used in this section "commercial vehicle" shall be as defined in California Vehicle Code § 260, "residential district" shall be as defined in California Vehicle Code § 515 and "park" shall have that meaning as defined in California Vehicle Code § 463.
- (d) The penalty for violation of this section shall be a fine of \$50.00 for each violation. (Ord. No. NS-1004.120, § 1, 11-3-80)

ARTICLE 1. GENERALLY

Sec. B12-97. Other laws and regulations not affected by this chapter.

The provisions of Articles 1 through 3 of this chapter are in addition to other parking regulations which are or may be imposed by the laws of this State and the provisions of this Code and shall not relieve any person from the duty to observe other and more restrictive provisions of the State Vehicle Code or this Code. (Ord. No. NS-1004.121, § 1, 11-3-80)

Sec. B12-98. Exemptions.

(a) The provisions of Articles 1 through 3 of this chapter regulating the parking and standing of vehicles shall not apply to any vehicle of the Sheriffs office or Fire Department, any public or private ambulance or any public utility vehicle, which public utility vehicle or private ambulance has qualified as an authorized emergency vehicle,

when any such vehicle mentioned in such articles is operated in the manner specified in the Vehicle Code in response to an emergency call.

- (b) The provisions of Articles 1 through 3 of this chapter regulating the parking or standing of vehicles shall not apply to any vehicle of a County department or public utility while necessarily in use for construction or repair.
- (c) The foregoing exemptions shall not, however, protect the driver of any such vehicle from the consequences of his wilful disregard for the safety of others.

Sec. B12-99. Peace officers to enforce regulations.

It shall be the duty of the Sheriff, all Deputy Sheriffs and all Special Deputy Sheriffs appointed for such purpose to enforce all parking regulations of this County and all state vehicle laws applicable to parking in this County, except in those parking areas on County property policed by employees of General Services Agency or other County departments. General Services Agency will supply and maintain parking records for all departments which enforce parking regulations, except for the Sheriff's Department. (Ord. No. NS-1004.121, § 1, 11-3-80)

Sec. B12-100. Parking for certain purposes prohibited.

No person who owns or has possession, custody or control of any vehicle shall park or leave standing or cause to be left parked or left standing such vehicle upon any highway in the unincorporated territory of the County for the principal purpose of:

- (a) Displaying such vehicle for sale; or
- (b) Servicing, repairing, assembling, disassembling, modifying or otherwise working on such vehicle except repairs necessitated by an emergency.

Sec. B12-101. Parking exceeding 72 hours— Prohibited.

No person who owns or has possession, custody or control of any vehicle shall park or leave standing, or cause to be left parked or left standing, such vehicle upon any highway in the unincorporated territory of the County for a period of 72 or more consecutive hours.

Sec. B12-102. Same-Removal of vehicle.

In the event that any vehicle is parked or left standing on any highway in the unincorporated territory of the County for a period of 72 or more consecutive hours, any member of the California Highway Patrol or regularly employed and salaried deputy of the Sheriffs office of the County may remove such vehicle from the highway in the manner and subject to the requirements of the Vehicle Code.

Sec. B12-103. Same—Notice; lien for towing and storage.

In the event that any officer removes a vehicle from a highway pursuant to Section B12-101, such officer shall give the notices provided for in the Vehicle Code; and the keeper of the garage in which such vehicle is stored may have a lien thereon dependent upon possession for his compensation for towage and for caring for and keeping safe such vehicle subject to the requirements and conditions of the Vehicle Code.

Sec. B12-150. Prohibition of solicitation of employment, business, money or other property.

- (a) The activity of solicitation between occupants of vehicles in the roadway and persons within the public right-of-way distracts drivers from the primary duties of watching for traffic and potential road hazards, watching for pedestrians, observing traffic control signals and warnings and otherwise safely driving through the County's streets and intersections.
- (b) The activity of solicitation between occupants of vehicles in the roadway and persons within the public right-of-way impedes, delays and obstructs the free flow of traffic on County streets, and results in congestion and blockage of the streets, driveways and sidewalks when persons approach vehicles to negotiate with the occupants and when motorists slow or stop their vehicles to solicit the services of such persons.
- (c) A motorist causes his or her own distraction and/or the distraction of other motorists when attempting to maneuver his or her vehicle while, at the same time, attempting to negotiate a verbal employment contact or other solicitation request.
- (d) Distracted drivers create an unsafe condition for persons engaging in solicitations, pedestrian traffic and vehicle traffic generally because such drivers are more prone to automobile accidents, and accidents on the public streets constitute a substantial traffic safety problem, which problem further impedes and prevents the orderly flow of traffic.
- (e) The traffic safety hazards resulting from the conduct described above is greatest in areas of the County where significant numbers of motorists tend to converge to solicit persons in the public right-of-way and where significant numbers of persons tend to converge in the public right-of-way to solicit motorists.

- (f) Significant numbers of motorists and persons tend to frequent certain areas within the County on a daily basis to solicit work.
- (g) The cumulative impact of this type of activity on certain of the County's streets, highways and sidewalks on a daily basis has created a potential safety hazard which poses a significant and substantial risk to the interest of the public in the free flow of travel in the County. (Ord. No. NS-1004.135, § 1, 6-9-98)

Sec. B12-151. Definitions.

The definitions set forth in this part shall govern the application and interpretation of this chapter:

- (a) "Business" means any type of product, goods, service, performance or activity that is provided or performed, or offered to be provided or performed, in exchange for money, labor, goods or any other form of consideration.
- (b) "Employment" means services, industry or labor performed by a person for wages or other compensation or under any contract of hire, written, oral, express or implied.
- (c) "Solicit" shall mean and include any request, offer, enticement, or action which announces the availability of or for employment, the sale of goods, or a request for money or other property; or any request, offer, enticement or action which seeks to purchase or secure goods or employment, or to make a contribution of money or other property. As defined herein, a solicitation shall be deemed complete when made whether or not an actual employment relationship is created, a transaction is completed, or an exchange of money or other property takes place.

(Ord. No. NS-1004.135, § 2, 6-9-98)

Sec. B12-152, Prohibition of solicitation in public right-of-way.

(a) It shall be unlawful for any person, while standing in any portion of the public right-of-way, including but not limited to public streets, high-



ways, sidewalks and driveways, to solicit, or attempt to solicit, employment, business or contributions of money or other property from any person traveling in a vehicle along a public right-of-way, including, but not limited to public streets, highways or driveways.

(b) It shall be unlawful for any person, while the occupant of any vehicle, to solicit, or attempt to solicit, employment, business or contributions of money or other property from a person who is within the public right-of-way, including but not limited to a public street, highway, sidewalk or driveway.

(Ord: No. NS-1004.135, § 3, 6-9-98)

Sec. B12-153. No vehicle solicitation zone.

- (a) The Director of the Santa Clara Roads and Airports Department may declare any area of the County to be a no vehicle solicitation zone if he or she finds, based upon traffic volume, traffic patterns, and the nature of the conduct of the solicitation activity that solicitation occurring in that area is creating a public nuisance or is adversely affecting public health, safety and welfare.
- (b) The prohibitions set forth in Section B12-152 shall not be enforceable in any area declared to be a no vehicle solicitation zone until the County of Santa Clara has posted signs giving notice of the prohibition.

Sec. B12-154. Penalty.

Any person convicted of a misdemeanor under this section shall be punishable by a fine of not more than \$500.00, or imprisonment in the County jail for a period not to exceed six months, or by both such fine and imprisonment. Each person shall be guilty of a separate offense for each and every violation of any provision of this section which is committed or permitted by such person, and shall be punishable accordingly. ORDINANCE NO. NS-1004.139

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA AMENDING DIVISION B12, CHAPTER III, ARTICLE 3 OF THE COUNTY OF SANTA CLARA ORDINANCE CODE RELATED TO PARKING REGULATIONS ON COUNTY PROPERTY

Summary

This ordinance amends the parking regulations in Division B12, Chapter III, Article 3 of the Santa Clara County Ordinance Code to delegate authority to impose certain parking regulations to the County Executive.

THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA CLARA ORDAINS AS FOLLOWS:

SECTION 1: Article 3, Chapter III, of Division B12 in Title B of the Ordinance Code of the County of Santa Clara is amended as follows:

ARTICLE 3. PARKING REGULATIONS ON COUNTY PROPERTY

Sec. B12-156. Regulations imposed; notice.

- (a) Parking regulations are hereby imposed upon the drives and parking areas of property owned, leased and managed by the County. Notice of the regulations is provided by the erection, placement or painting of signs on the property or by marking the property.
- (b) No vehicle shall be stopped, left standing or parked on County property except in conformance with these regulations and with the California Vehicle Code.
- (c) More than one regulation may be applicable to a parking area where a sign or marking provides notice of the regulations.
- (d) Parking regulations are applicable to parking areas at all times unless the days and hours when the regulations apply are specifically indicated.
- (e) Parking regulations which permit a vehicle to be parked or left standing do not restrict the period of time that the vehicle may be parked or left standing unless a period of time is specifically indicated.
- (f) For the purpose of this article, a regulation or restriction shall be "indicated" by a sign or marking.
- (g) For the purpose of this article, a parking "area" includes a parking space.

Sec. B12-157. Parking regulations.

Parking regulations and the signs and markings which provide notice of the regulations are set forth below.

(a) Designated parking:

Sign or marking: The sign or marking shall designate the characteristic of the vehicle or conditions under which a vehicle may or may not be parked or left standing. Designated parking areas include but are not limited to loading zones, County permits, disabled parking, visitor/public parking, carpool parking, no parking, or time limit parking.

Regulations: No person shall park or leave standing in said area any vehicle, whether attended or unattended, that does not have the designated characteristic or meet the condition indicated, with the following exception: a vehicle bearing a state "Disabled Person" license plate or placard may park in visitor/public parking areas and without time restriction in time limit parking areas.

(b) Reserved parking:

Sign or marking: The sign or marking shall have the designation "Reserved Parking" and shall indicate by number, position of official, the department of the County, specific vehicle or classification of users to which said parking area is assigned.

Regulations: No person shall park or leave standing in a reserved parking area any vehicle, whether attended or unattended, other than a specifically eligible vehicle.

(c) Disabled person parking:

Sign or marking: The sign shall conform to the California Building code requirements at the time of installation of the sign and stall markings shall include a typical parking stall accessibility pavement symbol to designate the stall.

Regulations: No person shall park or leave standing in a disabled person parking area or space any vehicle, whether attended or unattended, other than a vehicle displaying a state "Disabled Person" license plate or placard.

No person shall park or leave standing a vehicle so as to significantly obstruct or block either the wheelchair ramp or the path to and from said area.

Sec. B12-157.1. Parking regulations at the Civic Center Parking Garage.

(a) Signs shall be posted at the entrances and exits of the Civic Center Parking Garage listing the schedule of fees, rates and charges established for the use of this facility by the Board of Supervisors.

(b) Unless otherwise specifically indicated, no person shall park or leave standing in the Civic Center parking garage any vehicle, whether attended or unattended, without paying the required fees, rates and charges.

Sec. B12-157.2. Electric vehicle (EV) charging stations.

No person shall park a non-electric vehicle at a charging station. Non-EVs parked at stations will receive citations and may be towed.

EV Charging Stations are intended for EVs that need to be charged. EVs not utilizing the service or parking for longer than is designated by signage are subject to citation.

Sec. B12-158. Parking permits.

- (a) County permits: Regular, temporary and special County parking permits are issued to persons designated by the County Executive or designees in accordance with the Parking Administrative Guidelines.
- (b) Location of permit on vehicle: In order for a permit to authorize the parking of a vehicle, the permit shall be placed or affixed to the vehicle according to the following:
 - (1) All permits must be clearly visible and legible and placed in accordance with instructions at issuance and as referenced in the Administrative Guidelines.
 - (2) It is the responsibility of the permit holder to ensure the permit is visible.

A permit shall be invalid if it is improperly placed or affixed on the vehicle, is defaced, is illegible, has been inappropriately removed and reapplied to another vehicle, has expired, is altered/counterfeit, or is improperly completed.

Sec. B12-159. Proper positioning of vehicles.

All vehicles parked or left standing on any County property shall be positioned so as to be entirely within a parking space. Backing into parking spaces is prohibited in County lots. Driving through a parking space in order to position the vehicle so that the nose of the vehicle is pointing towards the traffic aisle is prohibited. Owners of vehicles which are improperly parked or left standing may receive citations. Vehicles over 20 feet in length shall not be parked on County property without prior written approval of the County Executive or designee.

Sec. B12-160. Speed limit.

No person shall drive or operate any vehicle on or across any of the drives or parking areas on County-owned, leased or managed property at a speed in excess of 15 miles per hour, unless otherwise indicated.

Sec. B12-161. Obstruction of drive areas.

No person shall stop or leave standing any vehicle, attended or unattended, in any drive area

adjoining or leading to any County building so as to obstruct traffic.

Sec. B12-162. Non-responsibility of County for loss or damage to vehicles.

The County shall not be responsible for loss or damage to any vehicle which is parked or left standing on County property or to any personal property situated therein, by reason of fire, theft or any other cause. Persons who park or leave vehicles standing on County property do so at their own risk.

Sec. B12-163. Notice of regulations and administrative guidelines.

Vehicles shall not be parked or left standing on property owned, leased or managed by the County except in parking areas designated by signs or markings. Notice of the regulations and administrative guidelines that are applicable to parking areas shall be given by appropriate signs, which shall be erected at the entrance to such parking areas.

The County Executive or designee has the responsibility to maintain the County of Santa Clara Parking Administrative Guidelines (Admin Guidelines) regarding signage, time of day and designated parking areas (both vehicular and bicycle) in order to meet the objectives of efficient use of limited parking areas, ease of public and employee access to County facilities, and support of the County's environmental goals, including the support of alternative commuting and the reduction of greenhouse gas emissions.

Copies of parking regulations and the Admin Guidelines shall be available for examination by all interested persons at the offices of the Clerk of the Board of Supervisors, the Office of the County Executive, the Facilities and Fleet Department, the Department of Revenue, the Employee Services Agency, the Office of the Sheriff, and shall be posted on the official County website.

Sec. B12-164. Penalty.

The failure or refusal of any person to comply with any of the regulations set forth in this article shall constitute a violation of California Vehicle Code § 21113 and shall be punishable as provided in Vehicle Code § 42001. A late fee will be imposed for delinquent penalty payment, and further non-compliance may result in a lien hold placed against the vehicle registration by the Department of Motor Vehicles. In addition to the above-mentioned penalties, all vehicles improperly parked in any drive or parking area may be towed away, removed or disabled at the owner's expense, as provided in California Vehicle Code §§ 22519, 22651 and 21652.

Sec. B12-165. Paid parking areas.

The County Executive may, from time to time, convert permitted parking areas into pay for parking areas. The County Executive may also, from time to time, convert parking areas for pay into designated, reserved and/or permitted areas.

Sec. B12-166. Citations

The citation shall securely attach to the vehicle and shall set forth the violation, including: reference to the section violated; the date; the approximate time thereof; the location of where the violation occurred; a statement printed on the notice indicating the date of payment required and Rev. 8/7/2012

the procedure for the registered owner, lessee, or rentee to deposit the parking penalty or appeal the parking citation.

Sec. B12-167. Citation nullification

Once the issuing officer has prepared the notice of parking violation and has attached it to the vehicle as provided in section B12-166, the officer shall file the notice with the processing agency. Any person, including the issuing officer and any member of the officer's department or agency who alters, conceals, modifies, nullifies, or destroys or causes to be altered, concealed, modified, nullified or destroyed for any reason before it is filed with the processing agency, is guilty of a misdemeanor, as provided in California Vehicle Code 40202.

As of October 9, 2012, almost 5,600 "green" stickers have been issued. Green stickers are valid through January 1, 2015.

California law allows single-occupant use of High Occupancy Vehicle (HOVs) lanes by certain qualifying clean alternative fuel vehicles. A **list of qualifying vehicles** and **frequently asked questions** are provided below. Use of these lanes with a single occupant requires a **Clean Air Vehicle Sticker** issued by the California Department of Motor Vehicles (DMV). Currently, there are two types of stickers that are being distributed by the DMV.

White Clean Air Vehicle Stickers are available to an unlimited number of qualifying Federal Inherently Low Emission Vehicles (ILEVs). Cars that meet these requirements are typically certified pure zero emission vehicles (100% battery electric and hydrogen fuel cell) and compressed natural gas (CNG) vehicles. The expiration date for the white stickers has been extended to January 1, 2015.

Green Clean Air Vehicle Stickers are available to the first 40,000 applicants that purchase or lease cars meeting California's Enhanced Advanced Technology Partial Zero Emission Vehicle (AT PZEV) requirement.

Yellow Clean Air Vehicle Stickers for hybrids are no longer valid - the program ended on 7/1/2011. Please note that these vehicles do not qualify for any other type of decals.

Yellow Clean Air Vehicle Decals: Hybrid Vehicles

Under AB 2628, "Yellow Stickers" were issued to early models of qualifying hybrid vehicles allowing single occupant access to HOV/carpool lanes. These stickers were limited to the first 85,000 applicants. As of July 1, 2011, this program has ended and Yellow Clean Air Vehicle stickers are no longer valid. HOV lane use by a Yellow Sticker vehicle, without the minimum required passengers, will subject the driver to a citation. Please note that these vehicles do not qualify for any other type of Clean Air Vehicle ticker or decal.

Why did yellow hybrid vehicle stickers expire?

The California legislature limited the time of this early hybrid vehicle program to help promote and encourage the development of newer plug-in hybrid and other zero emissions technologies.

White Clean Air Vehicle Decals: Zero Emission and CNG Vehicles White Clean Air Vehicle Stickers are available to an unlimited number of qualifying Federal Inherently Low Emission Vehicles (ILEVs). Cars that meet these requirements are typically certified pure zero emission vehicles (100% battery electric and hydrogen fuel cell) and compressed natural gas (CNG) vehicles. The expiration date for the white stickers has been extended to January 1, 2015.

Do neighborhood electric vehicles qualify?

"Neighborhood" electric vehicles such as the GEM EV and the Think! Neighbor are ZEVs certified to the US DOT safety standards that only allow their use on roads with posted speed limits of 35 MPH or less. As such they cannot be issued the California HOV lane access sticker. These vehicles are not permitted to be used on ANY road or freeway with posted speed limits above 35 MPH REGARDLESS of the speed at which traffic may actually be operating.

How do I transfer a Clean Air Vehicle decal to my name or get a replacement sticker?

All decals remain with the vehicle they were originally issued to and cannot be transferred to any other vehicle. If you purchase a vehicle that has a decal, you may transfer the decal to your name. Refer to Frequently Asked Questions on the **Department of Motor Vehicles** website for more information.

Green Clean Air Vehicle Decals: Plug-in Hybrid Vehicles

New Stickers are available as of January 1, 2012 and will be valid through January 1, 2015 to the first 40,000 applicants that purchase or lease cars meeting California's enhanced advanced technology partial zero emission vehicle (AT PZEV) requirements. Learn more with the California Clean Vehicle Incentives Fact Sheet. Vehicles qualifying for this new sticker will be added to this website.

Will qualifying vehicles purchased before January 1, 2012 be able to receive a sticker? Yes. Qualifying vehicles purchased before the program begins are eligible to receive a green sticker.

What models will qualify?

Qualifying vehicles will be posted to this web page. In general, vehicles with the potential of meeting the Enhanced AT PZEV requirement include plug-in hybrid (PHEV) and hydrogen internal combustion engine (hydrogen ICE) vehicles. In order to be certified as an Enhanced AT PZEV, PHEVs and hydrogen ICE vehicles must:

- Meet California's most stringent tailpipe emission standard
- Have zero evaporative emissions
- Have a 15 yr/150K mile warranty on the emissions system and;
- Have a 10 yr/150K warranty on the zero emission energy storage system.

Not all PHEV and hydrogen ICE vehicles will meet these requirements.

COUNTY OF SANTA CLARA CARPOOL PROGRAM AGREEMENT

QUALIFYING REQUIREMENTS

- A carpool is defined as a minimum of two persons commuting to and from a common origin and destination. At least two persons of a carpool must be County employees.
- 2. Applicants must use their assigned carpool space a minimum of three (3) days per week to qualify, or be subject to cancellation of the carpool privilege. A carpool week is considered to be Monday through Friday. Random checking of carpool spaces occurs, and this carpool authorization is subject to immediate cancellation without warning if program requirements are not met.
- 3. Application renewal/update occurs twice a year.
- 4. Carpool members must notify FAF Parking Patrol in <u>writing</u> of any changes in carpool membership, changes of vehicles, addresses, telephone numbers, shift changes, etc.
- 5. Carpool members must notify FAF Parking Patrol in writing of vacations and of absent carpool members due to illness or

PARKING RULES

- 1. While occupying your assigned carpool space, you must display <u>both</u> a valid carpool sticker and a County "C" permit. Stickers and permit <u>must be visible</u> from the rear of the vehicle.
- 2. Permits and stickers may not be altered or transferred.
- 3. Carpool vehicles must park only in the space they have been assigned. PARKING IN A SPACE OTHER THAN THE ONE TO WHICH YOU HAVE BEEN ASSIGNED WILL RESULT IN THE ISSUANCE OF A CITATION AND FINE.
- 4. At least two (2) participants in a carpool must end their trip at their assigned space, unless special circumstances are preapproved by FAF Parking Patrol, such as disability, pregnancy, medical conditions with a Doctor's note, or other extenuating circumstances. Any changes from the carpool standard requirements must be submitted in writing to: PARKING PATROL,1555 Berger Drive. San Jose CA 95112 (408) 299-4000. 408-271-1926 Fax
- 5. Termination of carpool privilege will result in a six month waiting period before acceptance back into the Carpool Program
